- 1 AN ACT Relating to capital punishment; reenacting and amending RCW
- 2 10.95.020; and prescribing penalties.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 10.95.020 and 1995 c 129 s 17 (Initiative Measure No.
- 5 159) and 1994 c 121 s 3 are each reenacted and amended to read as
- 6 follows:
- 7 A person is guilty of aggravated first degree murder if he or she
- 8 commits first degree murder as defined by RCW 9A.32.030(1)(a), as now
- 9 or hereafter amended, and one or more of the following aggravating
- 10 circumstances exist:
- 11 (1) The victim was a law enforcement officer, corrections officer,
- 12 or fire fighter who was performing his or her official duties at the
- 13 time of the act resulting in death and the victim was known or
- 14 reasonably should have been known by the person to be such at the time
- 15 of the killing;
- 16 (2) At the time of the act resulting in the death, the person was
- 17 serving a term of imprisonment, had escaped, or was on authorized or
- 18 unauthorized leave in or from a state facility or program for the
- 19 incarceration or treatment of persons adjudicated quilty of crimes;

- 1 (3) At the time of the act resulting in death, the person was in 2 custody in a county or county-city jail as a consequence of having been 3 adjudicated guilty of a felony;
- 4 (4) The person committed the murder pursuant to an agreement that 5 he or she would receive money or any other thing of value for 6 committing the murder;
- 7 (5) The person solicited another person to commit the murder and 8 had paid or had agreed to pay money or any other thing of value for 9 committing the murder;
 - (6) The defendant knew the victim was pregnant;
- 11 <u>(7)</u> The person committed the murder to obtain or maintain his or 12 her membership or to advance his or her position in the hierarchy of an 13 organization, association, or identifiable group;
- (((7))) (8) The murder was committed during the course of or as a result of a shooting where the discharge of the firearm, as defined in RCW 9.41.010, is either from a motor vehicle or from the immediate area of a motor vehicle that was used to transport the shooter or the firearm, or both, to the scene of the discharge;
- 19 $((\frac{8}{1}))$ (9) The victim was:

- (a) A judge; juror or former juror; prospective, current, or former witness in an adjudicative proceeding; prosecuting attorney; deputy prosecuting attorney; defense attorney; a member of the indeterminate sentence review board; or a probation or parole officer; and
- (b) The murder was related to the exercise of official duties performed or to be performed by the victim;
- (((+9))) (10) The person committed the murder to conceal the commission of a crime or to protect or conceal the identity of any person committing a crime, including, but specifically not limited to, any attempt to avoid prosecution as a persistent offender as defined in RCW 9.94A.030;
- (((10))) (11) There was more than one victim and the murders were part of a common scheme or plan or the result of a single act of the person;
- $((\frac{(11)}{(11)}))$ (12) The murder was committed in the course of, in furtherance of, or in immediate flight from one of the following 36 crimes:
- 37 (a) Robbery in the first or second degree;
- 38 (b) Rape in the first or second degree;
- 39 (c) Burglary in the first or second degree or residential burglary;

- 1 (d) Kidnapping in the first degree; or
- 2 (e) Arson in the first degree;
- 3 $((\frac{12}{12}))$ The victim was regularly employed or self-employed as
- 4 a newsreporter and the murder was committed to obstruct or hinder the
- 5 investigative, research, or reporting activities of the victim.
