1 AN ACT Relating to noxious weeds; amending RCW 17.10.905,
2 17.10.010, 17.10.020, 17.10.030, 17.10.040, 17.10.050, 17.10.060,
3 17.10.070, 17.10.074, 17.10.080, 17.10.090, 17.10.100, 17.10.110,
4 17.10.120, 17.10.130, 17.10.134, 17.10.140, 17.10.145, 17.10.154,
5 17.10.160, 17.10.170, 17.10.180, 17.10.190, 17.10.210, 17.10.235,
6 17.10.240, 17.10.250, 17.10.300, 17.10.310, 17.10.350, 17.10.890, and
7 17.10.900; adding new sections to chapter 17.10 RCW; recodifying RCW
8 17.10.905; and repealing RCW 17.10.005, 17.10.150, 17.10.200,
9 17.10.205, 17.10.320, 17.10.330, and 17.10.340.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

11 **Sec. 1.** RCW 17.10.905 and 1975 1st ex.s. c 13 s 17 are each
12 amended to read as follows:

13 The purpose of this chapter is to limit (~~economic loss due to the~~
14 ~~presence and spread of noxious weeds on or near agricultural land~~)
15 adverse effects to Washington's agricultural, natural, and human
16 resources due to the presence and spread of noxious weeds on all
17 terrestrial and aquatic lands in the state.

18 The intent of the legislature is that this chapter be liberally
19 construed, and that the jurisdiction, powers, and duties granted to the

1 county noxious weed control boards by this chapter are limited only by
2 specific provisions of this chapter or other state and federal law.

3 **Sec. 2.** RCW 17.10.010 and 1995 c 255 s 6 are each amended to read
4 as follows:

5 ~~((Unless a different meaning is plainly required by the context,~~
6 ~~the following words and phrases as hereinafter used in this chapter~~
7 ~~shall have the following meanings)) The definitions in this section
8 apply throughout this chapter unless the context clearly requires
9 otherwise:~~

10 (1) "Noxious weed" means ~~((any))~~ a plant ~~((which))~~ that when
11 established is highly destructive, competitive, or difficult to control
12 by cultural or chemical practices.

13 (2) "State noxious weed list" means a list of noxious weeds adopted
14 by the state noxious weed control board ~~((which))~~. The list is divided
15 into three classes:

16 (a) Class A ~~((shall))~~ consists of those noxious weeds not native to
17 the state that are of limited distribution or are unrecorded in the
18 state and that pose a serious threat to the state;

19 (b) Class B ~~((shall))~~ consists of those noxious weeds not native to
20 the state that are of limited distribution or are unrecorded in a
21 region of the state and that pose a serious threat to that region;

22 (c) Class C ~~((shall))~~ consists of any other noxious weeds.

23 (3) "Person" means any individual, partnership, corporation, firm,
24 the state or any department, agency, or subdivision thereof, or any
25 other entity.

26 (4) "Owner" means the person in actual control of property, or his
27 or her agent, whether ~~((such))~~ the control is based on legal or
28 equitable title or on any other interest entitling the holder to
29 possession and, for purposes of liability, pursuant to RCW 17.10.170 or
30 17.10.210, means the possessor of legal or equitable title or the
31 possessor of an easement: PROVIDED, That when the possessor of an
32 easement has the right to control or limit the growth of vegetation
33 within the boundaries of an easement, only the possessor of ~~((such))~~
34 the easement ~~((shall be))~~ is deemed, for the purpose of this chapter,
35 an "owner" of the property within the boundaries of ~~((such))~~ the
36 easement.

37 (5) As pertains to the duty of an owner, the words "control",
38 "contain", "eradicate", and the term "prevent the spread of noxious

1 weeds" (~~shall~~) means conforming to the standards of noxious weed
2 control or prevention in this chapter or as adopted by rule (~~or~~
3 ~~regulation~~) in chapter 16-750 WAC by the state noxious weed control
4 board and an activated county noxious weed control board.

5 (6) "Agent" means any occupant or any other person acting for the
6 owner and working or in charge of the land.

7 (7) "Agricultural purposes" are those (~~which~~) that are intended
8 to provide for the growth and harvest of food and fiber.

9 (8) "Director" means the director of the department of agriculture
10 or the director's appointed representative.

11 (9) "Weed district" means a weed district as defined in chapters
12 17.04 and 17.06 RCW.

13 (10) "Aquatic noxious weed" means an aquatic plant species that is
14 listed on the state weed list under RCW 17.10.080.

15 (11) "Screenings" means a mixture of mill or elevator run mixture
16 or a combination of varying amounts of materials obtained in the
17 process of cleaning either grain or seeds, or both, such as light or
18 broken grain or seed, weed seeds, hulls, chaff, joints, straw, elevator
19 dust, floor sweepings, sand, and dirt.

20 **Sec. 3.** RCW 17.10.020 and 1969 ex.s. c 113 s 2 are each amended to
21 read as follows:

22 (1) In each county of the state there is (~~hereby~~) created a
23 noxious weed control board, (~~which shall~~) bearing the name of the
24 county within which it is located. The jurisdictional boundaries of
25 each board (~~shall be coextensive with~~) are the boundaries of the
26 county within which it is located.

27 (2) Each noxious weed control board (~~shall be~~) is inactive until
28 activated pursuant to the provisions of RCW 17.10.040.

29 **Sec. 4.** RCW 17.10.030 and 1987 c 438 s 2 are each amended to read
30 as follows:

31 There is (~~hereby~~) created a state noxious weed control board
32 (~~which shall be~~) comprised of nine voting members and three nonvoting
33 members. Four of the voting members shall be elected by the members of
34 the various activated county noxious weed control boards, and shall be
35 residents of a county in which a county noxious weed control board has
36 been activated and a member of said board, and those qualifications
37 shall continue through their term of office. Two (~~such~~) of these

1 members shall be elected from the west side of the state, the crest of
2 the Cascades being the dividing line, and two from the east side of the
3 state. The director of agriculture (~~((shall be))~~) is a voting member of
4 the board. One voting member shall be elected by the directors of the
5 various active weed districts formed under chapter 17.04 or 17.06 RCW.
6 The Washington state association of counties (~~((shall))~~) appoints one
7 voting member who shall be a member of a county legislative authority.
8 (~~((The director shall appoint three nonvoting members representing
9 scientific disciplines relating to weed control.))~~) The director shall
10 (~~((also))~~) appoint two voting members to represent the public interest,
11 one from the west side and one from the east side of the state. The
12 director shall also appoint three nonvoting members representing
13 scientific disciplines relating to weed control. The term of office
14 for all members of the board (~~((shall be))~~) is three years from the date
15 of election or appointment.

16 The board, by rule, shall establish a position number for each
17 elected position of the board and shall designate which county noxious
18 weed control board members are eligible to vote for each elected
19 position. The elected members (~~((shall))~~) serve staggered terms.
20 Elections for the elected members of the board shall be held thirty
21 days prior to the expiration date of their respective terms.
22 Nominations and elections shall be by mail and conducted by the board.

23 The board shall conduct its first meeting within thirty days after
24 all its members have been elected. The board shall elect from its
25 members a (~~((chairman))~~) chair and (~~((such))~~) other officers as may be
26 necessary. A majority of the voting members of the board (~~((shall))~~)
27 constitutes a quorum for the transaction of business and (~~((shall be))~~)
28 is necessary for any action taken by the board. The members of the
29 board (~~((shall))~~) serve without salary, but shall be reimbursed for
30 travel expenses incurred in the performance of their duties under this
31 chapter in accordance with RCW 43.03.050 and 43.03.060 (~~((as now
32 existing or hereafter amended))~~).

33 **Sec. 5.** RCW 17.10.040 and 1987 c 438 s 3 are each amended to read
34 as follows:

35 An inactive county noxious weed control board may be activated by
36 any one of the following methods:

37 (1) Either within sixty days after a petition is filed by one
38 hundred registered voters within the county or, on its own motion, the

1 county legislative authority shall hold a hearing to determine whether
2 there is a need, due to a damaging infestation of noxious weeds, to
3 activate the county noxious weed control board. If such a need is
4 found to exist, then the county legislative authority shall, in the
5 manner provided by RCW 17.10.050, appoint five persons to (~~hold seats~~
6 ~~on~~) the county's noxious weed control board.

7 (2) If the county's noxious weed control board is not activated
8 within one year following a hearing by the county legislative authority
9 to determine the need for activation, then upon the filing with the
10 state noxious weed control board of a petition comprised either of the
11 signatures of at least two hundred registered voters within the county,
12 or of the signatures of a majority of an adjacent county's noxious weed
13 control board, the state board shall, within six months of the date of
14 (~~such~~) the filing, hold a hearing in the county to determine the need
15 for activation. If a need for activation is found to exist, then the
16 state board shall order the county legislative authority to activate
17 the county's noxious weed control board and to appoint members to
18 (~~such~~) the board in the manner provided by RCW 17.10.050.

19 (3) The director, (~~with notice to~~) upon request of the state
20 noxious weed control board, (~~may~~) shall order a county legislative
21 authority to activate the noxious weed control board immediately if an
22 infestation of a class A noxious weed or class B noxious weed
23 designated for control (~~within the region wherein the county lies as~~
24 ~~defined in RCW 17.10.080~~) on the state noxious weed list is confirmed
25 in that county. The county is liable for all expenses, costs, and
26 attorneys' fees incurred by the director in enforcing such an order.
27 The county legislative authority may, as an alternative to activating
28 the noxious weed board, combat the class A noxious weed or class B
29 noxious weed with county resources and personnel operating with the
30 authorities and responsibilities imposed by this chapter on a county
31 noxious weed control board. No county may continue without a noxious
32 weed control board for a second consecutive year if the class A noxious
33 weed or class B noxious weed (~~designated for control within the region~~
34 ~~wherein the county lies~~) has not been eradicated.

35 **Sec. 6.** RCW 17.10.050 and 1987 c 438 s 4 are each amended to read
36 as follows:

37 (1) Each activated county noxious weed control board (~~shall~~)
38 consists of five voting members (~~who shall be~~) appointed by the

1 county legislative authority. In appointing ~~((such))~~ the voting
2 members, the county legislative authority shall divide the county into
3 five ~~((sections, none of which shall overlap and each of which shall be~~
4 ~~of the same approximate area))~~ geographical areas that best represent
5 the county's interests, and ~~((shall))~~ appoint a voting member from each
6 ~~((section))~~ geographical area. ~~((At least four of the voting members~~
7 ~~shall be engaged in the primary production of agricultural products))~~
8 The voting members must represent the best interests of the county,
9 including those of agricultural production in the region, due to the
10 impact of noxious weeds on agriculture. There ~~((shall be))~~ is one
11 nonvoting member on ~~((such))~~ the board who ~~((shall be))~~ is the
12 ~~((chief))~~ chair of the county extension ~~((agent))~~ office or an
13 extension agent appointed by the ~~((chief))~~ chair of the county
14 extension ~~((agent))~~ office. Each voting member of the board ~~((shall))~~
15 serves a term of four years, except that the county legislative
16 authority shall, when a board is first activated under this chapter,
17 designate two voting members to serve terms of two years. The board
18 members shall not receive a salary but shall be compensated for actual
19 and necessary expenses incurred in the performance of their official
20 duties.

21 (2) The voting members of the board ~~((shall represent the same~~
22 ~~sections designated by the county legislative authority in appointing~~
23 ~~members to the board at its inception and shall))~~ serve until their
24 replacements are appointed. New members of the board shall be
25 appointed at least thirty days prior to the expiration of any board
26 member's term of office.

27 Notice of expiration of a term of office shall be published at
28 least twice in a weekly or daily newspaper of general circulation in
29 ~~((said))~~ the section with last publication occurring at least ten days
30 prior to the nomination. All persons interested in appointment to the
31 board and residing in the ~~((section))~~ geographical area with a pending
32 nomination shall make a written application that includes the
33 signatures of at least ten registered voters residing in the
34 ~~((section))~~ geographical area supporting the nomination to the county
35 noxious weed control board. After nominations close, the county
36 noxious weed control board shall, after a hearing, send the
37 applications to the county legislative authority recommending the names
38 of the most qualified candidates, and ~~((shall))~~ post the names of those
39 nominees in the county courthouse and ~~((in three places in the~~

1 ~~section~~) publish in at least one newspaper of general circulation in
2 the county. The county legislative authority, within ten days of
3 receiving the list of nominees, shall appoint one of those nominees to
4 the county noxious weed control board to represent that ~~((section))~~
5 geographical area during that term of office.

6 (3) Within thirty days after all the members have been appointed,
7 the board shall conduct its first meeting. A majority of the voting
8 members of the board ~~((shall))~~ constitutes a quorum for the transaction
9 of business and ~~((shall-be))~~ is necessary for any action taken by the
10 board. The board shall elect from its members a ~~((chairperson))~~ chair
11 and ~~((such))~~ other officers as may be necessary.

12 (4) In case of a vacancy occurring in any voting position on a
13 county noxious weed control board, the county legislative authority of
14 the county in which ~~((such))~~ the board is located shall appoint a
15 qualified person to fill the vacancy for the unexpired term.

16 **Sec. 7.** RCW 17.10.060 and 1987 c 438 s 5 are each amended to read
17 as follows:

18 (1) Each activated county noxious weed control board ~~((may))~~ shall
19 employ a weed coordinator whose duties ~~((shall-be))~~ are fixed by the
20 board but which shall include inspecting land to determine the presence
21 of noxious weeds, offering technical assistance and education, and
22 developing a program to achieve compliance with the weed law. Within
23 sixty days from initial employment the weed coordinator shall obtain a
24 pest control consultant license, a pesticide operator license, and the
25 necessary endorsements on the licenses as required by law. Each board
26 may purchase, rent, or lease ~~((such))~~ equipment, facilities, or
27 products and may hire ~~((such))~~ additional persons as it deems necessary
28 for the administration of the county's noxious weed control program.

29 (2) Each activated county noxious weed control board ~~((shall-have))~~
30 has the power to adopt ~~((such))~~ rules and regulations, subject to
31 notice and hearing as provided in chapters 42.30 and 42.32 RCW ~~((as now~~
32 ~~or hereafter amended))~~, as are necessary for an effective county weed
33 control or eradication program.

34 (3) Each activated county noxious weed control board shall meet
35 with a quorum at least quarterly.

36 **Sec. 8.** RCW 17.10.070 and 1987 c 438 s 6 are each amended to read
37 as follows:

1 (1) In addition to the powers conferred on the state noxious weed
2 control board under other provisions of this chapter, it ~~((shall have))~~
3 has the power to:

4 (a) Employ a state noxious weed control board executive secretary
5 ~~((who shall)), and additional persons as it deems necessary, to~~
6 disseminate information relating to noxious weeds to county noxious
7 weed control boards and weed districts ~~((and who shall work)),~~ to
8 coordinate the educational and weed control efforts of the various
9 county and regional noxious weed control boards and weed districts, and
10 to assist the board in carrying out its responsibilities;

11 (b) Adopt, amend, ~~((change,))~~ or repeal ~~((such))~~ rules, pursuant to
12 the administrative procedure act, chapter 34.05 RCW, as may be
13 necessary to carry out the duties and authorities assigned to the board
14 by this chapter.

15 (2) The state noxious weed control board shall provide a written
16 report before January 1 of each odd-numbered year to the governor, the
17 legislature, the county noxious weed control boards, and the weed
18 districts showing the ~~((funds disbursed by the department to each~~
19 ~~noxious weed control board or district,))~~ expenditure of state funds on
20 noxious weed control; specifically how the funds were spent~~((,))~~; the
21 status of the state, county, and district programs; and recommendations
22 for the continued best use of state funds for noxious weed control.
23 The report shall include recommendations as to the long-term needs
24 regarding weed control.

25 **Sec. 9.** RCW 17.10.074 and 1987 c 438 s 7 are each amended to read
26 as follows:

27 (1) In addition to the powers conferred on the director under other
28 provisions of this chapter, the director ~~((shall)),~~ with the advice of
29 the state noxious weed control board, ~~((have))~~ has power to:

30 (a) Require the county legislative authority or the noxious weed
31 control board of any county or any weed district to report to it
32 concerning the presence, absence, or estimated amount of noxious weeds
33 and measures, if any, taken or planned for the control thereof;

34 (b) Employ ~~((such))~~ staff as may be necessary in the administration
35 of this chapter;

36 (c) Adopt, amend, ~~((change,))~~ or repeal ~~((such))~~ rules, pursuant to
37 the administrative procedure act, chapter 34.05 RCW, as may be
38 necessary to carry out this chapter;

1 (d) Do such things as may be necessary and incidental to the
2 administration of its functions pursuant to this chapter including but
3 not limited to surveying for and detecting noxious weed infestations;

4 (e) Upon receipt of a complaint signed by a majority of the members
5 of an adjacent county noxious weed control board or weed district, or
6 by fifty registered voters within the county, require the county
7 legislative authority or noxious weed control board of the county or
8 weed district that is the subject of the complaint to respond to the
9 complaint within forty-five days with a plan for the control of the
10 noxious weeds cited in the complaint;

11 (f) If the complaint in (~~subsection~~) (e) of this subsection
12 involves a class A or class B noxious weed, order the county
13 legislative authority, noxious weed control board, or weed district to
14 take immediate action to eradicate or control the noxious weed
15 infestation. If the county or the weed district does not take action
16 to control the noxious weed infestation in accordance with the order,
17 the director may control it or cause it to be controlled. The county
18 or weed district (~~shall be~~) is liable for payment of the expense of
19 the control work including necessary costs and expenses for attorneys'
20 fees incurred by the director in securing payment from the county or
21 weed district. The director may bring a civil action in a court of
22 competent jurisdiction to collect the expenses of the control work,
23 costs, and attorneys' fees;

24 (g) In counties (~~which have not activated their~~) without an
25 activated noxious weed control board, enter upon any property as
26 provided for in RCW 17.10.160, issue or cause to be issued notices and
27 citations and take the necessary action to control noxious weeds as
28 provided in RCW 17.10.170, hold hearings on any charge or cost of
29 control action taken as provided for in RCW 17.10.180, issue a notice
30 of civil infraction as provided for in RCW 17.10.230(~~(7)~~) and 17.10.310
31 through 17.10.350, and place a lien on any property pursuant to RCW
32 17.10.280, 17.10.290, and 17.10.300 with the same authorities and
33 responsibilities imposed by these sections on county noxious weed
34 control boards;

35 (h) Adopt a list of noxious weed seeds and toxic weeds which shall
36 be controlled in designated articles, products, or feed stuffs as
37 provided for in RCW 17.10.235.

38 (2) The moneys appropriated for noxious weed control to the
39 department shall be used for administration of the state noxious weed

1 control board (~~(for determining the economic impact of noxious weeds in~~
2 ~~the state of Washington)~~), the administration of the director's powers
3 under this chapter, the purchase of materials for controlling,
4 containing, or eradicating noxious weeds, the purchase or collection of
5 biological control agents for controlling noxious weeds, and the
6 contracting for services to carry out the purposes of this chapter. In
7 a county with an activated noxious weed control board, the director
8 shall make every effort to contract with that board for the needed
9 services.

10 (3) If the director determines the need to reallocate funds
11 previously designated for county use, the director shall convene a
12 meeting of the state noxious weed control board to seek its advice
13 concerning any reallocation.

14 **Sec. 10.** RCW 17.10.080 and 1989 c 175 s 57 are each amended to
15 read as follows:

16 (1) The state noxious weed control board shall each year or more
17 often, following a hearing, adopt a state noxious weed list.

18 (2) (~~(At the hearing)~~) Any person may request during a comment
19 period established by the state weed board the inclusion, deletion, or
20 designation change of any plant to the (~~(lists to be adopted by the~~
21 ~~state noxious weed control board. Any hearing held pursuant to this~~
22 ~~section shall conform to the Administrative Procedure Act, chapter~~
23 ~~34.05 RCW: PROVIDED, That adding a weed to or deleting a weed from the~~
24 ~~list shall constitute a substantial change as provided for in RCW~~
25 ~~34.05.340)~~) state noxious weed list.

26 (3) The state noxious weed control board shall send a copy of the
27 list(~~(s)~~) to each activated county noxious weed control board, (~~(to~~
28 ~~each regional noxious weed control board,~~) to each weed district, and
29 to the county legislative authority of each county with an inactive
30 noxious weed control board.

31 (4) The record of (~~(hearing shall)~~) rule making must include the
32 written findings of the board for the inclusion of each plant on the
33 list. (~~(Such)~~) The findings shall be made available upon request to
34 any interested person.

35 **Sec. 11.** RCW 17.10.090 and 1987 c 438 s 9 are each amended to read
36 as follows:

1 Each county noxious weed control board shall, within (~~thirty~~)
2 ninety days of the (~~receipt~~) adoption of the state noxious weed list
3 from the state noxious weed control board and following a hearing,
4 select those weeds from the class C list and those weeds from the class
5 B list not designated for control in the noxious weed control region in
6 which the county lies (~~which~~) that it finds necessary to be
7 controlled in the county. The weeds thus selected and all class A
8 weeds and those class B weeds that have been designated for control in
9 the noxious weed control region in which the county lies shall be
10 classified within that county as noxious weeds, and those weeds
11 (~~shall~~) comprise the county noxious weed list.

12 **Sec. 12.** RCW 17.10.100 and 1987 c 438 s 10 are each amended to
13 read as follows:

14 Where any of the following occur, the state noxious weed control
15 board may, following a hearing, order any county noxious weed control
16 board or weed district to include a noxious weed from the state board's
17 list in the county's noxious weed list:

18 (1) Where the state noxious weed control board receives a petition
19 from at least one hundred registered voters within the county
20 requesting that the weed be listed.

21 (2) Where the state noxious weed control board receives a request
22 for (~~such~~) inclusion from an adjacent county's noxious weed control
23 board or weed district, which the adjacent board or district has
24 included that weed in (~~the~~) its county list, and (~~which~~) the
25 adjacent board or weed district alleges that its noxious weed control
26 program is being hampered by the failure to include the weed on the
27 county's noxious weed list.

28 **Sec. 13.** RCW 17.10.110 and 1987 c 438 s 11 are each amended to
29 read as follows:

30 A regional noxious weed control board comprising the area of two or
31 more counties may be created as follows:

32 Either the county legislative authority (~~and/or~~), or the noxious
33 weed control board, or both, of two or more counties may, upon a
34 determination that the purpose of this chapter will be served by the
35 creation of a regional noxious weed control board, adopt a resolution
36 providing for a limited merger of the functions of their respective
37 counties noxious weed control boards. (~~Such~~) The resolution

1 (~~shall~~) becomes effective only when a similar resolution is adopted
2 by the other county or counties comprising the proposed regional board.

3 **Sec. 14.** RCW 17.10.120 and 1987 c 438 s 12 are each amended to
4 read as follows:

5 In any case where a regional noxious weed control board is created,
6 the county noxious weed control boards comprising the regional board
7 shall still remain in existence and shall retain all powers and duties
8 provided for (~~such~~) the boards under this chapter.

9 The regional noxious weed control board (~~shall be~~) is comprised
10 of the voting members and the nonvoting members of the component
11 counties noxious weed control boards or county legislative authorities
12 who shall, respectively, be the voting and nonvoting members of the
13 regional board: PROVIDED, That each county shall have an equal number
14 of voting members. The board may appoint other nonvoting members as
15 deemed necessary. A majority of the voting members of the board
16 (~~shall~~) constitutes a quorum for the transaction of business and
17 (~~shall be~~) is necessary for any action taken by the board. The board
18 shall elect a (~~chairperson~~) chair from its members and (~~such~~) other
19 officers as may be necessary. Members of the regional board (~~shall~~)
20 serve without salary but shall be compensated for actual and necessary
21 expenses incurred in the performance of their official duties.

22 **Sec. 15.** RCW 17.10.130 and 1987 c 438 s 13 are each amended to
23 read as follows:

24 The powers and duties of a regional noxious weed control board are
25 as follows:

26 (1) The regional board shall, within (~~thirty~~) ninety days of the
27 (~~receipt~~) adoption of the state noxious weed list from the state
28 noxious weed control board and following a hearing, select those weeds
29 from the state list (~~which~~) that it finds necessary to be controlled
30 on a regional basis. The weeds thus selected shall also be contained
31 in the county noxious weed list of each county in the region.

32 (2) The regional board shall take (~~such~~) action as may be
33 necessary to coordinate the noxious weed control programs of the region
34 and (~~shall~~) adopt a regional plan for the control of noxious weeds.

35 **Sec. 16.** RCW 17.10.134 and 1987 c 438 s 14 are each amended to

17 NEW SECTION. Sec. 33. A new section is added to chapter 17.10 RCW
18 to read as follows:

19 (1) The state noxious weed control board shall:

20 (a) Work with the various federal and tribal land management
21 agencies to coordinate state and federal noxious weed control;

22 (b) Encourage the various federal and tribal land management
23 agencies to devote more time and resources to noxious weed control; and

24 (c) Assist the various federal and tribal land management agencies
25 by seeking adequate funding for noxious weed control.

26 (2) County noxious weed control boards and weed districts shall
27 work with the various federal and tribal land management agencies in
28 each county in order to:

29 (a) Identify new noxious weed infestations;

30 (b) Outline and plan necessary noxious weed control actions;

31 (c) Develop coordinated noxious weed control programs; and

32 (d) Notify local federal and tribal agency land managers of noxious
33 weed infestations.

34 (3) The department of agriculture, county noxious weed control
35 boards, and weed districts are authorized to enter federal lands, with
36 the approval of the appropriate federal agency, to survey for and
37 control noxious weeds where control measures of a type and extent
38 required under this chapter have not been taken.

1 (4) The department of agriculture, county noxious weed control
2 boards, and weed districts may bill the federal land management agency
3 that manages the land for all costs of the noxious weed control
4 performed on federal land. If not paid by the federal agency that
5 manages the land, the cost of the noxious weed control on federal land
6 may be paid from any funds available to the county noxious weed control
7 board or weed district that performed the noxious weed control.
8 Alternatively, the costs of noxious weed control on federal land may be
9 paid from any funds specifically appropriated to the department of
10 agriculture for that purpose.

11 (5) The department of agriculture, county noxious weed control
12 boards, and weed districts are authorized to enter into any reasonable
13 agreement with the appropriate authorities for the control of noxious
14 weeds on federal or tribal lands.

15 (6) The department of agriculture, county noxious weed control
16 boards, and weed districts shall consult with state agencies managing
17 federal land concerning noxious weed infestation and control programs.
