- AN ACT Relating to mediation in land-use decisions involving conditional or special use permits; adding a new section to chapter
- 3 35.63 RCW; adding a new section to chapter 35A.63 RCW; adding a new
- 4 section to chapter 36.70 RCW; adding a new section to chapter 35.22
- 5 RCW; and adding a new section to chapter 36.32 RCW.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. **Sec. 1.** A new section is added to chapter 35.63 RCW to read as follows:
- 9 Prior to filing an appeal of a final decision by a hearing examiner
- 10 involving a conditional or special use permit application, the
- 11 aggrieved party must, within five days after the final decision,
- 12 initiate formal mediation procedures in an attempt to resolve the
- 13 parties' differences. The mediation shall be conducted by a trained
- 14 mediator selected by agreement of the parties. If the parties are
- 15 unable to agree on a mediator, each party shall nominate a mediator and
- 16 the mediator shall be selected by lot from among the nominees. The
- 17 mediator must be selected within five days after formal mediation
- 18 procedures are initiated. The mediation process must be completed
- 19 within fourteen days from the time the mediator is selected except that

- 1 the mediation process may extend beyond fourteen days by agreement of
- 2 the parties. The mediator shall, within the fourteen-day period or
- 3 within the extension if an extension is agreed to, provide the parties
- 4 with a written summary of the issues and any agreements reached. The
- 5 mediation report shall be made available to the governing jurisdiction.
- 6 The cost of the mediation shall be shared by the parties.
- 7 Any time limits for filing of appeals are tolled during the
- 8 pendency of the mediation process.
- 9 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 35A.63 RCW
- 10 to read as follows:

- 18 mediation under section 1 of this act before an appeal may be filed.
- 19 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 35.22 RCW
- 20 to read as follows:

- 22 special use permit application under a home-rule charter is subject to
- 23 mediation under section 1 of this act before an appeal may be filed.
- 24 NEW SECTION. Sec. 5. A new section is added to chapter 36.32 RCW
- 25 to read as follows:
- 26 A final decision by a hearing examiner involving a conditional or
- 27 special use permit application under a home-rule charter is subject to
- 28 mediation under section 1 of this act before an appeal may be filed.
