SENATE BILL 5718

State of Washington 55th Legislature 1997 Regular Session

By Senators Wood, Newhouse, Haugen, Winsley and Oke; by request of Department of Licensing

Read first time 02/10/97. Referred to Committee on Transportation.

- AN ACT Relating to restricting the release and use of certain personal information from state motor vehicle and driver records; amending RCW 46.12.370, 46.12.380, 46.52.060, and 46.52.120; reenacting and amending RCW 42.17.310, 46.52.130, and 46.63.020; adding a new chapter to Title 46 RCW; prescribing penalties; and providing an effective date.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 8 <u>NEW SECTION.</u> **Sec. 1.** This chapter may be cited as the Uniform 9 Motor Vehicle and Driver Records Disclosure Act.
- 10 <u>NEW SECTION.</u> **Sec. 2.** The purpose of this chapter is to implement
- 11 the federal Driver's Privacy Protection Act of 1994 (Title XXX P.L.
- 12 103-322). The legislature finds that the people of the state of
- 13 Washington recognize the public benefit derived from motor vehicle
- 14 registration and titling, driver licensing, and the issuance of
- 15 identification documentation, and that the people recognize the need to
- 16 provide personal information to the state of Washington and its
- 17 agencies in order to properly maintain records on these activities.

The legislature further finds that the people have a right to expect that personal information maintained in motor vehicle and driver records will be used only for purposes relating to the ownership or operation of a motor vehicle, for purposes of public safety, and as otherwise expressly required or permitted by law.

It is the intent of this act to protect the interests of individuals in their personal privacy by prohibiting the disclosure and use of personal information contained in their motor vehicle and driver records, except as authorized by those individuals or by law.

- 10 <u>NEW SECTION.</u> **Sec. 3.** The definitions in this section apply 11 throughout this chapter unless the context clearly requires otherwise.
- (1) "Disclose" means to engage in any practice or conduct to make available and make known personal information contained in a motor vehicle or driver record about a person to any other person, organization, or entity, by any means of communication.
- 16 (2) "Individual record" is a motor vehicle or driver record 17 containing personal information about a designated person who is the 18 subject of the record as identified in a request.
- 19 (3) "Motor vehicle or driver record" means any record that pertains 20 to a motor vehicle operator's or driver's license or permit, motor 21 vehicle registration, motor vehicle title, or identification document 22 issued by the department of licensing, or other state or local agency 23 authorized to issue any of such forms of credentials.
- (4) "Person" means an individual, organization, or entity, but does not include the state of Washington or an agency thereof.
- (5) "Personal information" means information that identifies a person, including an individual's photograph or computerized image, social security number, driver identification number, name, address (but not the five-digit zip code), telephone number, and medical or disability information, but does not include information on vehicular accidents, driving or equipment-related violations, and driver's license or registration status.
- 33 (6) "Record" includes all books, papers, photographs, photostats, 34 cards, films, tapes, recordings, electronic data, printouts, or other 35 documentary materials regardless of physical form or characteristics.
- NEW SECTION. Sec. 4. Notwithstanding chapter 42.17 RCW to the contrary, except as provided in section 5, 6, or 7 of this act, the

- 1 department and any officer, employee, agent, or contractor thereof
- 2 shall not disclose personal information about any person obtained by
- 3 the department in connection with a motor vehicle or driver record.
- 4 NEW SECTION. Sec. 5. Personal information referred to in section
- 5 4 of this act shall be disclosed for use in connection with matters of
- 6 motor vehicle or driver safety and theft, motor vehicle emissions,
- 7 motor vehicle product alterations, recalls, or advisories, performance
- 8 monitoring of motor vehicles and dealers by motor vehicle
- 9 manufacturers, and removal of nonowner records from the original owner
- 10 records of motor vehicle manufacturers to carry out the purposes of the

- 21 consent of the person who is the subject of the information.
- 22 <u>NEW SECTION.</u> Sec. 7. Personal information referred to in section
- 23 4 of this act may be disclosed as otherwise permitted by law to any
- 24 person by the department, its officers, employees, or contractors, on
- 25 proof of the identity of the person requesting a record or records and
- 26 representation by such person that the use of the personal information
- 27 will be strictly limited to one or more of the following described
- 28 uses:
- 29 (1) For use by any government agency, including any court or law
- 30 enforcement agency, in carrying out its functions, or any private
- 31 person or entity acting on behalf of a government agency in carrying
- 32 out its functions;
- 33 (2) For use in connection with matters of motor vehicle or driver
- 34 safety and theft; motor vehicle emissions; motor vehicle product
- 35 alterations, recalls, or advisories; performance monitoring of motor
- 36 vehicles, motor vehicle parts, and dealers; motor vehicle market

- research activities, including survey research; and removal of nonowner 1 records from the original owner records of motor vehicle manufacturers;
- (3) For use in the normal course of business by a legitimate 3 4 business or its agents, employees, or contractors, but only:

- 5 (a) To verify the accuracy of personal information submitted by the individual to the business or its agents, employees, or contractors; 6 7 and
- 8 (b) If such information as so submitted is not correct or is no 9 longer correct, to obtain the correct information, but only for the 10 purposes of preventing fraud by, pursuing legal remedies against, or recovering on a debt or security interest against, the individual; 11
- (4) For use in connection with any civil, criminal, administrative, 12 13 or arbitral proceeding in any court or government agency or before any self-regulatory body, including the service of process, investigation 14 15 in anticipation of litigation, and the execution or enforcement of judgments and orders, or pursuant to an order of any court; 16
- 17 (5) For use in research activities, and for use in producing statistical reports, so long as the personal information is not 18 19 published, redisclosed, or used to contact individuals;
- 20 (6) For use by any insurer or insurance support organization, or by a self-insured entity, or its agents, employees, or contractors, in 21 22 connection with claims investigation activities, anti-fraud activities, 23 rating, or underwriting;
- 24 (7) For use in providing notice to the legal and registered owners 25 of towed or impounded vehicles;
- 26 (8) For use by any licensed private investigative agency or 27 licensed security service for any purpose permitted under this section;
- (9) For use by an employer or its agent or insurer to obtain or 28 verify information relating to a holder of a commercial driver's 29 30 license that is required under the Commercial Motor Vehicle Safety Act of 1986 (49 U.S.C. App. 2710 et seq.); 31
- (10) For use in connection with the operation of private toll 32 33 transportation facilities; and
- 34 (11) For any other use specifically authorized by law that is 35 related to the operation of a motor vehicle or public safety.
- 36 <u>NEW SECTION.</u> **Sec. 8.** Disclosure of personal information required or permitted under sections 5 through 7 of this act shall be subject to 37 payment by the requesting person to the department of all fees for the 38

- 1 information required by statute, regulation, administrative practice,
- 2 or the terms of any contract with the requesting person, on such terms
- 3 for payment as may be required or agreed, or as may be determined by
- 4 the department within the constraints of law.
- 5 <u>NEW SECTION.</u> **Sec. 9.** In addition to provisions for payment of
- 6 applicable fees, the department may, prior to the disclosure of
- 7 personal information as permitted under sections 5 through 7 of this
- 8 act, require the meeting of conditions by the requesting person for the
- 9 purposes of obtaining reasonable assurance concerning the identity of
- 10 such requesting person, and, to the extent required, that the use will
- 11 be only as authorized, or the consent of the person who is the subject
- 12 of the information has been obtained. Such conditions may include, but
- 13 need not be limited to, the making and filing of a written application
- 14 in such form and containing such information and certification
- 15 requirements as the department may prescribe.
- 16 <u>NEW SECTION.</u> **Sec. 10.** An authorized recipient of personal
- 17 information may resell or redisclose the information for any use
- 18 permitted under section 7 of this act if such resale or redisclosure is
- 19 otherwise permitted by law, and subject to any applicable agreement
- 20 with the department.
- 21 <u>NEW SECTION.</u> **Sec. 11.** The department is authorized to adopt rules
- 22 to carry out the purposes of this chapter.
- 23 <u>NEW SECTION.</u> **Sec. 12.** Any person requesting the disclosure of
- 24 personal information from department records who knowingly
- 25 misrepresents his or her identity or knowingly makes a false statement
- 26 to the department on any application required to be submitted pursuant
- 27 to this chapter shall be guilty of false swearing, a gross misdemeanor,
- 28 under RCW 9A.72.040.
- 29 **Sec. 13.** RCW 42.17.310 and 1996 c 305 s 2, 1996 c 253 s 302, 1996

- (b) Personal information in files maintained for employees, appointees, or elected officials of any public agency to the extent that disclosure would violate their right to privacy.
- 7 (c) Information required of any taxpayer in connection with the 8 assessment or collection of any tax if the disclosure of the 9 information to other persons would (i) be prohibited to such persons by 10 RCW 82.32.330 or (ii) violate the taxpayer's right to privacy or result 11 in unfair competitive disadvantage to the taxpayer.
- 12 (d) Specific intelligence information and specific investigative 13 records compiled by investigative, law enforcement, and penology 14 agencies, and state agencies vested with the responsibility to 15 discipline members of any profession, the nondisclosure of which is 16 essential to effective law enforcement or for the protection of any 17 person's right to privacy.
- (e) Information revealing the identity of persons who are witnesses 18 19 to or victims of crime or who file complaints with investigative, law 20 enforcement, or penology agencies, other than the public disclosure commission, if disclosure would endanger any person's life, physical 21 If at the time a complaint is filed the 22 safety, or property. complainant, victim or witness indicates a desire for disclosure or 23 24 nondisclosure, such desire shall govern. However, all complaints filed 25 with the public disclosure commission about any elected official or 26 candidate for public office must be made in writing and signed by the 27 complainant under oath.
- (f) Test questions, scoring keys, and other examination data used to administer a license, employment, or academic examination.
- (g) Except as provided by chapter 8.26 RCW, the contents of real estate appraisals, made for or by any agency relative to the acquisition or sale of property, until the project or prospective sale is abandoned or until such time as all of the property has been acquired or the property to which the sale appraisal relates is sold, but in no event shall disclosure be denied for more than three years after the appraisal.
- 37 (h) Valuable formulae, designs, drawings, and research data 38 obtained by any agency within five years of the request for disclosure 39 when disclosure would produce private gain and public loss.

- 1 (i) Preliminary drafts, notes, recommendations, and intra-agency 2 memorandums in which opinions are expressed or policies formulated or 3 recommended except that a specific record shall not be exempt when 4 publicly cited by an agency in connection with any agency action.
 - (j) Records which are relevant to a controversy to which an agency is a party but which records would not be available to another party under the rules of pretrial discovery for causes pending in the superior courts.

- 9 (k) Records, maps, or other information identifying the location of 10 archaeological sites in order to avoid the looting or depredation of 11 such sites.
 - (1) Any library record, the primary purpose of which is to maintain control of library materials, or to gain access to information, which discloses or could be used to disclose the identity of a library user.
- (m) Financial information supplied by or on behalf of a person, firm, or corporation for the purpose of qualifying to submit a bid or proposal for (i) a ferry system construction or repair contract as required by RCW 47.60.680 through 47.60.750 or (ii) highway construction or improvement as required by RCW 47.28.070.
- (n) Railroad company contracts filed prior to July 28, 1991, with the utilities and transportation commission under RCW 81.34.070, except that the summaries of the contracts are open to public inspection and copying as otherwise provided by this chapter.
 - (o) Financial and commercial information and records supplied by private persons pertaining to export services provided pursuant to chapter 43.163 RCW and chapter 53.31 RCW, and by persons pertaining to export projects pursuant to RCW 43.23.035.
- (p) Financial disclosures filed by private vocational schools under chapters 28B.85 and 28C.10 RCW.
- (q) Records filed with the utilities and transportation commission or attorney general under RCW 80.04.095 that a court has determined are confidential under RCW 80.04.095.
- 33 (r) Financial and commercial information and records supplied by 34 businesses or individuals during application for loans or program 35 services provided by chapters 43.163, 43.160, 43.330, and 43.168 RCW, 36 or during application for economic development loans or program 37 services provided by any local agency.
- 38 (s) Membership lists or lists of members or owners of interests of 39 units in timeshare projects, subdivisions, camping resorts,

- 1 condominiums, land developments, or common-interest communities
- 2 affiliated with such projects, regulated by the department of

- 4 (t) All applications for public employment, including the names of

- 7 (u) The residential addresses and residential telephone numbers of

- 9 in personnel records, employment or volunteer rosters, or mailing lists

- 3 (aa) Financial and commercial information supplied to the state 4 investment board by any person when the information relates to the 5 investment of public trust or retirement funds and when disclosure 6 would result in loss to such funds or in private loss to the providers 7 of this information.

- 9 (cc) Client records maintained by an agency that is a domestic 10 violence program as defined in RCW 70.123.020 or 70.123.075 or a rape 11 crisis center as defined in RCW 70.125.030.
- (dd) Information that identifies a person who, while an agency employee: (i) Seeks advice, under an informal process established by the employing agency, in order to ascertain his or her rights in connection with a possible unfair practice under chapter 49.60 RCW against the person; and (ii) requests his or her identity or any identifying information not be disclosed.
- (ee) Investigative records compiled by an employing agency conducting a current investigation of a possible unfair practice under chapter 49.60 RCW or of a possible violation of other federal, state, or local laws prohibiting discrimination in employment.

- 6 (3) Inspection or copying of any specific records exempt under the 7 provisions of this section may be permitted if the superior court in 8 the county in which the record is maintained finds, after a hearing 9 with notice thereof to every person in interest and the agency, that 10 the exemption of such records is clearly unnecessary to protect any 11 individual's right of privacy or any vital governmental function.
- (4) Agency responses refusing, in whole or in part, inspection of any public record shall include a statement of the specific exemption authorizing the withholding of the record (or part) and a brief explanation of how the exemption applies to the record withheld.

- (1) Notwithstanding the provisions of chapter 42.17 RCW, the name or address of an individual vehicle owner shall not be released by the department, county auditor, or agency or firm authorized by the department except as provided in section 5, 6, or 7 of this act and under the following circumstances:
- 18 (a) The requesting party is a business entity that requests the 19 information for use in the course of business;
- (b) The request is a written request that is signed by the person requesting disclosure that contains the full legal name and address of the requesting party, that specifies the purpose for which the information will be used; and

- 1 (3) Whenever the disclosing entity grants a request for information 2 under this section by an attorney or private investigator, the 3 disclosing entity shall provide notice to the vehicle owner, to whom 4 the information applies, that the request has been granted. The notice 5 also shall contain the name and address of the requesting party.
- 6 (4) Any person who is furnished vehicle owner information under 7 this section shall be responsible for assuring that the information 8 furnished is not used for a purpose contrary to the agreement between 9 the person and the department.
- 10 (5) This section shall not apply to requests for information by 11 governmental entities or requests that may be granted under any other 12 provision of this title expressly authorizing the disclosure of the 13 names or addresses of vehicle owners.
- 14 (6) This section shall not apply to title history information under 15 RCW 19.118.170.

- It shall be the duty of the chief of the Washington state patrol to file, tabulate, and analyze all accident reports and to publish annually, immediately following the close of each fiscal year, and monthly during the course of the year, statistical information based thereon showing the number of accidents, the location, the frequency and circumstances thereof and other statistical information which may prove of assistance in determining the cause of vehicular accidents.

infractions certified by the courts, together with an index crossreference record of each accident reported relating to such individual with a brief statement of the cause of the accident. The chief of the Washington state patrol shall furnish the index cross-reference record to the director, with reference to each driver involved in the reported accidents.

- (2) The records shall be for the confidential use of the director, the chief of the Washington state patrol, the director of the Washington traffic safety commission, and for such police officers or other cognizant public officials as may be designated by law, and shall not be disclosed except as permitted under section 5, 6, or 7 of this act and as otherwise permitted by law. Such case records shall not be offered as evidence in any court except in case appeal is taken from the order of the director, suspending, revoking, canceling, or refusing a vehicle driver's license.
- (3) The director shall tabulate and analyze vehicle driver's case 16 records and suspend, revoke, cancel, or refuse a vehicle driver's 17 license to a person when it is deemed from facts contained in the case 18 19 record of such person that it is for the best interest of public safety 20 that such person be denied the privilege of operating a motor vehicle. Whenever the director orders the vehicle driver's license of any such 21 person suspended, revoked, or canceled, or refuses the issuance of a 22 23 vehicle driver's license, such suspension, revocation, cancellation, or 24 refusal is final and effective unless appeal from the decision of the 25 director is taken as provided by law.

A certified abstract of the driving record shall be furnished only to the individual named in the abstract, an employer or prospective employer or an agent acting on behalf of an employer or prospective employer if the named individual's employment involves the operation of a motor vehicle, the insurance carrier that has insurance in effect covering the employer or a prospective employer, the insurance carrier that has insurance in effect covering the named individual, the insurance carrier to which the named individual has applied, an alcohol/drug assessment or treatment agency approved by the department of social and health services, to which the named individual has applied or been assigned for evaluation or treatment, or city and

The abstract, whenever possible, shall include an 21 enumeration of motor vehicle accidents in which the person was driving; 22 the total number of vehicles involved; whether the vehicles were 23 24 legally parked or moving; whether the vehicles were occupied at the 25 time of the accident; any reported convictions, forfeitures of bail, or findings that an infraction was committed based upon a violation of any 26 27 motor vehicle law; and the status of the person's driving privilege in this state. The enumeration shall include any reports of failure to 28 29 appear in response to a traffic citation or failure to respond to a 30 notice of infraction served upon the named individual by an arresting 31 officer. Certified abstracts furnished to prosecutors and alcohol/drug assessment or treatment agencies shall also indicate whether a recorded 32 violation is an alcohol-related offense as defined in RCW 46.01.260(2) 33 34 that was originally charged as one of the alcohol-related offenses 35 designated in RCW 46.01.260(2)($(\frac{a}{a})(\frac{i}{b})$) (b)(i). 36

The abstract provided to the insurance company shall exclude any information, except that related to the commission of misdemeanors or felonies by the individual, pertaining to law enforcement officers or fire fighters as defined in RCW 41.26.030, or any officer of the

Washington state patrol, while driving official vehicles in the 1 2 performance of occupational duty. The abstract provided to the insurance company shall include convictions for RCW 46.61.525 (1) and 3 4 (2) except that the abstract shall report them only as negligent 5 driving without reference to whether they are for first or second degree negligent driving. The abstract provided to the insurance 6 7 company shall exclude any deferred prosecution under RCW 10.05.060, 8 except that if a person is removed from a deferred prosecution under 9 RCW 10.05.090, the abstract shall show the deferred prosecution as well 10 as the removal.

The director shall collect for each abstract the sum of four 11 dollars and fifty cents which shall be deposited in the highway safety 12 fund. 13

14 Any insurance company or its agent receiving the certified abstract 15 shall use it exclusively for its own underwriting purposes and shall 16 not divulge any of the information contained in it to a third party. No policy of insurance may be canceled, nonrenewed, denied, or have the rate increased on the basis of such information unless the policyholder 19 was determined to be at fault. No insurance company or its agent for underwriting purposes relating to the operation of commercial motor vehicles may use any information contained in the abstract relative to any person's operation of motor vehicles while not engaged in such employment, nor may any insurance company or its agent for underwriting purposes relating to the operation of noncommercial motor vehicles use any information contained in the abstract relative to any person's 26 operation of commercial motor vehicles.

Any employer or prospective employer or an agent acting on behalf of an employer or prospective employer receiving the certified abstract shall use it exclusively for his or her own purpose to determine whether the licensee should be permitted to operate a commercial vehicle or school bus upon the public highways of this state and shall not divulge any information contained in it to a third party.

Any alcohol/drug assessment or treatment agency approved by the department of social and health services receiving the certified abstract shall use it exclusively for the purpose of assisting its employees in making a determination as to what level of treatment, if any, is appropriate. The agency, or any of its employees, shall not divulge any information contained in the abstract to a third party.
