- 1 AN ACT Relating to state lottery accounts; and amending RCW 2 67.70.240, 67.70.260, and 67.70.042.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 67.70.240 and 1995 3rd sp.s. c 1 s 105 are each 5 amended to read as follows:
- 6 The moneys in the state lottery account shall be used only: For the payment of prizes to the holders of winning lottery tickets or 8 shares; (2) for purposes of making deposits into the reserve account 9 created by RCW 67.70.250 and into the lottery administrative account 10 created by RCW 67.70.260; (3) for purposes of making deposits into the state's general fund; and (4) ((for purposes of making deposits into 11 12 the housing trust fund under the provisions of section 7 of this 1987 13 act; (5))) for distribution to a county for the purpose of paying the 14 principal and interest payments on bonds issued by the county to 15 construct a baseball stadium, as defined in RCW 82.14.0485, including reasonably necessary preconstruction costs((; (6) for the purchase and 16 17 promotion of lottery games and game-related services; and (7) for the Three million dollars shall be 18 payment of agent compensation)). 19 distributed under subsection $((\frac{5}{1}))$ of this section during

- 1 calendar year 1996. During subsequent years, such distributions shall
- 2 equal the prior year's distributions increased by four percent.
- 3 Distributions under subsection $((\frac{(5)}{)})$ of this section shall cease
- 4 when the bonds issued for the construction of the baseball stadium are
- 5 retired, but not more than twenty years after the tax under RCW
- 6 82.14.0485 is first imposed.

- 13 There is hereby created the lottery administrative account in the
- 14 state treasury. The account shall be managed, controlled, and
- 15 maintained by the director. The legislature may appropriate from the
- 16 account for the payment of costs incurred in the operation and
- 17 administration of the lottery, including the purchase and promotion of
- 18 <u>lottery games and game-related services and the payment of agent</u>
- 19 <u>compensation</u>.
- 20 **Sec. 3.** RCW 67.70.042 and 1995 3rd sp.s. c 1 s 104 are each
- 21 amended to read as follows:
- The lottery commission shall conduct at least two but not more than
- 23 four scratch games with sports themes per year. These games are
- 24 intended to generate additional moneys sufficient to cover the
- 25 distributions under RCW 67.70.240(((5)))) (4).
