State of Washington 55th Legislature 1997 Regular Session

By Senators Thibaudeau, Fairley, Wojahn, Prentice, Patterson and Kohl Read first time 02/24/97. Referred to Committee on Agriculture & Environment.

- AN ACT Relating to providing certain health and safety standards
- 2 for registered commercial breeders of dogs and cats as pets; reenacting
- 3 and amending RCW 18.130.040; adding a new chapter to Title 18 RCW;
- 4 creating a new section; and providing an effective date.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** It is the intent of the legislature to
- 7 assure the humane, safe, and healthy treatment of dogs and cats bred
- 8 by commercial breeding operations in this state. The registration of
- 9 breeders by the department of health and the establishment of
- 10 reasonable state-wide minimal operating standards will provide breeders
- 11 with a fair system of accountability that merits public confidence
- 12 while preventing abuse and neglect of prospective pets. The
- 13 legislature finds that local controls of breeders are disparate,
- 14 incomplete, and infrequently enforced and the establishment of state-
- 15 wide uniform minimum standards will assist breeders in meeting public
- 16 expectations consistent with recognized standards for the humane
- 17 treatment, health, safety, and welfare of dogs and cats. The
- 18 legislature recognizes the special bond between pet owners and their

- 1 animal companions and the importance of assuring public confidence in
- 2 the breeder industry.
- 3 <u>NEW SECTION.</u> **Sec. 2.** The definitions in this section apply 4 throughout this chapter unless the context clearly requires otherwise.
- 5 (1) "Breeder" means a person who causes five or more litters of
- 6 dogs or cats or both to be produced annually on property he or she
- 7 owns, controls, or occupies and who sells the animals at wholesale or
- 8 retail.
- 9 (2) "Department" means the state department of health.
- 10 (3) "Secretary" means the secretary of health.
- 11 <u>NEW SECTION.</u> **Sec. 3.** (1) No breeder may operate a facility in
- 12 which five or more litters of dogs or cats, or both, are bred and
- 13 produced annually for sale without a license under this chapter. No
- 14 person may represent oneself as registered, or engage in any commercial
- 15 breeding operations covered under this chapter, without being
- 16 registered by the department.
- 17 (2) An application for registration must be made to the department
- 18 upon forms provided, and must contain such information as the
- 19 department reasonably requires including, but not limited to, evidence
- 20 of ability to comply with the laws as prescribed in this chapter.
- 21 NEW SECTION. Sec. 4. The secretary has authority to:
- 22 (1) Adopt rules necessary to implement this chapter;
- 23 (2) Establish all registration and renewal fees in accordance with
- 24 the purposes and processes specified in RCW 43.70.250;
- 25 (3) Establish forms and procedures necessary to administer this
- 26 chapter;
- 27 (4) Register and issue a registration certificate to an applicant
- 28 covered under this chapter;
- 29 (5) Hire staff as needed to implement this chapter;
- 30 (6) Maintain the official record of all applicants and licensees;
- 31 and
- 32 (7) Examine records and facilities of registrants for compliance
- 33 with this chapter.
- 34 <u>NEW SECTION.</u> **Sec. 5.** Applications for initial and renewal
- 35 registration must be submitted on forms provided by the secretary. The

- 1 secretary may require any information and documentation which
- 2 reasonably relates to the need to determine whether the applicant meets
- 3 the criteria for registration under this chapter. Each applicant shall
- 4 pay a fee determined by the secretary under RCW 43.70.250 which must
- 5 accompany the application.
- 6 <u>NEW SECTION.</u> **Sec. 6.** The secretary may establish procedural
- 7 requirements and fees for renewal of registration. Failure to renew
- 8 invalidates the registration and all privileges granted by it.
- 9 <u>NEW SECTION.</u> **Sec. 7.** The uniform disciplinary act, chapter 18.130
- 10 RCW, governs the issuance and denial of a registration, and the
- 11 discipline of a breeder registered under this chapter. The secretary
- 12 is the disciplining authority under this chapter.
- 13 <u>NEW SECTION.</u> **Sec. 8.** (1) The secretary shall appoint a breeder
- 14 advisory committee to advise the secretary on the implementation of
- 15 this chapter and on the operating standards for the commercial breeding
- 16 of dogs and cats by breeders. The committee is comprised of seven
- 17 members consisting of one veterinarian licensed by the department, two
- 18 members who are breeders registered under this chapter, two members of
- 19 an animal care and control agency, and two members representing the
- 20 public who, in the determination of the secretary, present no conflicts
- 21 of interest to matters included in this chapter. The secretary shall
- 22 appoint the members for staggered terms, two members for one-year
- 23 terms, two members for two-year terms, and three members for three-year
- 24 terms. Subsequent appointments shall be for three-year terms.
- 25 (2) The secretary may remove any member for cause as specified by
- 26 rule. In the case of a vacancy, the secretary shall appoint a person
- 27 to serve for the remainder of the unexpired term.
- 28 (3) The committee shall meet at the request of the secretary and
- 29 hold meetings during the year as necessary to provide advice to the
- 30 secretary concerning the implementation of this chapter. The committee
- 31 may elect a chair and vice-chair. A majority of the members currently
- 32 serving shall constitute a quorum.
- 33 (4) Each member shall be reimbursed for travel expenses, as
- 34 authorized in RCW 43.03.050 and 43.03.060, and shall serve without

35 compensation.

- 1 (5) The secretary, members of the committee, or individuals acting 2 on their behalf are immune from civil action for official acts 3 performed in the course of their duties.
- The secretary, in consultation with the 4 NEW SECTION. Sec. 9. advisory committee, shall adopt rules establishing the minimum 5 standards to be implemented by breeders. The program shall include, 6 7 but not be limited to, provisions for adequate housing, nutrition, hydration, sanitation, vaccinations, exercise and socialization needs, 8 9 internal and external parasite controls, care of pregnant and nursing 10 animals, first aid and emergency protocols, treatment of illness and injury, and humane euthanasia methods. The secretary is guided by the 11 12 requirements of the federal animal welfare act (7 U.S.C. Sec. 2131 et seq.), and rules adopted under this section may not be inconsistent 13 14 with the federal act.
- NEW SECTION. **Sec. 10.** In addition to any action the secretary may take for acts of unprofessional conduct specified under the uniform disciplinary act, chapter 18.130 RCW, the secretary may deny or revoke the registration of a breeder who:
- 19 (1) Violates this act or any rules adopted under this act that are 20 considered an act of unprofessional conduct for purposes of the uniform 21 disciplinary act;
 - (2) Is convicted of violating RCW 16.52.205 or 16.52.207; or
- (3) Is convicted of violating any animal protection law of this state or ordinance or substantially similar law in any other jurisdiction concerning the proper breeding, care, housing, raising, or treatment of dogs or cats.
- 27 **Sec. 11.** RCW 18.130.040 and 1996 c 200 s 32 and 1996 c 81 s 5 are 28 each reenacted and amended to read as follows:
- 29 (1) This chapter applies only to the secretary and the boards and 30 commissions having jurisdiction in relation to the professions licensed 31 under the chapters specified in this section. This chapter does not 32 apply to any business or profession not licensed under the chapters 33 specified in this section.
- 34 (2)(a) The secretary has authority under this chapter in relation 35 to the following professions:

- 29 (b) The boards and commissions having authority under this chapter
- 30 are as follows:
- 31 (i) The podiatric medical board as established in chapter 18.22
- 32 RCW;
- 33 (ii) The chiropractic quality assurance commission as established
- 34 in chapter 18.25 RCW;
- 35 (iii) The dental quality assurance commission as established in
- 36 chapter 18.32 RCW;
- 37 (iv) The board of hearing and speech as established in chapter

- 1 (v) The board of examiners for nursing home administrators as 2 established in chapter 18.52 RCW;

- 23 (3) In addition to the authority to discipline license holders, the
- 24 disciplining authority has the authority to grant or deny licenses
- 25 based on the conditions and criteria established in this chapter and
- 26 the chapters specified in subsection (2) of this section. This chapter
- 27 also governs any investigation, hearing, or proceeding relating to
- 28 denial of licensure or issuance of a license conditioned on the
- 29 applicant's compliance with an order entered pursuant to RCW 18.130.160
- 30 by the disciplining authority.
- 31 (4) All disciplining authorities shall adopt procedures to ensure
- 32 substantially consistent application of this chapter, the Uniform
- 33 Disciplinary Act, among the disciplining authorities listed in
- 34 subsection (2) of this section.
- 35 <u>NEW SECTION.</u> **Sec. 12.** Sections 2 through 10 of this act
- 36 constitute a new chapter in Title 18 RCW.

- 2 take effect January 1, 1998.
