1 AN ACT Relating to the capital budget; amending 1995 2nd sp.s. c 16
2 s 713 (uncodified); adding new sections to 1995 2nd sp.s. c 16; making
3 appropriations and authorizing expenditures for capital improvements;
4 and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
