- 1 AN ACT Relating to the definition of the practice of optometry; and
- 2 amending RCW 18.53.010.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 18.53.010 and 1989 c 36 s 1 are each amended to read 5 as follows:
- 6 (1) The practice of optometry is defined as the examination of the 7 human eye, the examination and ascertaining any defects of the human 8 vision system and the analysis of the process of vision. The practice 9 of optometry may include, but not necessarily be limited to, the 10 following:
- 11 (a) The employment of any objective or subjective means or method,
  12 or procedure included in the curricula of recognized schools of
  13 optometry as approved by the board of optometry, including the use of
  14 drugs topically applied to the eye for diagnostic and therapeutic
  15 purposes by those licensed under this chapter and who meet the
  16 requirements of subsections (2) and (3) of this section, and the use of
- 17 any diagnostic instruments or devices for the examination or analysis
- 18 of the human vision system, the measurement of the powers or range of

- 1 human vision, or the determination of the refractive powers of the 2 human eye or its functions in general; and
- 3 (b) The prescription and fitting of lenses, prisms, therapeutic or 4 refractive contact lenses and the adaption or adjustment of frames and 5 lenses used in connection therewith; and
  - (c) The prescription and provision of visual therapy, therapeutic aids and other optical devices, and the treatment with topically applied drugs by those licensed under this chapter and who meet the requirements of subsections (2) and (3) of this section; and
- 10 (d) The ascertainment of the perceptive, neural, muscular or 11 pathological condition of the visual system; and
  - (e) The adaptation of prosthetic eyes.

- 13 (2) Those persons using drugs for diagnostic purposes in the practice of optometry shall have a minimum of sixty hours of didactic 14 15 and clinical instruction in general and ocular pharmacology as applied 16 to optometry, and for therapeutic purposes, an additional minimum of seventy-five hours of didactic and clinical instruction as established 17 by the board, and certification from an institution of higher learning, 18 19 accredited by those agencies recognized by the United States office of 20 education or the council on postsecondary accreditation to qualify for certification by the optometry board of Washington to use drugs for 21 diagnostic and therapeutic purposes. Such course or courses shall be 22 23 the fiscal responsibility of the participating and attending 24 optometrist.
  - (3) The board shall establish a schedule of drugs for diagnostic and treatment purposes limited to the practice of optometry, and no person licensed pursuant to this chapter shall prescribe, dispense, purchase, possess, or administer drugs except as authorized and to the extent permitted by the board.
- 30 (4) The board shall develop a means of identification and 31 verification of optometrists certified to use therapeutic drugs for the 32 purpose of issuing prescriptions as authorized by this section.
