- AN ACT Relating to apiaries; amending RCW 15.62.010, 15.62.020,
- 2 15.62.030, 15.62.040, 15.62.070, 15.62.080, 15.62.140, 15.62.300, and
- 3 15.60.005; adding new sections to chapter 17.24 RCW; repealing RCW
- 4 15.60.007, 15.60.010, 15.60.015, 15.60.020, 15.60.025, 15.60.030,
- 5 15.60.040, 15.60.042, 15.60.043, 15.60.050, 15.60.100, 15.60.110,
- 6 15.60.120, 15.60.140, 15.60.150, 15.60.170, 15.60.230, and 15.60.900;
- 7 providing an effective date; and declaring an emergency.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 9 **Sec. 1.** RCW 15.62.010 and 1989 c 5 s 1 are each amended to read as 10 follows:
- 11 (1) The purpose of this chapter is to ((advance the public welfare
- 12 and education and to)) provide the apiary industry the opportunity to
- 13 <u>establish a honey bee commission;</u> promote the interest, products,
- 14 services, and stabilization of Washington's honey bee industry;
- 15 identify and conduct research on treatments and medications to control
- 16 bee pests; and perform nonregulatory functions and provide information
- 17 and services to beekeepers in the state.
- 18 (2) The legislature finds that:

- (((1))) (a) Increasing the consumption of products of the honey bee 1 2 industry and promoting the use of its services and stabilizing the honey bee industry within the state and nation is a valid and necessary 3 4 exercise of the power of the state to protect the public health, to 5 provide for the economic development of the state, and to promote the welfare of the people of the state; 6
- 7  $((\frac{2}{2}))$  Honey bee industry products produced and services provided in Washington make an important contribution to 8 9 agricultural industry of the state of Washington. The business of 10 researching, marketing, and distributing such products and the promotion of its services is in the public interest; 11
- 12  $((\frac{3}{1}))$  (c) It is necessary to enhance the reputation of Washington 13 honey bee industry products and services in domestic and national 14 markets;
- 15 (((4))) (d) It is necessary to promote and educate the public regarding the value of honey bee industry products and services, and to 16 spread that knowledge throughout the state and nation to increase the 17 awareness and consumption of honey bee products and the use of honey 18 19 bee services;
- 20 (((5))) (e) State and national markets for Washington honey bee industry products may benefit from promotion of honey bee products 21 22 through education and advertising;
- 23 (((6))) It is necessary to stabilize the Washington honey bee 24 industry, to enlarge its markets, and increase the consumption of Washington honey bee industry products and services to assure the 26 payment of taxes to the state and its subdivisions, to alleviate 27 unemployment, and to provide for higher wage scales for agricultural labor and maintenance of a reasonable standard of living;
- 29  $((\frac{7}{1}))$  (g) Providing information to the public on the manner, 30 cost, and expense of producing, and the care taken to produce and sell, honey bee industry products and services of the highest quality, the 31 methods and care used in their preparation for market, and the methods 32 of sale and distribution is in the public interest; 33
- 34 (((8))) (h) It is necessary to protect the public by educating it 35 on the various benefits of honey bee industry services, the food value of its products, and their industrial and medicinal uses. 36
- 37 Sec. 2. RCW 15.62.020 and 1989 c 5 s 2 are each amended to read as follows: 38

- Unless the context clearly requires otherwise, the definitions in this section apply throughout this chapter:
- 3 (1) "Affected person" means an apiarist, manufacturer, processor, 4 first handler, broker, or volunteer who shall pay to the commission the 5 minimum assessments required in RCW 15.62.140.
- 6 (2) "Apiarist" means any person, firm, partnership, association, or corporation who owns, operates, manages, or brokers ((ten)) five or 8 more honey bee (Apis mellifera) colonies in the state or any 9 ((volunteer participant having less than ten colonies)) owner of one to 10 four colonies in the state of Washington that voluntarily registers with the department.
- 12 (3) "Bee colony" means a natural group of honey bees containing 13 seven thousand or more workers and one or more queens, housed in a man-14 made hive with movable frames, and operated as a beekeeping unit.
- 15 (4) "Bee pests" means mites, other parasites, or diseases that 16 cause injury to bees.
- 17 <u>(5)</u> "Broker" means any person other than an apiarist who, for a 18 fee, places or sets twenty-five or more bee colonies for pollination or 19 buys and sells one thousand dollars or more per year of industry 20 products he or she does not produce or manufacture.
- 21 (((5))) (6) "Commission" means the Washington state honey bee 22 industry commission or its authorized agents.
- (((6))) "Department" means the department of agriculture.
- $((\frac{7}{1}))$  (8) "Director" means the director of the department of agriculture.
- $((\frac{8}{8}))$  (9) "First handler" means any person in Washington who imports industry products or bee supplies and equipment into Washington for processing, packing, or sale in the state of Washington.
- ((<del>(9)</del>)) <u>(10)</u> "Industry products" means queen bees, packaged bees, and items which are made by bees including, but not limited to, honey, pollen, bees wax, and propolis and items manufactured for use in the honey bee industry as enumerated under "manufacturer" in this section.
- ((\(\frac{(10)}{10}\))) (11) "Manufacturer" means any person making bee supplies and equipment such as: Supers (hive boxes), frames, bees wax foundation, smokers, extractors, bee veils, pollen traps, queen rearing equipment, bee cages and packages, queen excluders, and other bee supplies used in the honey bee industry.
- $((\frac{11}{11}))$  (12) "Person" means any individual, firm, partnership, or corporation engaged in the apiculture industry.

- 6 **Sec. 3.** RCW 15.62.030 and 1989 c 5 s 3 are each amended to read as
- 7 follows:
- 8 A petition may be filed with the director to conduct a referendum
- 9 to form a honey bee commission. A referendum shall be conducted if the
- 10 petition contains the names of at least fifteen percent of the
- 11 apiarists registered in accordance with RCW 15.60.050 or section 9 of
- 12 this act during the most recent registration period and that those
- 13 persons represent fifteen percent of the registered hives. The
- 14 director shall conduct the referendum by mail.
- The Washington state honey bee commission shall be established

- ((<del>(6) To</del>)) <u>(14) I</u>nvestigate and refer violations of this chapter to local prosecuting attorneys or special prosecutors appointed by the commission and the local prosecuting attorney;
- ((<del>(7) To)</del>) (15) Contract for scientific research designed to improve production, pollination, management, quality, processing, and distribution and ((<del>to</del>)) develop and discover uses for products of the honey bee industry;
- 30 ((<del>(8) To</del>)) (16) Make in its name advertising contracts and other 31 agreements necessary to promote the industry and bee products and 32 services in state, national, and foreign markets;
- ((<del>(9) To</del>)) <u>(17) Keep accurate records of all commission dealings,</u>
  which shall be open to public inspection and audit by authorized state
  agencies;
- ((<del>(10) To</del>)) <u>(18) Contract</u> for research to develop more efficient methods of promoting the honey bee industry and its products and services;

- 4 (((12) To)) (20) Enter into contracts and agreements for purposes 5 consistent with this chapter;
- 6  $((\frac{13}{T_0}))$  <u>(21)</u> Publish at least an annual report of its 7 activities and financial status subject to audit by the state auditor;
- 8 ((<del>(14) To)</del>) <u>(22) E</u>stablish an operating monetary reserve and carry 9 over to subsequent fiscal periods any excess funds in the reserve:
- 10 PROVIDED, That the reserve funds shall not exceed one fiscal period's
- 11 budget. The reserve funds shall only be used to defray any expenses
- 12 authorized under this chapter;
- 13  $((\frac{(15)}{T0}))$  <u>(23)</u> Audit any affected person's records as described

- 22 (1) The regular terms of office of each elected member of the 23 commission shall be three years, except that the term of office for the
- 24 initial members shall be as follows:
- 25 (a) Positions for areas one, four, and seven one year.
- 26 (b) Positions for areas two, five, and eight two years.
- 27 (c) Positions for areas three, six, and nine three years.
- 28 (d) If filled, position for area eleven three years.
- 29 (2) No elected member of the board may serve more than two full 30 consecutive three-year terms.
- 31 (3) Terms of office shall end on August 31<u>st</u> of the last year of 32 the elected or appointed term.
- 33 (4) Any vacancies on the commission shall be filled by a person

- 3 (1) Apiarist members of the commission shall be nominated and 4 elected by the apiarists within the district they are to represent in 5 the year in which a member's term expires. The candidate receiving the 6 largest number of votes cast shall be elected. The election shall be 7 by secret mail ballot and shall be conducted by the director, who shall 8 be reimbursed for actual expenses of conducting the election by the 9 commission.
- 10 (2) The director shall provide forms for the nomination of 11 candidates to each affected person. The nomination form shall provide 12 for the name of the person being nominated and the names of five 13 persons supporting the nomination.
- 14 (3) The persons nominating the candidate shall affirm that the 15 candidate meets the qualifications and is willing to serve by signing 16 the nomination form.
- 17 (4) The nomination forms shall be returned to the director by June 18 30th of the election year, and the director shall not accept any 19 nomination postmarked later than midnight of that date.
- (5) In the event no nomination is submitted for a position, the director shall nominate at least two, but no more than three, qualified persons and place their names on the election ballot as nominees. Any qualified person may be elected by write-in ballot, even though his or her name was not placed in nomination.
- 25 (6) Ballots for electing commission members shall be mailed by the director to all apiarists and brokers in areas where elections are to 26 27 be held no later than July 15st. Ballots, to be valid, shall be returned to the director postmarked no later than July 31st. Elected 28 29 persons shall take office effective September 1st of the year elected 30 except, if a referendum is approved before December 31, 1998, initial elections shall take place within one hundred twenty days ((after July 31 23, 1989)) of the date of approval. If a referendum is approved before 32 December 31, 1998, the director has the discretion to set dates for 33 34 submitting nominations, and mailing out and returning ballots for the initial election of commission members. 35
- 36 (7) If a referendum to establish a commission is approved, the 37 director has the discretion to call for the immediate nomination of 38 apiarists and to establish the dates for mailing out and returning 39 ballots for the initial election of commission members.

- In the ((seventh)) <u>fifth</u> year following the inception of the
