- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.04 RCW 7 to read as follows:
- 8 (1) In computing tax due under this chapter, there may be deducted
- 9 from the measure of tax all amounts received by a nonprofit
- 10 neighborhood recreational organization:
- 11 (a) As membership fees or dues, irrespective of the fact that the
- 12 payment of the membership fees or dues to the organization might
- 13 entitle its members, in addition to other rights or privileges, to use
- 14 the organization's facilities; and
- 15 (b) From members of the organization for recreational services
- 16 provided by the organization or for the use of the organization's
- 17 recreational facilities.
- 18 (2) For the purposes of this section, "nonprofit neighborhood
- 19 recreational organization" means a nonprofit organization engaged in

- 1 providing recreational, swimming pool, and tennis court facilities to

- 3 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.08 RCW 4 to read as follows:
- 5 (1) The tax imposed by RCW 82.08.020 does not apply to sales by a 6 nonprofit neighborhood recreational organization of:
- 7 (a) Membership fees or dues, irrespective of the fact that the 8 payment of the membership fees or dues to the organization might 9 entitle its members, in addition to other rights or privileges, to use 10 the organization's facilities; and
- 11 (b) Recreational services provided by the organization or for the 12 use of the organization's recreational facilities, to members of the 13 organization.
- 14 (2) For the purposes of this section, "nonprofit neighborhood 15 recreational organization" means a nonprofit organization engaged in 16 providing recreational, swimming pool, and tennis court facilities to 17 members who share ownership of the facilities.
- NEW SECTION. Sec. 3. A new section is added to chapter 82.12 RCW to read as follows:
- 20 (1) The provisions of this chapter do not apply in respect to the 21 use of the following items provided by a nonprofit neighborhood 22 recreational organization:
- (a) Membership fees or dues, irrespective of the fact that the payment of the membership fees or dues to the organization might entitle its members, in addition to other rights or privileges, to use the organization's facilities; and
- (b) Recreational services provided by the organization or for the use of the organization's recreational facilities, to members of the organization.
- 30 (2) For the purposes of this section, "nonprofit neighborhood 31 recreational organization" means a nonprofit organization engaged in 32 providing recreational, swimming pool, and tennis court facilities to 33 members who share ownership of the facilities.
