SUBSTITUTE SENATE BILL 6637

- 1 AN ACT Relating to low-alcohol beverage coolers; amending RCW
- 2 66.04.010; adding a new section to chapter 66.24 RCW; and providing an
- 3 effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 66.04.010 and 1997 c 321 s 37 are each amended to read 6 as follows:
- 7 In this title, unless the context otherwise requires:
- 8 (1) "Alcohol" is that substance known as ethyl alcohol, hydrated
- 9 oxide of ethyl, or spirit of wine, which is commonly produced by the
- 10 fermentation or distillation of grain, starch, molasses, or sugar, or
- 11 other substances including all dilutions and mixtures of this
- 12 substance. The term "alcohol" does not include alcohol in the
- 13 possession of a manufacturer or distiller of alcohol fuel, as described
- 14 in RCW 66.12.130, which is intended to be denatured and used as a fuel
- 15 for use in motor vehicles, farm implements, and machines or implements
- 16 of husbandry.
- 17 (2) "Beer" means any malt beverage or malt liquor as these terms
- 18 are defined in this chapter.

- 1 (3) "Beer distributor" means a person who buys beer from a brewer 2 or brewery located either within or beyond the boundaries of the state, 3 beer importers, or foreign produced beer from a source outside the 4 state of Washington, for the purpose of selling the same pursuant to 5 this title, or who represents such brewer or brewery as agent.
- 6 (4) "Beer importer" means a person or business within Washington 7 who purchases beer from a United States brewery holding a certificate 8 of approval (B5) or foreign produced beer from a source outside the 9 state of Washington for the purpose of selling the same pursuant to 10 this title.
- 11 (5) "Brewer" means any person engaged in the business of 12 manufacturing beer and malt liquor.
- 13 (6) "Board" means the liquor control board, constituted under this 14 title.
- 15 (7) "Club" means an organization of persons, incorporated or 16 unincorporated, operated solely for fraternal, benevolent, educational, 17 athletic or social purposes, and not for pecuniary gain.
- 18 (8) "Consume" includes the putting of liquor to any use, whether by drinking or otherwise.
- (9) "Dentist" means a practitioner of dentistry duly and regularly licensed and engaged in the practice of his profession within the state pursuant to chapter 18.32 RCW.
- 23 (10) "Distiller" means a person engaged in the business of 24 distilling spirits.
- 25 (11) "Domestic winery" means a place where wines are manufactured 26 or produced within the state of Washington.
- 27 (12) "Druggist" means any person who holds a valid certificate and 28 is a registered pharmacist and is duly and regularly engaged in 29 carrying on the business of pharmaceutical chemistry pursuant to 30 chapter 18.64 RCW.
- 31 (13) "Drug store" means a place whose principal business is, the 32 sale of drugs, medicines and pharmaceutical preparations and maintains 33 a regular prescription department and employs a registered pharmacist 34 during all hours the drug store is open.
- 35 (14) "Employee" means any person employed by the board, including 36 a vendor, as hereinafter in this section defined.
 - (15) "Fund" means 'liquor revolving fund.'
- 38 (16) "Hotel" means every building or other structure kept, used, 39 maintained, advertised or held out to the public to be a place where

food is served and sleeping accommodations are offered for pay to 1 transient guests, in which twenty or more rooms are used for the 2 sleeping accommodation of such transient guests and having one or more 3 4 dining rooms where meals are served to such transient guests, such 5 sleeping accommodations and dining rooms being conducted in the same building and buildings, in connection therewith, and such structure or 6 7 structures being provided, in the judgment of the board, with adequate 8 and sanitary kitchen and dining room equipment and capacity, for 9 preparing, cooking and serving suitable food for its guests: PROVIDED 10 FURTHER, That in cities and towns of less than five thousand population, the board shall have authority to waive the provisions 11 12 requiring twenty or more rooms.

- 13 (17) "Importer" means a person who buys distilled spirits from a 14 distillery outside the state of Washington and imports such spirituous 15 liquor into the state for sale to the board or for export.
 - (18) "Imprisonment" means confinement in the county jail.

- 17 (19) "Liquor" includes the four varieties of liquor herein defined (alcohol, spirits, wine and beer), and all fermented, spirituous, 18 19 vinous, or malt liquor, or combinations thereof, and mixed liquor, a part of which is fermented, spirituous, vinous or malt liquor, or 20 otherwise intoxicating; and every liquid or solid or semisolid or other 21 substance, patented or not, containing alcohol, spirits, wine or beer, 22 23 and all drinks or drinkable liquids and all preparations or mixtures 24 capable of human consumption, and any liquid, semisolid, solid, or 25 other substance, which contains more than one percent of alcohol by 26 weight shall be conclusively deemed to be intoxicating. Liquor does 27 not include confections or food products that contain one percent or less of alcohol by weight. 28
- (20) "Low-alcohol beverage cooler" means a drink containing onehalf of one percent or more of alcohol by volume, but not more than
 seven and one-half percent alcohol by volume, and consisting of spirits
 mixed with nonalcoholic beverages or flavoring or coloring materials;
 it may also contain water, fruit juices, fruit adjuncts, sugar, carbon
 dioxide, preservatives, or other similar products manufactured by
 fermenting fruit or fruit juices.
- 36 <u>(21)</u> "Manufacturer" means a person engaged in the preparation of 37 liquor for sale, in any form whatsoever.
- $((\frac{(21)}{(21)}))$ <u>(22)</u> "Malt beverage" or "malt liquor" means any beverage such as beer, ale, lager beer, stout, and porter obtained by the

- 1 alcoholic fermentation of an infusion or decoction of pure hops, or
- 2 pure extract of hops and pure barley malt or other wholesome grain or
- 3 cereal in pure water containing not more than eight percent of alcohol
- 4 by weight, and not less than one-half of one percent of alcohol by
- 5 volume. For the purposes of this title, any such beverage containing
- 6 more than eight percent of alcohol by weight shall be referred to as
- 7 "strong beer."
- 8 $((\frac{(22)}{2}))$ "Package" means any container or receptacle used for
- 9 holding liquor.
- 10 $((\frac{(23)}{)})$ <u>(24)</u> "Permit" means a permit for the purchase of liquor
- 11 under this title.
- 12 $((\frac{24}{1}))$ "Person" means an individual, copartnership,
- 13 association, or corporation.
- $((\frac{(25)}{)}))$ (26) "Physician" means a medical practitioner duly and
- 15 regularly licensed and engaged in the practice of his profession within
- 16 the state pursuant to chapter 18.71 RCW.
- 17 $((\frac{26}{1}))$ "Prescription" means a memorandum signed by a
- 18 physician and given by him to a patient for the obtaining of liquor
- 19 pursuant to this title for medicinal purposes.
- 20 $((\frac{27}{27}))$ <u>(28)</u> "Public place" includes streets and alleys of
- 21 incorporated cities and towns; state or county or township highways or
- 22 roads; buildings and grounds used for school purposes; public dance
- 23 halls and grounds adjacent thereto; those parts of establishments where
- 24 beer may be sold under this title, soft drink establishments, public
- 25 buildings, public meeting halls, lobbies, halls and dining rooms of
- 26 hotels, restaurants, theatres, stores, garages and filling stations
- 27 which are open to and are generally used by the public and to which the
- 28 public is permitted to have unrestricted access; railroad trains,
- 29 stages, and other public conveyances of all kinds and character, and
- 30 the depots and waiting rooms used in conjunction therewith which are
- 31 open to unrestricted use and access by the public; publicly owned
- 32 bathing beaches, parks, and/or playgrounds; and all other places of
- 33 like or similar nature to which the general public has unrestricted
- 34 right of access, and which are generally used by the public.
- $((\frac{(28)}{(28)}))$ "Regulations" means regulations made by the board
- 36 under the powers conferred by this title.
- $((\frac{(29)}{(30)}))$ "Restaurant" means any establishment provided with
- 38 special space and accommodations where, in consideration of payment,

- 1 food, without lodgings, is habitually furnished to the public, not 2 including drug stores and soda fountains.
- $((\frac{30}{10}))$ (31) "Sale" and "sell" include exchange, barter, and 3 4 traffic; and also include the selling or supplying or distributing, by any means whatsoever, of liquor, or of any liquid known or described as 5 beer or by any name whatever commonly used to describe malt or brewed 6 7 liquor or of wine, by any person to any person; and also include a sale 8 or selling within the state to a foreign consignee or his agent in the 9 state. "Sale" and "sell" shall not include the giving, at no charge, 10 of a reasonable amount of liquor by a person not licensed by the board to a person not licensed by the board, for personal use only. "Sale" 11 and "sell" also does not include a raffle authorized under RCW 12 13 9.46.0315: PROVIDED, That the nonprofit organization conducting the
- $((\frac{31}{1}))$ (32) "Soda fountain" means a place especially equipped with apparatus for the purpose of dispensing soft drinks, whether mixed or otherwise.

raffle has obtained the appropriate permit from the board.

- (((32))) <u>(33)</u> "Spirits" means any beverage which contains alcohol obtained by distillation, including wines exceeding twenty-four percent of alcohol by volume. <u>"Spirits" does not mean low-alcohol beverage</u> coolers.
- 22 (((33))) (34) "Store" means a state liquor store established under 23 this title.
- (((34))) (35) "Tavern" means any establishment with special space and accommodation for sale by the glass and for consumption on the premises, of beer, as herein defined.
- 27 (((35))) (36) "Vendor" means a person employed by the board as a 28 store manager under this title.
- (((36))) (37) "Winery" means a business conducted by any person for the manufacture of wine for sale, other than a domestic winery.
- 31 $((\frac{37}{1}))$ (38) "Wine" means any alcoholic beverage obtained by fermentation of fruits (grapes, berries, apples, et cetera) or other 32 33 agricultural product containing sugar, to which any saccharine 34 substances may have been added before, during or after fermentation, 35 and containing not more than twenty-four percent of alcohol by volume, including sweet wines fortified with wine spirits, such as port, 36 37 sherry, muscatel and angelica, not exceeding twenty-four percent of alcohol by volume and not less than one-half of one percent of alcohol 38 by volume. For purposes of this title, any beverage containing no more 39

- 1 than fourteen percent of alcohol by volume when bottled or packaged by
- 2 the manufacturer shall be referred to as "table wine," and any beverage
- 3 containing alcohol in an amount more than fourteen percent by volume
- 4 when bottled or packaged by the manufacturer shall be referred to as
- 5 "fortified wine." However, "fortified wine" shall not include: (a)
- 6 Wines that are both sealed or capped by cork closure and aged two years
- 7 or more; and (b) wines that contain more than fourteen percent alcohol
- 8 by volume solely as a result of the natural fermentation process and
- 9 that have not been produced with the addition of wine spirits, brandy,
- 10 or alcohol.
- 11 This subsection shall not be interpreted to require that any wine
- 12 be labeled with the designation "table wine" or "fortified wine."
- (((38))) (39) "Wine distributor" means a person who buys wine from
- 14 a vintner or winery located either within or beyond the boundaries of
- 15 the state for the purpose of selling the same not in violation of this
- 16 title, or who represents such vintner or winery as agent.
- 17 (((39))) (40) "Wine importer" means a person or business within
- 18 Washington who purchases wine from a United States winery holding a
- 19 certificate of approval (W7) or foreign produced wine from a source
- 20 outside the state of Washington for the purpose of selling the same
- 21 pursuant to this title.
- 22 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 66.24 RCW
- 23 to read as follows:
- 24 (1) Low-alcohol beverage coolers as defined in RCW 66.24.010(20)
- 25 shall be taxed at the rate of twenty and one-fourth cents per liter.
- 26 (2) An additional tax is imposed equal to the rate specified in RCW
- 27 82.02.030 multiplied by the tax payable under subsection (1) of this
- 28 section. All revenues collected during any month from this additional
- 29 tax shall be transferred to the state general fund by the twenty-fifth
- 30 day of the following month.
- 31 <u>NEW SECTION.</u> **Sec. 3.** This act takes effect July 1, 1998.
