- AN ACT Relating to growth management; amending RCW 36.70A.030, 1 2 36.70A.060, 36.70A.070, 36.70A.130, 36.70A.270, 36.70A.290, 36.70A.300, 3 36.70A.305, 36.70A.320, 36.70A.330, 36.70A.110, 43.62.035, 36.70A.500, 43.155.070, 70.146.070, 84.34.020, 84.34.060, 84.34.065, 84.40.030, 4 90.60.030, 35A.14.295, 35.13.174, 36.93.170, 84.14.010, 84.14.030, 5 84.14.050, 90.61.020, 90.61.040, 36.70B.040, 43.21C.110, 36.70B.110, 6 7 43.21C.075, 90.58.090, 90.58.143, and 34.05.518; adding new sections to chapter 36.70A RCW; adding a new section to chapter 35.13 RCW; creating 8 new sections; providing expiration dates; and declaring an emergency.
- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. **Sec. 1.** A new section is added to chapter 36.70A RCW to read as follows:
- In enacting the section 7(5), chapter . . ., Laws of 1997 (section
- 14 7(5) of this act) amendments to RCW 36.70A.070(5), the legislature
- 15 finds that chapter 36.70A RCW is intended to recognize the importance
- 16 of agriculture, forestry, and rural lands and rural character to
- 17 Washington's economy, its people, and its environment, while respecting
- 18 regional differences and, in accordance with one of the goals of the
- 19 growth management act, protecting the property rights of landowners

from arbitrary and discriminatory actions. Rural lands and rural-based 1 economies, including agriculture and forest uses that are located 2 outside of designated resource lands, enhance the economic desirability 3 4 of the state, help to preserve traditional economic activities, and 5 contribute to the state's overall quality of life. The legislature developing its rural element 6 also finds that in under 7 36.70A.070(5), a county should foster land use patterns and develop a 8 local vision of rural character that: Will help preserve rural-based 9 economies and traditional rural lifestyles; will encourage the economic 10 prosperity of rural residents; will foster opportunities for smallscale, rural-based employment and self-employment; will permit the 11 operation of rural-based agricultural, commercial, recreational, and 12 13 tourist businesses that are consistent with existing and planned land use patterns; will foster the private stewardship of the land and 14 15 preservation of open space; and will enhance the rural sense of community and quality of life. The legislature recognizes that there 16 17 will be a variety of interpretations by counties of how best to implement a rural element, reflecting the diverse needs and local 18 19 circumstances found across the state. RCW 36.70A.070(5) provides a framework for local elected officials to make these determinations. 20 References to both wildlife and water are intended in RCW 36.70A.030 21 36.70A.070 to acknowledge their importance as features or 22 23 components of rural character. It is expected that these matters will 24 be addressed in comprehensive plans, but that counties may not 25 necessarily need to adopt new regulations to account adequately for 26 them in establishing a pattern of land use and development for rural 27 areas.

NEW SECTION. Sec. 2. A new section is added to chapter 36.70A RCW to read as follows:

30 In amending RCW 36.70A.320(3) by section 20(3), chapter . . ., Laws of 1997 (section 20(3) of this act), the legislature intends that the 31 boards apply a more deferential standard of review to actions of 32 33 counties and cities than the preponderance of the evidence standard 34 provided for under existing law. In recognition of the broad range of discretion that may be exercised by counties and cities consistent with 35 36 the requirements of this chapter, the legislature intends for the boards to grant deference to counties and cities in how they plan for 37 growth, consistent with the requirements and goals of this chapter. 38

- 1 Local comprehensive plans and development regulations require counties
- 2 and cities to balance priorities and options for action in full
- 3 consideration of local circumstances. The legislature finds that while
- 4 this chapter requires local planning to take place within a framework
- 5 of state goals and requirements, the ultimate burden and responsibility
- 6 for planning, harmonizing the planning goals of this chapter, and
- 7 implementing a county's or city's future rests with that community.
- 8 **Sec. 3.** RCW 36.70A.030 and 1995 c 382 s 9 are each amended to read 9 as follows:
- 10 Unless the context clearly requires otherwise, the definitions in 11 this section apply throughout this chapter.
- 12 (1) "Adopt a comprehensive land use plan" means to enact a new 13 comprehensive land use plan or to update an existing comprehensive land 14 use plan.
- 15 (2) "Agricultural land" means land primarily devoted to the 16 commercial production of horticultural, viticultural, floricultural, 17 dairy, apiary, vegetable, or animal products or of berries, grain, hay, 18 straw, turf, seed, Christmas trees not subject to the excise tax 19 imposed by RCW 84.33.100 through 84.33.140, finfish in upland
- 20 hatcheries, or livestock, and that has long-term commercial
- 21 significance for agricultural production.
- 22 (3) "City" means any city or town, including a code city.
- (4) "Comprehensive land use plan," "comprehensive plan," or "plan" means a generalized coordinated land use policy statement of the governing body of a county or city that is adopted pursuant to this chapter.
- (5) "Critical areas" include the following areas and ecosystems:
  (a) Wetlands; (b) areas with a critical recharging effect on aquifers
  used for potable water; (c) fish and wildlife habitat conservation
  areas; (d) frequently flooded areas; and (e) geologically hazardous
  areas.
- 32 (6) "Department" means the department of community, trade, and 33 economic development.
- (7) "Development regulations" or "regulation" means the controls placed on development or land use activities by a county or city, including, but not limited to, zoning ordinances, critical areas ordinances, shoreline master programs, official controls, planned unit development ordinances, subdivision ordinances, and binding site plan

- ordinances together with any amendments thereto. A development regulation does not include a decision to approve a project permit application, as defined in RCW 36.70B.020, even though the decision may be expressed in a resolution or ordinance of the legislative body of the county or city.
- (8) "Forest land" means land primarily devoted to growing trees for 6 7 long-term commercial timber production on land that can be economically 8 and practically managed for such production, including Christmas trees 9 subject to the excise tax imposed under RCW 84.33.100 through 10 84.33.140, and that has long-term commercial significance. determining whether forest land is primarily devoted to growing trees 11 for long-term commercial timber production on land that can be 12 13 economically and practically managed for such production, the following factors shall be considered: (a) The proximity of the land to urban, 14 15 suburban, and rural settlements; (b) surrounding parcel size and the 16 compatibility and intensity of adjacent and nearby land uses; (c) long-17 term local economic conditions that affect the ability to manage for timber production; and (d) the availability of public facilities and 18 19 services conducive to conversion of forest land to other uses.
- (9) "Geologically hazardous areas" means areas that because of their susceptibility to erosion, sliding, earthquake, or other geological events, are not suited to the siting of commercial, residential, or industrial development consistent with public health or safety concerns.
- (10) "Long-term commercial significance" includes the growing capacity, productivity, and soil composition of the land for long-term commercial production, in consideration with the land's proximity to population areas, and the possibility of more intense uses of the land.
- 29 (11) "Minerals" include gravel, sand, and valuable metallic 30 substances.
- 31 (12) "Public facilities" include streets, roads, highways, 32 sidewalks, street and road lighting systems, traffic signals, domestic 33 water systems, storm and sanitary sewer systems, parks and recreational 34 facilities, and schools.
- 35 (13) "Public services" include fire protection and suppression, law 36 enforcement, public health, education, recreation, environmental 37 protection, and other governmental services.

- 1 (14) "Rural character" refers to the patterns of land use and 2 development established by a county in the rural element of its 3 comprehensive plan:
- 4 <u>(a) In which open space, the natural landscape, and vegetation</u> 5 <u>predominate over the built environment;</u>
- 6 (b) That foster traditional rural lifestyles, rural-based 7 economies, and opportunities to both live and work in rural areas;
- 8 (c) That provide visual landscapes that are traditionally found in 9 rural areas and communities;
- 10 <u>(d) That are compatible with the use of the land by wildlife and</u>
  11 for fish and wildlife habitat;
- 12 <u>(e) That reduce the inappropriate conversion of undeveloped land</u>
  13 <u>into sprawling, low-density development;</u>
- (f) That generally do not require the extension of urban governmental services; and
- 16 <u>(g) That are consistent with the protection of natural surface</u> 17 <u>water flows and ground water and surface water recharge and discharge</u> 18 <u>areas.</u>
- 19 (15) "Rural development" refers to development outside the urban growth area and outside agricultural, forest, and mineral resource 20 lands designated pursuant to RCW 36.70A.170. Rural development can 21 consist of a variety of uses and residential densities, including 22 clustered residential development, at levels that are consistent with 23 24 the preservation of rural character and the requirements of the rural element. Rural development does not refer to agriculture or forestry 25 26 activities that may be conducted in rural areas.
- (16) "Rural governmental services" or "rural services" include 27 28 those public services and public facilities historically and typically 29 delivered at an intensity usually found in rural areas, and may include 30 domestic water systems, fire and police protection services, transportation and public transit services, and other public utilities 31 associated with rural development and normally not associated with 32 urban areas. Rural services do not include storm or sanitary sewers, 33 34 except as otherwise authorized by RCW 36.70A.110(4).
- 35 (17) "Urban growth" refers to growth that makes intensive use of 36 land for the location of buildings, structures, and impermeable 37 surfaces to such a degree as to be incompatible with the primary use of 38 ((such)) land for the production of food, other agricultural products, 39 or fiber, or the extraction of mineral resources, rural uses, rural

- 1 development, and natural resource lands designated pursuant to RCW
- 2 <u>36.70A.170</u>. A pattern of more intensive rural development, as provided
- 3 <u>in RCW 36.70A.070(5)(d)</u>, is not urban growth. When allowed to spread
- 4 over wide areas, urban growth typically requires urban governmental
- 5 services. "Characterized by urban growth" refers to land having urban
- 6 growth located on it, or to land located in relationship to an area
- 7 with urban growth on it as to be appropriate for urban growth.
- 8  $((\frac{15}{15}))$  <u>(18)</u> "Urban growth areas" means those areas designated by
- 9 a county pursuant to RCW 36.70A.110.
- 10 ((<del>(16)</del>)) <u>(19)</u> "Urban governmental services" <u>or "urban services"</u>
- 11 include those ((governmental)) public services and public facilities at
- 12 <u>an intensity</u> historically and typically ((<del>delivered by</del>)) <u>provided in</u>
- 13 cities, ((and include)) specifically including storm and sanitary sewer
- 14 systems, domestic water systems, street cleaning services, fire and
- 15 police protection services, public transit services, and other public
- 16 utilities associated with urban areas and normally not associated with
- 17 ((nonurban)) rural areas.
- 18  $((\frac{17}{17}))$  (20) "Wetland" or "wetlands" means areas that are
- 19 inundated or saturated by surface water or ground water at a frequency
- 20 and duration sufficient to support, and that under normal circumstances
- 21 do support, a prevalence of vegetation typically adapted for life in
- 22 saturated soil conditions. Wetlands generally include swamps, marshes,
- 23 bogs, and similar areas. Wetlands do not include those artificial
- 24 wetlands intentionally created from nonwetland sites, including, but
- 25 not limited to, irrigation and drainage ditches, grass-lined swales,
- 26 canals, detention facilities, wastewater treatment facilities, farm
- 27 ponds, and landscape amenities, or those wetlands created after July 1,
- 28 1990, that were unintentionally created as a result of the construction
- 29 of a road, street, or highway. Wetlands may include those artificial
- 30 wetlands intentionally created from nonwetland areas created to
- 31 mitigate conversion of wetlands.
- 32 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 36.70A RCW
- 33 to read as follows:
- 34 (1) A county, after conferring with its cities, may develop
- 35 alternative methods of achieving the planning goals established by RCW
- 36 36.70A.020.
- 37 (2) The authority provided by this section may not be used to
- 38 modify:

- 1 (a) Requirements for the designation and protection of critical 2 areas or for the designation of natural resource lands under RCW 3 36.70A.060(2), 36.70A.170, and 36.70A.172;
- 4 (b) The requirement that wetlands be delineated consistent with the 5 requirements of RCW 36.70A.175; or
- 6 (c) The requirement to establish a process for the siting of 7 essential public facilities pursuant to RCW 36.70A.200.
- 8 (3) Before adopting any alternative methods of achieving the 9 planning goals established by RCW 36.70A.020, a county shall provide an 10 opportunity for public review and comment. An ordinance or resolution 11 proposing or adopting alternative methods must be submitted to the 12 department in the same manner as provided in RCW 36.70A.106 for 13 submittal of proposed and adopted comprehensive plans and development 14 regulations.
- NEW SECTION. **Sec. 5.** A new section is added to chapter 36.70A RCW to read as follows:
- 17 The legislature finds that it is the goal of the state of 18 Washington to achieve no overall net loss of wetland functions. Wetlands can provide public benefits related to flood control, 19 groundwater recharge, water quality, and wildlife habitat. 20 legislature further finds that consideration should be given to the 21 functions wetlands provide and to the needs of private property owners 22 23 to assure that wetlands regulations both reflect the impact to wetland functions and allow for a reasonable use of property. 24 In adopting critical areas development regulations, counties and cities should 25 consider and balance all of the goals under RCW 36.70A.020. 26 27 legislature intends that no goal takes precedence over any of the others, but that counties and cities may prioritize the goals in 28 29 accordance with local history, conditions, circumstances, and choice.
- 30 **Sec. 6.** RCW 36.70A.060 and 1991 sp.s. c 32 s 21 are each amended 31 to read as follows:
- 32 (1) Each county that is required or chooses to plan under RCW 36.70A.040, and each city within such county, shall adopt development regulations on or before September 1, 1991, to assure the conservation of agricultural, forest, and mineral resource lands designated under RCW 36.70A.170. Regulations adopted under this subsection may not prohibit uses legally existing on any parcel prior to their adoption

- 1 and shall remain in effect until the county or city adopts development
- 2 regulations pursuant to RCW 36.70A.120. Such regulations shall assure
- 3 that the use of lands adjacent to agricultural, forest, or mineral
- 4 resource lands shall not interfere with the continued use, in the
- 5 accustomed manner and in accordance with best management practices, of
- 6 these designated lands for the production of food, agricultural
- 7 products, or timber, or for the extraction of minerals. Counties and
- 8 cities shall require that all plats, short plats, development permits,
- 9 and building permits issued for development activities on, or within
- 10 three hundred feet of, lands designated as agricultural lands, forest
- 11 lands, or mineral resource lands, contain a notice that the subject
- 12 property is within or near designated agricultural lands, forest lands,
- 13 or mineral resource lands on which a variety of commercial activities
- 14 may occur that are not compatible with residential development for
- 15 certain periods of limited duration.
- 16 (2) Each county and city shall adopt development regulations that
- 17 protect critical areas that are required to be designated under RCW
- 18 36.70A.170. For counties and cities that are required or choose to
- 19 plan under RCW 36.70A.040, such development regulations shall be
- 20 adopted on or before September 1, 1991. For the remainder of the
- 21 counties and cities, such development regulations shall be adopted on
- 22 or before March 1, 1992.
- 23 (3) Such counties and cities shall review these designations and
- 24 development regulations when adopting their comprehensive plans under
- 25 RCW 36.70 A. 040 and implementing development regulations under RCW
- 26 36.70A.120 and may alter such designations and development regulations
- 27 to insure consistency.
- 28 (4) Forest land and agricultural land located within urban growth
- 29 areas shall not be designated by a county or city as forest land or
- 30 agricultural land of long-term commercial significance under RCW
- 31 36.70A.170 unless the city or county has enacted a program authorizing
- 32 transfer or purchase of development rights.
- 33 (5) Counties and cities may exempt the following from critical
- 34 <u>areas development regulations:</u>
- 35 (a) Emergency activities; and
- 36 (b) Activities with minor impacts on critical areas.
- 37 **Sec. 7.** RCW 36.70A.070 and 1996 c 239 s 1 are each amended to read
- 38 as follows:

The comprehensive plan of a county or city that is required or chooses to plan under RCW 36.70A.040 shall consist of a map or maps, and descriptive text covering objectives, principles, and standards used to develop the comprehensive plan. The plan shall be an internally consistent document and all elements shall be consistent with the future land use map. A comprehensive plan shall be adopted and amended with public participation as provided in RCW 36.70A.140.

Each comprehensive plan shall include a plan, scheme, or design for each of the following:

- 10 (1)A land use element designating the proposed general distribution and general location and extent of the uses of land, where 11 appropriate, for agriculture, timber production, housing, commerce, 12 13 industry, recreation, open spaces, general aviation airports, public utilities, public facilities, and other land uses. 14 The land use 15 element shall include population densities, building intensities, and 16 estimates of future population growth. The land use element shall 17 provide for protection of the quality and quantity of ground water used for public water supplies. Where applicable, the land use element 18 19 shall review drainage, flooding, and storm water run-off in the area 20 and nearby jurisdictions and provide quidance for corrective actions to mitigate or cleanse those discharges that pollute waters of the state, 21 22 including Puget Sound or waters entering Puget Sound.
  - (2) A housing element ensuring the vitality and character of established residential neighborhoods that: (a) Includes an inventory and analysis of existing and projected housing needs; (b) includes a statement of goals, policies, objectives, and mandatory provisions for the preservation, improvement, and development of housing, including single-family residences; (c) identifies sufficient land for housing, including, but not limited to, government-assisted housing, housing for low-income families, manufactured housing, multifamily housing, and group homes and foster care facilities; and (d) makes adequate provisions for existing and projected needs of all economic segments of the community.
  - (3) A capital facilities plan element consisting of: (a) An inventory of existing capital facilities owned by public entities, showing the locations and capacities of the capital facilities; (b) a forecast of the future needs for such capital facilities; (c) the proposed locations and capacities of expanded or new capital facilities; (d) at least a six-year plan that will finance such capital

- 1 facilities within projected funding capacities and clearly identifies
- 2 sources of public money for such purposes; and (e) a requirement to
- 3 reassess the land use element if probable funding falls short of
- 4 meeting existing needs and to ensure that the land use element, capital
- 5 facilities plan element, and financing plan within the capital
- 6 facilities plan element are coordinated and consistent.
- 7 (4) A utilities element consisting of the general location,
- 8 proposed location, and capacity of all existing and proposed utilities,
- 9 including, but not limited to, electrical lines, telecommunication
- 10 lines, and natural gas lines.
- 11 (5) <u>Rural element.</u> Counties shall include a rural element
- 12 including lands that are not designated for urban growth, agriculture,
- 13 forest, or mineral resources. The following provisions shall apply to
- 14 the rural element:
- 15 <u>(a) Growth management act goals and local circumstances. Because</u>
- 16 circumstances vary from county to county, in establishing patterns of
- 17 rural densities and uses, a county may consider local circumstances,
- 18 but shall develop a written record explaining how the rural element
- 19 <u>harmonizes the planning goals in RCW 36.70A.020 and meets the</u>
- 20 <u>requirements of this chapter.</u>
- 21 (b) Rural development. The rural element shall permit
- 22 ((appropriate land uses that are compatible with the rural character of
- 23 such lands and)) rural development, forestry, and agriculture in rural
- 24 <u>areas. The rural element shall</u> provide for a variety of rural
- 25 densities ((and)), uses ((and may also provide)), essential public
- 26 <u>facilities</u>, and rural governmental services needed to serve the
- 27 permitted densities and uses. In order to achieve a variety of rural
- 28 <u>densities and uses, counties may provide</u> for clustering, density
- 29 transfer, design guidelines, conservation easements, and other
- 30 innovative techniques that will accommodate appropriate rural <u>densities</u>
- 31 <u>and</u> uses <u>that are</u> not characterized by urban growth <u>and that are</u>
- 32 consistent with rural character.
- 33 (c) Measures governing rural development. The rural element shall
- 34 <u>include measures that apply to rural development and protect the rural</u>
- 35 character of the area, as established by the county, by:
- 36 (i) Containing or otherwise controlling rural development;
- 37 (ii) Assuring visual compatibility of rural development with the
- 38 <u>surrounding rural area;</u>

- 1 (iii) Reducing the inappropriate conversion of undeveloped land 2 into sprawling, low-density development in the rural area;
- 3 (iv) Protecting critical areas, as provided in RCW 36.70A.060, and 4 surface water and ground water resources; and
- 5 <u>(v) Protecting against conflicts with the use of agricultural,</u> 6 forest, and mineral resource lands designated under RCW 36.70A.170.
- 7 (d) Limited areas of more intensive rural development. Subject to 8 the requirements of this subsection and except as otherwise 9 specifically provided in this subsection (5)(d), the rural element may 10 allow for limited areas of more intensive rural development, including 11 necessary public facilities and public services to serve the limited 12 area as follows:
- (i) Rural development consisting of the infill, development, or 13 14 redevelopment of existing commercial, industrial, residential, or mixed-use areas, whether characterized as shoreline development, 15 villages, hamlets, rural activity centers, or crossroads developments. 16 A commercial, industrial, residential, shoreline, or mixed-use area 17 shall be subject to the requirements of (d)(iv) of this subsection, but 18 19 shall not be subject to the requirements of (c)(ii) and (iii) of this subsection. An industrial area is not required to be principally 20 designed to serve the existing and projected rural population; 21

- (ii) The intensification of development on lots containing, or new development of, small-scale recreational or tourist uses, including commercial facilities to serve those recreational or tourist uses, that rely on a rural location and setting, but that do not include new residential development. A small-scale recreation or tourist use is not required to be principally designed to serve the existing and projected rural population. Public services and public facilities shall be limited to those necessary to serve the recreation or tourist use and shall be provided in a manner that does not permit low-density sprawl;
- (iii) The intensification of development on lots containing isolated nonresidential uses or new development of isolated cottage industries and isolated small-scale businesses that are not principally designed to serve the existing and projected rural population and nonresidential uses, but do provide job opportunities for rural residents. Public services and public facilities shall be limited to those necessary to serve the isolated nonresidential use and shall be provided in a manner that does not permit low-density sprawl;

- 1 (iv) A county shall adopt measures to minimize and contain the
- 2 existing areas or uses of more intensive rural development, as
- 3 appropriate, authorized under this subsection. Lands included in such
- 4 existing areas or uses shall not extend beyond the logical outer
- 5 boundary of the existing area or use, thereby allowing a new pattern of
- 6 <u>low-density sprawl</u>. Existing areas are those that are clearly
- 7 identifiable and contained and where there is a logical boundary
- 8 delineated predominately by the built environment, but that may also
- 9 include undeveloped lands if limited as provided in this subsection.
- 10 The county shall establish the logical outer boundary of an area of
- 11 more intensive rural development. In establishing the logical outer
- 12 boundary the county shall address (A) the need to preserve the
- 13 character of existing natural neighborhoods and communities, (B)
- 14 physical boundaries such as bodies of water, streets and highways, and
- 15 <u>land forms and contours, (C) the prevention of abnormally irregular</u>
- 16 boundaries, and (D) the ability to provide public facilities and public
- 17 services in a manner that does not permit low-density sprawl;
- 18 <u>(v) For purposes of (d) of this subsection, an existing area or</u>
- 19 existing use is one that was in existence:
- 20 (A) On July 1, 1990, in a county that was initially required to
- 21 plan under all of the provisions of this chapter;
- 22 (B) On the date the county adopted a resolution under RCW
- 23 36.70A.040(2), in a county that is planning under all of the provisions
- 24 of this chapter under RCW 36.70A.040(2); or
- 25 (C) On the date the office of financial management certifies the
- 26 county's population as provided in RCW 36.70A.040(5), in a county that
- 27 <u>is planning under all of the provisions of this chapter pursuant to RCW</u>
- 28 36.70A.040(5).
- 29 (e) Exception. This subsection shall not be interpreted to permit
- 30 in the rural area a major industrial development or a master planned

- 8 (8) "Residential targeted area" means an area within an urban 9 center that has been designated by the governing authority as a 10 residential targeted area in accordance with this chapter.
- 11 (9) "Substantial compliance" means compliance with local building 12 or housing code requirements that are typically required for 13 rehabilitation as opposed to new construction.
- 14 (10) "Urban center" means a compact identifiable district where 15 urban residents may obtain a variety of products and services. An 16 urban center must contain:
- 17 (a) Several existing or previous, or both, business establishments 18 that may include but are not limited to shops, offices, banks, 19 restaurants, governmental agencies;
- 20 (b) Adequate public facilities including streets, sidewalks, 21 lighting, transit, domestic water, and sanitary sewer systems; and
- (c) A mixture of uses and activities that may include housing, recreation, and cultural activities in association with either commercial or office, or both, use.
- NEW SECTION. **Sec. 41.** A new section is added to chapter 36.70A RCW to read as follows:
- The legislature recognizes that the preservation of urban 27 greenbelts is an integral part of comprehensive growth management in 28 29 Washington. The legislature further recognizes that certain greenbelts 30 are subject to adverse possession action which, if carried out, threaten the comprehensive nature of this chapter. - (5) Property proposed to be rehabilitated must be vacant at least twelve months before submitting an application and fail to comply with one or more standards of the applicable state or local building or housing codes on or after July 23, 1995; and
- 26 (6) The applicant must enter into a contract with the city approved 27 by the governing body under which the applicant has agreed to the 28 implementation of the development on terms and conditions satisfactory 29 to the governing authority.

- 8 (g) Use environmental review on projects to: (i) Review and 9 document consistency with comprehensive plans and development 10 regulations; (ii) provide prompt and coordinated review by agencies, tribes, and the public on compliance with applicable environmental laws 11 12 and plans, including mitigation for site specific project impacts that 13 have not been considered and addressed at the plan or development regulation level; and (iii) ensure accountability by local government 14 15 to applicants and the public for requiring and implementing mitigation 16 measures;
  - (h) Maintain or improve the quality of environmental analysis both for plan and for project decisions, while integrating these analyses with improved state and local planning and permitting processes;

If provided, an administrative appeal of the 29 30 project decision((, combined with)) and of any environmental determination((s)) issued at the same time as the project decision, 31 shall be filed within fourteen days after the notice of the decision or 32 after other notice that the decision has been made and is appealable. 33 The local government shall extend the appeal period for an additional 34 35 seven days, if state or local rules adopted pursuant to chapter 43.21C RCW allow public comment on a determination of nonsignificance issued 36
- 37 as part of the appealable project permit decision.

- 1 (10) The applicant for a project permit is deemed to be a 2 participant in any comment period, open record hearing, or closed 3 record appeal.
- 4 (11) Each local government planning under RCW 36.70A.040 shall 5 adopt procedures for administrative interpretation of its development 6 regulations.
- 7 **Sec. 49.** RCW 43.21C.075 and 1995 c 347 s 204 are each amended to 8 read as follows:
- 9 (1) Because a major purpose of this chapter is to combine environmental considerations with public decisions, any appeal brought 10 under this chapter shall be linked to a specific governmental action. 11 The State Environmental Policy Act provides a basis for challenging 12 13 whether governmental action is in compliance with the substantive and 14 procedural provisions of this chapter. The State Environmental Policy 15 Act is not intended to create a cause of action unrelated to a specific governmental action. 16

- (f) If a certificate of appealability is denied, review shall be by the superior court. The superior court's decision may be appealed to the court of appeals.

Except as otherwise specifically provided in section 22 of this act, sections 1 through 21, chapter . . ., Laws of 1997 (sections 1 through 21 of this act) are prospective in effect and shall not affect the validity of actions taken or decisions made before the effective date of this section.
- NEW SECTION. Sec. 54. If any provision of this act or its application to any person or circumstance is held invalid, the remainder of the act or the application of the provision to other persons or circumstances is not affected.
- NEW SECTION. **Sec. 55.** Sections 29 and 30 of this act are necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and take effect immediately.
