Adds a new provision replacing language regarding the entitlement to industrial insurance benefits that have been withheld or underpaid. The new provision permits the recipient to request an adjustment of benefits when the Department of Labor and Industries or self-insurer fails to pay benefits because of identity, clerical mistake of error, or misrepresentation. The recipient must make the request within one year from the date of incorrect payment and may not seek adjustment because of adjudicator error (failure to consider information in the file or to secure adequate information, or an error in judgment).
