7 NEW SECTION. **Sec. 21.** A new section is added to chapter 41.32
8 RCW under subpart Provisions applicable to plan I, plan II, and plan
9 III" to read as follows:

10 (1) Charter public schools are employers and charter public school
11 teachers are members under this chapter.

12 (2) This section takes effect only if the department of retirement
13 systems receives determinations from the internal revenue service and
14 the United States department of labor that such participation does not
15 jeopardize the status of these retirement systems as governmental plans
16 under the federal employees' retirement income security act and the
17 internal revenue code.

18 (3) Charter public school- means the same as defined in section
19 2 of this act.

20 NEW SECTION. **Sec. 22.** A new section is added to chapter 41.35
21 RCW under subpart Provisions applicable to plan II and plan III" to
22 read as follows:

23 (1) Charter public schools are employers and charter public school
24 employees other than teachers are members under this chapter.

25 (2) This section takes effect only if the department of retirement
26 systems receives determinations from the internal revenue service and
27 the United States department of labor that such participation does not
28 jeopardize the status of these retirement systems as governmental plans
29 under the federal employees' retirement income security act and the
30 internal revenue code.

31 (3) Charter public school- means the same as defined in section
32 2 of this act.

33 (4) This section takes effect September 1, 2000.

1 NEW SECTION. **Sec. 23.** A new section is added to chapter 41.40
2 RCW under subpart "Provisions applicable to plan I and plan II" to read
3 as follows:

4 (1) Charter public schools are employers and charter public school
5 employees other than teachers are members under this chapter. RCW
6 41.40.750 applies to charter public school employees who are not in
7 plan 1 under this chapter on September 1, 2000.

8 (2) This section takes effect only if the department of retirement
9 systems receives determinations from the internal revenue service and
10 the United States department of labor that such participation does not
11 jeopardize the status of these retirement systems as governmental plans
12 under the federal employees' retirement income security act and the
13 internal revenue code.

14 (3) Charter public school- means the same as defined in section
15 2 of this act.-

16 Renumber remaining sections consecutively, correct internal
17 references accordingly, and correct the title.

EFFECT: Makes technical changes to place provisions making
charter public school employees part of the public retirement
systems in the proper retirement system statutes. (Retains
language making this designation contingent on authorization from
the IRS and U.S. Department of Labor.)
