EFFECT: Reduces the Office of the Governor by \$804,000, the Governor's emergency fund by \$304,000, and Attorney General salary increases by \$885,000. Eliminates funding for the Family Policy Council restoration (\$737,000), and gravel studies in the Department of Ecology (\$500,000). Adds \$2.487 million for local DUI costs in Special Appropriations to the Governor.

FISCAL IMPACT: Reduces General Fund-State by \$779,000.
