5 Strike everything after the enacting clause and insert the
6 following:

7 "NEW SECTION. **Sec. 1.** (1) A person who, with intent to deprive
8 the owner or owner's agent, wrongfully obtains anhydrous ammonia, is
9 guilty of theft of anhydrous ammonia.

10 (2) Theft of anhydrous ammonia is a class C felony.

11 NEW SECTION. **Sec. 2.** A person is guilty of the crime of unlawful
12 storage of anhydrous ammonia if the person possesses anhydrous ammonia
13 in a container that (1) is not approved by the United States department
14 of transportation to hold anhydrous ammonia, or (2) was not constructed
15 to meet state and federal industrial health and safety standards for
16 holding anhydrous ammonia. Violation of this section is a class C
17 felony.

18 This section does not apply to public employees or private
19 contractors authorized to clean up and dispose of hazardous waste or
20 toxic substances under chapter 70.105 or 70.105D RCW.

21 NEW SECTION. **Sec. 3.** Any damages arising out of the unlawful
22 possession of, storage of, or tampering with anhydrous ammonia or
23 anhydrous ammonia equipment shall be the sole responsibility of the
24 unlawful possessor, storer, or tamperer. In no case shall liability
25 for damages arising out of the unlawful possession of, storage of, or
26 tampering with anhydrous ammonia or anhydrous ammonia equipment extend
27 to the lawful owner, installer, maintainer, designer, manufacturer,
28 possessor, or seller of the anhydrous ammonia or anhydrous ammonia
29 equipment, unless such damages arise out of the owner, installer,
30 maintainer, designer, manufacturer, possessor, or seller's acts or
31 omissions that constitute negligent misconduct to abide by the laws
32 regarding anhydrous ammonia possession and storage.

2 NEW SECTION. **Sec. 6.** Sections 1 through 3 of this act constitute
3 a new chapter in Title 69 RCW.

4 NEW SECTION. **Sec. 7.** If specific funding for the purposes of this
5 act, referencing this act by bill or chapter number, is not provided by
6 June 30, 2000, in the omnibus appropriations act, this act is null and
7 void.

8 NEW SECTION. **Sec. 8.** If any provision of this act or its
9 application to any person or circumstance is held invalid, the
10 remainder of the act or the application of the provision to other
11 persons or circumstances is not affected."

12 Correct the title.

EFFECT: A person possessing anhydrous ammonia in a container that is not approved by the United States Department of Transportation to hold or transport anhydrous ammonia is guilty of unlawful storage of anhydrous ammonia. This amendment exempts public employees or private contractors authorized to clean up and dispose of hazardous waste or toxic substances from this law.
