The plan(s) shall include, but 38 is not limited to, the following elements: A description of the 39 problem or opportunity that the information technology project is

- intended to address; a statement of project objectives and assumptions; a definition and schedule of phases, tasks, and activities to be accomplished; and the estimated cost of each phase. The planning for the phased approach shall be such that the business case justification for a project needs to demonstrate how the project recovers cost or adds measurable value or positive cost benefit to the agency's business functions within each development cycle.
- 8 (5) The agency shall produce quality assurance plans 9 information technology projects. Consistent with the direction of the 10 information services board and the published policies and guidelines of the department of information services, the quality assurance plan 11 shall address all factors critical to successful completion of the 12 13 successful integration with the agency and state project and information technology infrastructure. At a minimum, quality assurance 14 15 plans shall provide time and budget benchmarks against which project progress can be measured, a specification of quality assurance 16 responsibilities, and a statement of reporting requirements. 17 18 quality assurance plans shall set out the functionality requirements 19 for each phase of a project.
- 20 (6) A copy of each feasibility study, project management plan, and quality assurance plan shall be provided to the department of 21 services, the office of financial management, 22 legislative fiscal committees. The plans and studies shall demonstrate 23 a sound business case that justifies the investment of taxpayer funds 24 25 on any new project, an assessment of the impact of the proposed system 26 on the existing information technology infrastructure, the disciplined use of preventative measures to mitigate risk, and the leveraging of 27 private-sector expertise as needed. Authority to expend any funds for 28 29 individual information systems projects is conditioned on the approval 30 of the relevant feasibility study, project management plan, and quality assurance plan by the department of information services and the office 31 32 of financial management.
- (7) Quality assurance status reports shall be submitted to the department of information services, the office of financial management, and legislative fiscal committees at intervals specified in the project's quality assurance plan.

2 PROVISIONS NECESSARY TO IMPLEMENT APPROPRIATIONS

3 NEW SECTION. Sec. 601. As a management tool to reduce costs and 4 make more effective use of resources, while improving employee 5 productivity and morale, agencies may offer voluntary separation and/or downshifting incentives and options according to procedures and 6 7 guidelines established by the department of personnel the 8 department of retirement systems, in consultation with the office of 9 financial management. The options may include, but are not limited to, 10 financial incentives for: Voluntary resignation and retirement, voluntary leave-without-pay, voluntary workweek or work hour reduction, 11 12 voluntary downward movement, and temporary separation for development 13 purposes.

Agency plans and offers shall be reviewed and monitored jointly by the department of personnel, office of financial management, and the department of retirement systems. The senate transportation committee and the house of representatives transportation committee shall also review and monitor the plans of agencies that receive funds appropriated under this act.

20 NEW SECTION. Sec. 602. - (i) Development of tools that assist policymakers and managers in using performance measures and investment tradeoff methods;
 - (j) Development of long-term investment strategies; and
- 38 (k) Other program items that would be beneficial to include in the 39 program accountability review.

1 (3) The recommendations will be considered in future biennium 2 transportation budgets in determining whether to enhance, streamline, 3 retain, reduce, or eliminate programs based on value and benefits 4 provided to the state.

NEW SECTION. Sec. 605. (1) Forty percent of the funds available for surface transportation flexible funds available under Sections 105(c)(2) and 133(d)(3)(A)(ii) of Title 23, United States Code are made available for the Washington state department of transportation.

(7) Purchases by institutions of higher education not exceeding thirty-five thousand dollars: PROVIDED, That for purchases between two thousand five hundred dollars and thirty-five thousand dollars quotations shall be secured from at least three vendors to assure establishment of a competitive price and may be obtained by telephone or written quotations, or both. For purchases between two thousand five hundred dollars and thirty-five thousand dollars, each institution of higher education shall invite at least one quotation each from a certified minority and a certified women-owned vendor who shall otherwise qualify to perform such work. - (8) Negotiation of a contract by the department of transportation, valid until June 30, 2001, with registered tow truck operators to provide roving service patrols in one or more Washington state patrol tow zones whereby those registered tow truck operators wishing to participate would cooperatively, with the department of transportation, develop a demonstration project upon terms and conditions negotiated by the parties.

hundred gross tons or as a master of inland steam or motor vessels of not more than one thousand six hundred gross tons, such license to have been held by the applicant for a period of at least two years prior to taking the Washington state pilotage examination and a first class United States endorsement without restrictions on that license to pilot in the pilotage districts for which the pilot applicant desires to be licensed, and if the pilot applicant meets such other qualifications as may be required by the board. A person applying for a license under this section shall not have been convicted of an offense involving drugs or the personal consumption of alcohol in the twelve months prior to the date of application. This restriction does not apply to license renewals under this section.

- (3) Pilots shall be licensed hereunder for a term of five years from and after the date of the issuance of their respective state licenses. Such licenses shall thereafter be renewed as of course, unless the board shall withhold same for good cause. Each pilot shall pay to the state treasurer an annual license fee as follows: For the period beginning July 1, 1995, through June 30, ((1999)) 2001, the fee shall be two thousand five hundred dollars; and for the period beginning July 1, ((1999)) 2001, the fee shall be three thousand dollars. The fees shall be deposited in the state treasury to the credit of the pilotage account. The board may assess partially active or inactive pilots a reduced fee.
- (4) Pilot applicants shall be required to pass a written and oral examination administered and graded by the board which shall test such applicants on this chapter, the rules of the board, local harbor ordinances, and such other matters as may be required to compliment the United States examinations and qualifications. The board shall hold examinations at such times as will, in the judgment of the board, ensure the maintenance of an efficient and competent pilotage service. An examination shall be scheduled for the Puget Sound pilotage district if there are three or fewer successful candidates from the previous examination who are waiting to become pilots in that district.
 - (5) The board shall develop an examination and grading sheet for each pilotage district, for the testing and grading of pilot applicants. The examinations shall be administered to pilot applicants and shall be updated as required to reflect changes in law, rules, policies, or procedures. The board may appoint a special independent examination committee or may contract with a firm knowledgeable and

experienced in the development of professional tests for development of said examinations. Active licensed state pilots may be consulted for the general development of examinations but shall have no knowledge of the specific questions. The pilot members of the board may participate in the grading of examinations. If the board does appoint a special examination development committee it is authorized to pay the members of said committee the same compensation and travel expenses as received by members of the board. When grading examinations the board shall carefully follow the grading sheet prepared for that examination. board shall develop a "sample examination" which would tend to indicate to an applicant the general types of questions on pilot examinations, but such sample questions shall not appear on any actual examinations. Any person who willfully gives advance knowledge of information contained on a pilot examination is guilty of a gross misdemeanor.

- (6) All pilots and applicants are subject to an annual physical examination by a physician chosen by the board. The physician shall examine the applicant's heart, blood pressure, circulatory system, lungs and respiratory system, eyesight, hearing, and such other items as may be prescribed by the board. After consultation with a physician and the United States coast guard, the board shall establish minimum health standards to ensure that pilots licensed by the state are able to perform their duties. Within ninety days of the date of each annual physical examination, and after review of the physician's report, the board shall make a determination of whether the pilot or candidate is fully able to carry out the duties of a pilot under this chapter. The board may in its discretion check with the appropriate authority for any convictions of offenses involving drugs or the personal consumption of alcohol in the prior twelve months.
- (7) The board shall prescribe, pursuant to chapter 34.05 RCW, a number of familiarization trips, between a minimum number of twenty-five and a maximum of one hundred, which pilot applicants must make in the pilotage district for which they desire to be licensed. Familiarization trips any particular applicant must make are to be based upon the applicant's vessel handling experience.

Of the counties', cities', and towns' share of any additional amounts 14 15 required in each fiscal year, the percentage thereof to be taken from 16 the counties' distributive share and from the cities' and towns' distributive share shall correspond to the percentage of funds 17 authorized for specific county projects and for specific city and town 18 19 projects, respectively, from the proceeds of series III bonds, for the 20 period through the first eleven months of the prior fiscal year as determined by the chairman of the transportation improvement board and 21 reported to the state finance committee and the state treasurer not 22 later than the first working day of June. 23
 - (3) Any payments on such bonds or interest thereon taken from motor vehicle or special fuel tax revenues that are distributable to the state, counties, cities, and towns shall be repaid from the first moneys distributed to the urban arterial trust account not required for redemption of the first authorization bonds, series II bonds, or series III bonds or interest on these bonds.

30 **Sec. 612.** RCW 47.26.505 and 1999 c 94 s 24 and 1999 c . . . (SHB 31 1053) s 9 are each reenacted and amended to read as follows:

Any funds required to repay such bonds, or the interest thereon 32 33 when due, shall be taken from that portion of the motor vehicle fund 34 which results from the imposition of excise taxes on motor vehicle and special fuels and which is distributed to the transportation 35 36 improvement account in the motor vehicle fund under RCW 46.68.090(1)(h), and shall never constitute a charge against any 37 allocations of any other such funds in the motor vehicle fund to the 38

The legislature, public officials, and citizens need to know the extent 5 to which state agencies, programs, and activities that impact the 6 state's transportation system are achieving the purposes for which they 7 8 were created.

The legislature recognizes that if it is to adequately fulfill its responsibility to provide for a balanced, efficient state-wide transportation system, it is essential to establish a joint legislative transportation committee that will provide an opportunity for members of the house of representatives and the senate to examine, develop, and oversee critical transportation policy and fiscal issues and make recommendations on such issues to the house of representatives and senate standing committees on transportation.

17 **Sec. 616.** RCW 44.40.010 and 1980 c 87 s 39 are each amended to 18 read as follows:

19 The joint fact-finding committee on highways, streets, and bridges originally created by chapter 111, Laws of 1947, recreated and renamed 20 21 joint committee on highways by chapter 3, Laws extraordinary session, is hereby recreated and renamed the legislative 22 23 transportation committee. The renaming of said committee shall not 24 affect any powers invested in it or its duties imposed upon it by any 25 other statute. All appropriations made to the committee under its former name shall continue to be available to said committee as 26 renamed, the legislative transportation committee. The committee shall 27 28 consist of ((eleven)) twelve senators to be appointed by the president 29 of the senate and twelve members of the house of representatives to be 30 appointed by the speaker thereof. Not more than six members from each house may be from the same political party. A list of appointees shall 31 be submitted before the close of each regular legislative session 32 during an odd-numbered year or any successive special session convened 33 34 by the governor or the legislature prior to the close of such regular session or successive special session(s) for confirmation of senate 35 36 members, by the senate, and house members, by the house. 37 occurring shall be filled by the appointing authority. All vacancies
