- AN ACT Relating to voter registration; and amending RCW 29.08.080
- 2 and 46.20.155.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 29.08.080 and 1993 c 434 s 8 are each amended to read 5 as follows:
- 6 The secretary of state shall furnish registration forms necessary
- 7 to carry out the registration of voters as provided by this chapter
- 8 without cost to the respective counties. ((However, costs incurred by
- 9 the secretary of state during 1994 and 1995 in the printing and
- 10 distribution of voter registration forms shall be reimbursed by the
- 11 counties. This cost shall be considered an election cost under RCW
- 12 29.13.045 and be prorated as part of the 1994 and 1995 general election
- 13 costs.))
- 14 All newly printed voter registration forms must include clear and
- 15 conspicuous language designed to draw an applicant's attention stating
- 16 that only citizens of the United States may register to vote. Similar
- 17 <u>language must be stamped conspicuously onto existing voter registration</u>
- 18 forms in the possession of the office of the secretary of state.

- 1 **Sec. 2.** RCW 46.20.155 and 1990 c 143 s 6 are each amended to read 2 as follows:
- 3 Before issuing an original license or identification card or
- 4 renewing a license or identification card under this chapter, the
- 5 licensing agent shall determine if the applicant wants to register to
- 6 vote or transfer his or her voter registration by asking the following
- 7 <u>as a single question:</u>
- 8 "Are you a United States citizen and do you want to register to
- 9 vote or transfer your voter registration?".
- 10 If the applicant ((<del>chooses to register or transfer a registration</del>))
- 11 responds in the affirmative, the agent shall provide the applicant with
- 12 a voter registration form and instructions and shall record that the
- 13 applicant has requested to register to vote or transfer a voter
- 14 registration.
- 15 <u>NEW SECTION.</u> **Sec. 3.** If any provision of this act or its
- 16 application to any person or circumstance is held invalid, the
- 17 remainder of the act or the application of the provision to other
- 18 persons or circumstances is not affected.
