- 1 AN ACT Relating to community and technical colleges economic
- 2 incentive grants; and adding new sections to chapter 28B.50 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 NEW SECTION. Sec. 1. (1) The legislature finds that it is in the
- 5 public interest to encourage and enhance cooperation among business,
- 6 industry, and community and technical colleges. It is the policy of
- 7 the state to facilitate interinstitutional coordination, planning, and
- 8 collaborative arrangements to make efficient use of educational
- 9 facilities and encourage economic development.
- 10 (2) In order to secure for the citizens of Washington the
- 11 advantages that would accrue through cooperative programs that meet
- 12 specific educational, business, and societal needs, the college board
- 13 may provide economic development grants for the planning and design of
- 14 programs offered by two or more community and technical colleges using
- 15 appropriated funds. Economic development grants shall encourage
- 16 cooperation among business, industry, and community and technical
- 17 colleges, and meet the work force training needs of this state.

- 1 <u>NEW SECTION.</u> **Sec. 2.** As used in sections 1 through 4 of this act,
- 2 "instructional program" means a course of study leading to
- 3 certification, licensure, or a degree at the associate level.
- 4 NEW SECTION. Sec. 3. The college board, using funds appropriated
- 5 therefor, may award economic incentive grants for instructional
- 6 programs that meet the demand of work force training for business and
- 7 industry. Economic incentive grants may be used to fund proposals that
- 8 emphasize collaboration between business, industry, and community and
- 9 technical colleges. The criteria for awarding the grants must be
- 10 uniform and applicable to all eligible colleges and the proposals shall
- 11 meet the following conditions:
- 12 (1) The program shall be offered by two or more eligible community
- 13 colleges and technical colleges;
- 14 (2) The participating colleges shall obtain a matching grant from
- 15 business and industry that is equal to the amount of the state grant.
- 16 (3) The partnership between business, industry, and community and
- 17 technical colleges shall be a cost-effective means to provide the
- 18 training program;
- 19 (4) The program shall provide training for the regional work force;
- 20 and
- 21 (5) The program shall meet the needs of the regional employers.
- 22 <u>NEW SECTION.</u> **Sec. 4.** The college board shall assure continuing
- 23 evaluation of the effectiveness of the economic incentive grants
- 24 authorized by section 3 of this act, and before December of each even-
- 25 numbered year shall submit a report to the governor and legislature.
- 26 In administering the grants, the college board shall require the use of
- 27 appropriate fiscal procedures to ensure accountability of public funds.
- NEW SECTION. Sec. 5. Sections 1 through 4 of this act are each
- 29 added to chapter 28B.50 RCW.
- 30 <u>NEW SECTION.</u> **Sec. 6.** If any provision of this act or its
- 31 application to any person or circumstance is held invalid, the
- 32 remainder of the act or the application of the provision to other
- 33 persons or circumstances is not affected.
