- 1 AN ACT Relating to the jurisdiction of the Washington human rights
- 2 commission; amending RCW 49.60.010, 49.60.020, 49.60.030, 49.60.040,
- 3 49.60.120, 49.60.130, 49.60.175, 49.60.176, 49.60.178, 49.60.180,
- 4 49.60.190, 49.60.200, 49.60.215, 49.60.223, 49.60.224, 49.60.225, and
- 5 48.30.300; and reenacting and amending RCW 49.60.222.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 **Sec. 1.** RCW 49.60.010 and 1997 c 271 s 1 are each amended to read 8 as follows:
- 9 This chapter shall be known as the "Cal Anderson law against
- 10 discrimination(("))." It is an exercise of the police power of the
- 11 state for the protection of the public welfare, health, and peace of
- 12 the people of this state, and in fulfillment of the provisions of the
- 13 Constitution of this state concerning civil rights. The legislature
- 14 hereby finds and declares that practices of discrimination against any
- 15 of its inhabitants because of race, creed, color, national origin,
- 16 families with children, sex, marital status, sexual orientation, age,
- 17 or the presence of any sensory, mental, or physical disability or the
- 18 use of a trained dog guide or service animal by a disabled person are
- 19 a matter of state concern, that such discrimination threatens not only

- the rights and proper privileges of its inhabitants but menaces the 1 institutions and foundation of a free democratic state. A state agency 2 3 is herein created with powers with respect to elimination and 4 prevention of discrimination in employment, in credit and insurance 5 transactions, in places of public resort, accommodation, or amusement, and in real property transactions because of race, creed, color, 6 7 national origin, families with children, sex, marital status, sexual 8 orientation, age, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a 9 10 disabled person; and the commission established hereunder is hereby given general jurisdiction and power for such purposes. 11
- 12 **Sec. 2.** RCW 49.60.020 and 1993 c 510 s 2 are each amended to read 13 as follows:
- 14 The provisions of this chapter shall be construed liberally for the 15 accomplishment of the purposes thereof. Nothing contained in this 16 chapter shall be deemed to repeal any of the provisions of any other law of this state relating to discrimination because of race, color, 17 18 creed, national origin, sex, marital status, sexual orientation, age, 19 or the presence of any sensory, mental, or physical disability, other than a law which purports to require or permit doing any act which is 20 an unfair practice under this chapter. Nor shall anything herein 21 22 contained be construed to deny the right to any person to institute any 23 action or pursue any civil or criminal remedy based upon an alleged 24 violation of his or her civil rights. This chapter shall not be construed to endorse any specific belief, practice, behavior, or 25 orientation. 26
- 27 **Sec. 3.** RCW 49.60.030 and 1997 c 271 s 2 are each amended to read 28 as follows:
- (1) The right to be free from discrimination because of race, creed, color, national origin, sex, <u>sexual orientation</u>, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a disabled person is recognized as and declared to be a civil right. This right shall include, but not be limited to:
- 35 (a) The right to obtain and hold employment without discrimination;

- 1 (b) The right to the full enjoyment of any of the accommodations, 2 advantages, facilities, or privileges of any place of public resort, 3 accommodation, assemblage, or amusement;
- 4 (c) The right to engage in real estate transactions without 5 discrimination, including discrimination against families with 6 children;
- 7 (d) The right to engage in credit transactions without 8 discrimination;
- 9 (e) The right to engage in insurance transactions or transactions 10 with health maintenance organizations without discrimination: 11 PROVIDED, That a practice which is not unlawful under RCW 48.30.300, 12 48.44.220, or 48.46.370 does not constitute an unfair practice for the 13 purposes of this subparagraph; and
- (f) The right to engage in commerce free from any discriminatory 14 boycotts or blacklists. Discriminatory boycotts or blacklists for 15 16 purposes of this section shall be defined as the formation or execution of any express or implied agreement, understanding, policy or 17 contractual arrangement for economic benefit between any persons which 18 19 is not specifically authorized by the laws of the United States and 20 which is required or imposed, either directly or indirectly, overtly or covertly, by a foreign government or foreign person in order to 21 restrict, condition, prohibit, or interfere with or in order to exclude 22 23 any person or persons from any business relationship on the basis of 24 race, color, creed, religion, sex, sexual orientation, the presence of 25 any sensory, mental, or physical disability, or the use of a trained 26 dog guide or service animal by a disabled person, or national origin or lawful business relationship: PROVIDED HOWEVER, That nothing herein 27 28 contained shall prohibit the use of boycotts as authorized by law pertaining to labor disputes and unfair labor practices. 29
  - (2) Any person deeming himself or herself injured by any act in violation of this chapter shall have a civil action in a court of competent jurisdiction to enjoin further violations, or to recover the actual damages sustained by the person, or both, together with the cost of suit including reasonable attorneys' fees or any other appropriate remedy authorized by this chapter or the United States Civil Rights Act of 1964 as amended, or the Federal Fair Housing Amendments Act of 1988 (42 U.S.C. Sec. 3601 et seq.).

(9) "Full enjoyment of" includes the right to purchase any service, commodity, or article of personal property offered or sold on, or by, any establishment to the public, and the admission of any person to accommodations, advantages, facilities, or privileges of any place of public resort, accommodation, assemblage, or amusement, without acts directly or indirectly causing persons of any particular race, creed, color, sex, sexual orientation, national origin, or with any sensory, mental, or physical disability, or the use of a trained dog guide or service animal by a disabled person, to be treated as not welcome, accepted, desired, or solicited;

- 27 credit transaction, whether in the nature of a loan, retail installment
- 28 transaction, credit card issue or charge, or otherwise, and whether for
- 29 personal or for business purposes, in which a service, finance, or
- 30 interest charge is imposed, or which provides for repayment in
- 31 scheduled payments, when such credit is extended in the regular course
- 32 of any trade or commerce, including but not limited to transactions by
- 33 banks, savings and loan associations or other financial lending
- 34 institutions of whatever nature, stock brokers, or by a merchant or
- 35 mercantile establishment which as part of its ordinary business permits
- 36 or provides that payment for purchases of property or service therefrom
- 37 may be deferred;
- $((\frac{19}{19}))$  (20) "Families with children status" means one or more
- 39 individuals who have not attained the age of eighteen years being

- 1 domiciled with a parent or another person having legal custody of such
- 2 individual or individuals, or with the designee of such parent or other
- 3 person having such legal custody, with the written permission of such
- 4 parent or other person. Families with children status also applies to
- 5 any person who is pregnant or is in the process of securing legal
- 6 custody of any individual who has not attained the age of eighteen
- 7 years;
- 8 (((20))) (21) "Covered multifamily dwelling" means: (a) Buildings
- 9 consisting of four or more dwelling units if such buildings have one or

- 16 purpose of guiding blind persons or a dog that is trained for the

- 18 (((23))) (24) "Service animal" means an animal that is trained for
- 19 the purpose of assisting or accommodating a disabled person's sensory,
- 20 mental, or physical disability.
- 21 **Sec. 5.** RCW 49.60.120 and 1997 c 271 s 4 are each amended to read
- 22 as follows:
- 23 The commission shall have the functions, powers, and duties:
- 24 (1) To appoint an executive director and chief examiner, and such
- 25 investigators, examiners, clerks, and other employees and agents as it
- 26 may deem necessary, fix their compensation within the limitations
- 27 provided by law, and prescribe their duties.
- 28 (2) To obtain upon request and utilize the services of all
- 29 governmental departments and agencies.
- 30 (3) To adopt, promulgate, amend, and rescind suitable rules and
- 31 regulations to carry out the provisions of this chapter, and the
- 32 policies and practices of the commission in connection therewith.

- 3 (6) To make such technical studies as are appropriate to effectuate 4 the purposes and policies of this chapter and to publish and distribute 5 the reports of such studies.
- 6 (7) To cooperate and act jointly or by division of labor with the 7 United States or other states, with other Washington state agencies, 8 commissions, and other government entities, and with political 9 subdivisions of the state of Washington and their respective human 10 rights agencies to carry out the purposes of this chapter. However, the powers which may be exercised by the commission under this 11 subsection permit investigations and complaint dispositions only if the 12 13 investigations are designed to reveal, or the complaint deals only with, allegations which, if proven, would constitute unfair practices 14 15 under this chapter. The commission may perform such services for these agencies and be reimbursed therefor. 16
- 17 (8) To foster good relations between minority and majority 18 population groups of the state through seminars, conferences, 19 educational programs, and other intergroup relations activities.
- 20 **Sec. 6.** RCW 49.60.130 and 1997 c 271 s 5 are each amended to read 21 as follows:

22 The commission has power to create such advisory agencies and 23 conciliation councils, local, regional, or state-wide, as in its 24 judgment will aid in effectuating the purposes of this chapter. 25 commission may empower them to study the problems of discrimination in all or specific fields of human relationships or in specific instances 26 27 of discrimination because of sex, race, creed, color, national origin, marital status, sexual orientation, age, or the presence of any 28 29 sensory, mental, or physical disability or the use of a trained dog quide or service animal by a disabled person; to foster through 30 community effort or otherwise good will, cooperation, and conciliation 31 32 among the groups and elements of the population of the state, and to 33 make recommendations to the commission for the development of policies 34 and procedures in general and in specific instances, and for programs of formal and informal education which the commission may recommend to 35 36 the appropriate state agency. 7 It is an unfair practice for any person whether acting for himself, herself, or another in connection with an insurance transaction or 8 9 transaction with a health maintenance organization to cancel or fail or refuse to issue or renew insurance or a health maintenance agreement to 10 any person because of sex, marital status, sexual orientation, race, 11 12 creed, color, national origin, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service 13 14 animal by a disabled person: PROVIDED, That a practice which is not unlawful under RCW 48.30.300, 48.44.220, or 48.46.370 does not 15 16 constitute an unfair practice for the purposes of this section. the purposes of this section, "insurance transaction" is defined in RCW 17 18 48.01.060, health maintenance agreement is defined in RCW 48.46.020, and "health maintenance organization" is defined in RCW 48.46.020. 19

- 20 The fact that such unfair practice may also be a violation of 21 chapter 48.30, 48.44, or 48.46 RCW does not constitute a defense to an 22 action brought under this section.
- The insurance commissioner, under RCW 48.30.300, and the human rights commission, under chapter 49.60 RCW, shall have concurrent jurisdiction under this section and shall enter into a working agreement as to procedure to be followed in complaints under this section.
- 28 **Sec. 10.** RCW 49.60.180 and 1997 c 271 s 10 are each amended to 29 read as follows:

((\(\frac{4+}{1}\))) (d) To print, or circulate, or cause to be printed or circulated any statement, advertisement, or publication, or to use any form of application for employment, or to make any inquiry in connection with prospective employment, which expresses any limitation, specification, or discrimination as to age, sex, marital status, sexual orientation, race, creed, color, national origin, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a disabled person, or any intent to make any such limitation, specification, or discrimination, unless based upon a bona fide occupational qualification: PROVIDED, Nothing contained herein shall prohibit advertising in a foreign language.

30 (2) This section shall not be construed to require an employer to
31 establish employment goals or quotas based on sexual orientation or on
32 any other basis.

any person to pay a larger sum than the uniform rates charged other 1 2 persons, or the refusing or withholding from any person the admission, patronage, custom, presence, frequenting, dwelling, staying, or lodging 3 4 in any place of public resort, accommodation, assemblage, or amusement, 5 except for conditions and limitations established by law and applicable to all persons, regardless of race, creed, color, national origin, 6 7 sexual orientation, sex, the presence of any sensory, mental, or 8 physical disability, or the use of a trained dog guide or service 9 animal by a disabled person: PROVIDED, That this section shall not be 10 construed to require structural changes, modifications, or additions to 11 make any place accessible to a disabled person except as otherwise 12 required by law: PROVIDED, That behavior or actions constituting a 13 risk to property or other persons can be grounds for refusal and shall not constitute an unfair practice. 14

- (ii) Engage in a practice that subjects policyholders to rate increases on discontinued policy forms unless such policyholders are offered the opportunity to purchase comparable coverage without health screening.
- The insurer may limit an offer of comparable coverage without health screening to a period not less than thirty days from the date the offer is first made.
