1 AN ACT Relating to motor vehicle theft; amending RCW 9A.56.070,
2 9.94A.360, and 13.40.0357; reenacting and amending RCW 9.94A.320; and
3 prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 9A.56.070 and 1975 1st ex.s. c 260 s 9A.56.070 are
6 each amended to read as follows:

7 (1) (~~Every person who shall~~) (a) A person is guilty of taking a
8 motor vehicle without permission in the first degree if he or she,
9 without the permission of the owner or person entitled to possession,
10 intentionally takes or drives away any automobile or motor vehicle,
11 whether propelled by steam, electricity, or internal combustion engine,
12 that is the property of another, and he or she:

13 (i) Alters the motor vehicle for the purpose of changing its
14 appearance or primary identification, including obscuring, removing, or
15 changing the manufacturer's serial number or the vehicle identification
16 number plates;

17 (ii) Removes, or participates in the removal of, parts from the
18 motor vehicle with the intent to sell the parts;

1 (iii) Exports, or attempts to export, the motor vehicle across
2 state lines or out of the United States for profit;

3 (iv) Intends to sell the motor vehicle; or

4 (v) Is engaged in a conspiracy and the central object of the
5 conspiratorial agreement is the theft of motor vehicles for sale to
6 others for profit.

7 (b) Taking a motor vehicle without permission in the first degree
8 is a class B felony.

9 (2)(a) A person is guilty of taking a motor vehicle without
10 permission in the second degree if he or she, without the permission
11 of the owner or person entitled to ((the)) possession ((thereof)),
12 intentionally takes or drives away any automobile or motor vehicle,
13 whether propelled by steam, electricity, or internal combustion engine,
14 that is the property of another, ((shall be deemed guilty of a felony,
15 and every person)) or he or she voluntarily ((riding)) rides in or upon
16 ((said)) the automobile or motor vehicle with knowledge of the fact
17 that ((the same)) it was unlawfully taken ((shall be equally guilty
18 with the person taking or driving said automobile or motor vehicle and
19 shall be deemed guilty of taking a motor vehicle without permission)).

20 ((+2)) (b) Taking a motor vehicle without permission in the second
21 degree is a class C felony.

8 **Sec. 3.** RCW 9.94A.360 and 1998 c 211 s 4 are each amended to read
9 as follows:

10 The offender score is measured on the horizontal axis of the
11 sentencing grid. The offender score rules are as follows:

12 The offender score is the sum of points accrued under this section
13 rounded down to the nearest whole number.

14 (1) A prior conviction is a conviction which exists before the date
15 of sentencing for the offense for which the offender score is being
16 computed. Convictions entered or sentenced on the same date as the
17 conviction for which the offender score is being computed shall be
18 deemed "other current offenses" within the meaning of RCW 9.94A.400.

19 (2) Class A and sex prior felony convictions shall always be
20 included in the offender score. Class B prior felony convictions other
21 than sex offenses shall not be included in the offender score, if since
22 the last date of release from confinement (including full-time
23 residential treatment) pursuant to a felony conviction, if any, or
24 entry of judgment and sentence, the offender had spent ten consecutive
25 years in the community without committing any crime that subsequently
26 results in a conviction. Class C prior felony convictions other than
27 sex offenses shall not be included in the offender score if, since the
28 last date of release from confinement (including full-time residential
29 treatment) pursuant to a felony conviction, if any, or entry of
30 judgment and sentence, the offender had spent five consecutive years in
31 the community without committing any crime that subsequently results in
32 a conviction. Serious traffic convictions shall not be included in the
33 offender score if, since the last date of release from confinement
34 (including full-time residential treatment) pursuant to a felony
35 conviction, if any, or entry of judgment and sentence, the offender
36 spent five years in the community without committing any crime that
37 subsequently results in a conviction. This subsection applies to both
38 adult and juvenile prior convictions.

1 (3) Out-of-state convictions for offenses shall be classified
2 according to the comparable offense definitions and sentences provided
3 by Washington law. Federal convictions for offenses shall be
4 classified according to the comparable offense definitions and
5 sentences provided by Washington law. If there is no clearly
6 comparable offense under Washington law or the offense is one that is
7 usually considered subject to exclusive federal jurisdiction, the
8 offense shall be scored as a class C felony equivalent if it was a
9 felony under the relevant federal statute.

10 (4) Score prior convictions for felony anticipatory offenses
11 (attempts, criminal solicitations, and criminal conspiracies) the same
12 as if they were convictions for completed offenses.

13 (5)(a) In the case of multiple prior convictions, for the purpose
14 of computing the offender score, count all convictions separately,
15 except:

16 (i) Prior offenses which were found, under RCW 9.94A.400(1)(a), to
17 encompass the same criminal conduct, shall be counted as one offense,
18 the offense that yields the highest offender score. The current
19 sentencing court shall determine with respect to other prior adult
20 offenses for which sentences were served concurrently or prior juvenile
21 offenses for which sentences were served consecutively, whether those
22 offenses shall be counted as one offense or as separate offenses using
23 the "same criminal conduct" analysis found in RCW 9.94A.400(1)(a), and
24 if the court finds that they shall be counted as one offense, then the
25 offense that yields the highest offender score shall be used. The
26 current sentencing court may presume that such other prior offenses
27 were not the same criminal conduct from sentences imposed on separate
28 dates, or in separate counties or jurisdictions, or in separate
29 complaints, indictments, or informations;

30 (ii) In the case of multiple prior convictions for offenses
31 committed before July 1, 1986, for the purpose of computing the
32 offender score, count all adult convictions served concurrently as one
33 offense, and count all juvenile convictions entered on the same date as
34 one offense. Use the conviction for the offense that yields the
35 highest offender score.

36 (b) As used in this subsection (5), "served concurrently" means
37 that: (i) The latter sentence was imposed with specific reference to
38 the former; (ii) the concurrent relationship of the sentences was
39 judicially imposed; and (iii) the concurrent timing of the sentences

1 was not the result of a probation or parole revocation on the former
2 offense.

3 (6) If the present conviction is one of the anticipatory offenses
4 of criminal attempt, solicitation, or conspiracy, count each prior
5 conviction as if the present conviction were for a completed offense.

6 (7) If the present conviction is for a nonviolent offense and not
7 covered by subsection (11) or (12) of this section, count one point for
8 each adult prior felony conviction and one point for each juvenile
9 prior violent felony conviction and 1/2 point for each juvenile prior
10 nonviolent felony conviction.

11 (8) If the present conviction is for a violent offense and not
12 covered in subsection (9), (10), (11), or (12) of this section, count
13 two points for each prior adult and juvenile violent felony conviction,
14 one point for each prior adult nonviolent felony conviction, and 1/2
15 point for each prior juvenile nonviolent felony conviction.

16 (9) If the present conviction is for Murder 1 or 2, Assault 1,
17 Assault of a Child 1, Kidnapping 1, Homicide by Abuse, or Rape 1, count
18 three points for prior adult and juvenile convictions for crimes in
19 these categories, two points for each prior adult and juvenile violent
20 conviction (not already counted), one point for each prior adult
21 nonviolent felony conviction, and 1/2 point for each prior juvenile
22 nonviolent felony conviction.

23 (10) If the present conviction is for Burglary 1, count prior
24 convictions as in subsection (8) of this section; however count two
25 points for each prior adult Burglary 2 or residential burglary
26 conviction, and one point for each prior juvenile Burglary 2 or
27 residential burglary conviction.

28 (11) If the present conviction is for a felony traffic offense
29 count two points for each adult or juvenile prior conviction for
30 Vehicular Homicide or Vehicular Assault; for each felony offense or
31 serious traffic offense, count one point for each adult and 1/2 point
32 for each juvenile prior conviction. This subsection shall not apply
33 when additional time is added to a sentence pursuant to RCW
34 46.61.520(2).

35 (12) If the present conviction is for a drug offense count three
36 points for each adult prior felony drug offense conviction and two
37 points for each juvenile drug offense. All other adult and juvenile
38 felonies are scored as in subsection (8) of this section if the current

1 drug offense is violent, or as in subsection (7) of this section if the
2 current drug offense is nonviolent.

3 (13) If the present conviction is for Willful Failure to Return
4 from Furlough, RCW 72.66.060, Willful Failure to Return from Work
5 Release, RCW 72.65.070, or Escape from Community Custody, RCW
6 72.09.310, count only prior escape convictions in the offender score.
7 Count adult prior escape convictions as one point and juvenile prior
8 escape convictions as 1/2 point.

9 (14) If the present conviction is for Escape 1, RCW 9A.76.110, or
10 Escape 2, RCW 9A.76.120, count adult prior convictions as one point and
11 juvenile prior convictions as 1/2 point.

12 (15) If the present conviction is for Burglary 2 or residential
13 burglary, count priors as in subsection (7) of this section; however,
14 count two points for each adult and juvenile prior Burglary 1
15 conviction, two points for each adult prior Burglary 2 or residential
16 burglary conviction, and one point for each juvenile prior Burglary 2
17 or residential burglary conviction.

18 (16) If the present conviction is for a sex offense, count priors
19 as in subsections (7) through (15) of this section; however count three
20 points for each adult and juvenile prior sex offense conviction.

21 (17) If the present conviction is for taking a motor vehicle
22 without permission, first or second degree, count two points for each
23 prior adult and juvenile conviction for this offense.

24 (18) If the present conviction is for an offense committed while
25 the offender was under community placement, add one point.
