- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 43.46.090 and 1983 c 204 s 1 are each amended to read 7 as follows:
- 8 The legislature recognizes this state's responsibility to foster
- 9 culture and the arts and its interest in the viable development of
- 10 ((her)) the state's artists and ((craftsmen)) craftpersons by the
- 11 establishment of the Washington state arts commission. ((The
- 12 legislature declares it to be a policy of this state that a portion of
- 13 appropriations for capital expenditures be set aside for the
- 14 acquisition of works of art to be placed in public buildings or
- 15 lands.)) There is hereby established a visual arts program to be
- 16 administered by the Washington state arts commission.
