- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 43.79 RCW
- 6 to read as follows:
- 7 The transportation fund is created in the state treasury. Moneys
- 8 in the fund may be spent only after appropriation. Expenditures from
- 9 the account may be used only for transportation purposes.
- 10 <u>NEW SECTION</u>. **Sec. 2.** A new section is added to chapter 82.32 RCW
- 11 to read as follows:
- 12 The department shall deposit into the transportation fund all
- 13 revenue received from taxes imposed under chapters 82.08 and 82.12 RCW
- 14 upon the sale of, use of, or charge made for:
- 15 (1) Vehicles, trailers, and semitrailers used, or of the type
- 16 designed primarily to be used, upon the public streets and highways,
- 17 for the convenience or pleasure of the owner, or for the conveyance,
- 18 for hire or otherwise, of persons or property, including fixed loads

- 1 and facilities for human habitation; but not including (a) dock and
- 2 warehouse tractors and their cars or trailers, lumber carriers of the
