- AN ACT Relating to requiring the department of ecology to present updated shoreline management guidelines to the legislature; adding a new section to chapter 90.58 RCW; creating a new section; providing an expiration date; and declaring an emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 NEW SECTION. Sec. 1. The legislature recognizes that local 7 governments are involved in implementing the watershed management laws. 8 The legislature further recognizes that local governments and others 9 are concerned about the financial and other impacts on 10 governments associated with responding to current and proposed listings of species under the federal endangered species act. 11 The legislature 12 also recognizes that the department of ecology began a process last 13 year to adopt new shoreline master program quidelines to be used by 14 local governments in updating their current shoreline master programs. 15 The legislature further recognizes that the department of ecology's 16 proposed revisions to the shoreline master program guidelines generated 17 much controversy and discussion about substantive changes to the The legislature intends by this act to 18 shoreline management act. 19 provide for a report by the department of ecology on its guideline

- 7 the department of ecology shall submit the proposed guidelines to the
- 8 appropriate standing committees of the legislature. The department of
- 9 ecology shall also submit to the appropriate standing committees of the
- 10 legislature a report on the process used by the department of ecology
- 11 related to development of the proposed guidelines and to be used
- 12 regarding comments on the proposed guidelines.
- 13 <u>NEW SECTION.</u> **Sec. 3.** Sections 1 and 2 of this act expire July 1,
- 14 2002.
- 15 <u>NEW SECTION.</u> **Sec. 4.** This act is necessary for the immediate
- 16 preservation of the public peace, health, or safety, or support of the
- 17 state government and its existing public institutions, and takes effect
- 18 immediately.
