1 AN ACT Relating to financial assistance to local governments;
2 amending RCW 43.135.035; adding new sections to chapter 43.135 RCW;
3 adding a new section to chapter 43.79 RCW; adding a new section to
4 chapter 39.42 RCW; creating a new section; making appropriations;
5 providing an effective date; and declaring an emergency.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** A new section is added to chapter 43.135 RCW
8 to read as follows:

9 The legislature recognizes the need for ongoing financial
10 assistance to local governments for the purposes of public safety,
11 criminal justice, public health, shorelines protection, and other
12 operations.

13 Therefore, it is the intent of the legislature that the state
14 provide funding for the current and future fiscal bienna for a portion
15 of local governments' costs for these programs and services that are
16 the ongoing responsibility of the recipient local government.

17 NEW SECTION. **Sec. 2.** A new section is added to chapter 43.135 RCW
18 to read as follows:

(1) Moneys appropriated in sections 4 and 5, chapter . . ., Laws of 2000 (sections 4 and 5 of this act) shall be used to supplant a portion of the costs of existing local programs, as specified in this section:

(a) In section 4, chapter . . ., Laws of 2000 (section 4 of this act), moneys are provided for the superior court system, police operations, crime prevention, care and custody of prisoners, and legal services; and

(b) In section 5, chapter . . ., Laws of 2000 (section 5 of this act), moneys are provided for municipal court systems, police operations, fire protection services, transportation, crime prevention, care and custody of prisoners, and legal services.

(2) Moneys appropriated in sections 4 and 5, chapter . . ., Laws of 2000 (sections 4 and 5 of this act) constitute a transfer to the state of local government costs under RCW 43.135.060(2).

1 NEW SECTION. **Sec. 6.** In addition to the requirements for the
2 study required by section 3, chapter . . . , Laws of 2000 (Substitute
3 House Bill No. 2392) for the joint task force on local governments, the
4 joint task force on local governments shall identify appropriate levels
5 of ongoing state funding of city and county program costs and the
6 manner in which such funding would be distributed. The joint task
7 force on local governments shall consider factors that may be
8 incorporated into distribution mechanisms to provide equalization
9 funding for jurisdictions based on incorporation, growth, economic
10 conditions, or other economic changes.

11 NEW SECTION. **Sec. 7.** A new section is added to chapter 43.79 RCW
12 to read as follows:

13 (1) The shorelines protection account is created in the state
14 treasury. Moneys transferred into the account shall be distributed by
15 the treasurer to eligible counties as provided in this section.
16 Beginning with the fiscal year ending June 30, 2002, and in each of the
17 following fiscal years through the fiscal year ending June 30, 2006,
18 the treasurer shall transfer the sum of twenty million dollars into the
19 shorelines protection account from the general fund--state. The
20 transfers shall be made in equal quarterly deposits.

21 (2) Deposits in the shorelines protection account shall be
22 distributed to eligible counties as defined in subsection (3) of this
23 section based on miles of shorelines in the county. For purposes of
24 this section, "miles of shorelines in the county" means the number of
25 miles of shorelines of the state, as defined in RCW 90.58.030, in the
26 county as of January 1, 2000.

27 (3) A county is eligible for distributions from the shorelines
28 protection account created under this section if it: (a) Has
29 shorelines of the state as defined in RCW 90.58.030; and (b) has a
30 population of less than five hundred thousand as determined by the
31 office of financial management.

32 (4) Eligible counties may use the moneys received under this
33 section solely for the purposes authorized in subsection (5) of this
34 section on riparian, marine, or estuarine parcels, or the portion
35 thereof, that:

36 (a) Have been designated as critical areas under chapter 36.70A
37 RCW;

1 (b) Are located within a county's shoreline management jurisdiction
2 under chapter 90.58 RCW; or

3 (c) Have been identified as addressing a limiting factor under RCW
4 75.46.070.

5 (5)(a) Eligible counties may use moneys received from the account
6 for:

7 (i) Voluntary leases or licenses from willing lessors or licensors
8 for shoreline conservation or preservation; or

9 (ii) Voluntary acquisition of less than fee simple interests from
10 willing sellers for conservation futures, development rights, or
11 conservation easements.

12 (b) Eligible counties also may use moneys received from the account
13 for restoration, maintenance, and monitoring of property leased or
14 property interests acquired as specified in (a) of this subsection.

15 (6) In making acquisition decisions, counties shall consult with a
16 designated lead entity that has been established under RCW 75.46.060,
17 and municipalities within the county, and shall give priority to
18 riparian, marine, and estuarine projects or parcels:

19 (a) For which interests may be acquired or leases may be executed
20 in coordination with acquisitions made by the interagency committee for
21 outdoor recreation according to chapter 43.99A RCW; or

22 (b) That have been designated by the United States national marine
23 fisheries service or the United States fish and wildlife service as
24 critical habitat for threatened or endangered species according to
25 U.S.C. Sec. 1533(a)(3).

26 **Sec. 8.** RCW 43.135.035 and 1994 c 2 s 4 are each amended to read
27 as follows:

28 (1) After July 1, 1995, any action or combination of actions by the
29 legislature that raises state revenue or requires revenue-neutral tax
30 shifts may be taken only if approved by a two-thirds vote of each
31 house, and then only if state expenditures in any fiscal year,
32 including the new revenue, will not exceed the state expenditure limits
33 established under this chapter.

34 (2)(a) If the legislative action under subsection (1) of this
35 section will result in expenditures in excess of the state expenditure
36 limit, then the action of the legislature shall not take effect until
37 approved by a vote of the people at a November general election. The
38 office of financial management shall adjust the state expenditure limit

1 by the amount of additional revenue approved by the voters under this
2 section. This adjustment shall not exceed the amount of revenue
3 generated by the legislative action during the first full fiscal year
4 in which it is in effect. The state expenditure limit shall be
5 adjusted downward upon expiration or repeal of the legislative action.

6 (b) The ballot title for any vote of the people required under this
7 section shall be substantially as follows:

8 "Shall taxes be imposed on in order to allow a
9 spending increase above last year's authorized spending adjusted for
10 inflation and population increases?"

11 (3)(a) The state expenditure limit may be exceeded upon declaration
12 of an emergency for a period not to exceed twenty-four months by a law
13 approved by a two-thirds vote of each house of the legislature and
14 signed by the governor. The law shall set forth the nature of the
15 emergency, which is limited to natural disasters that require immediate
16 government action to alleviate human suffering and provide humanitarian
17 assistance. The state expenditure limit may be exceeded for no more
18 than twenty-four months following the declaration of the emergency and
19 only for the purposes contained in the emergency declaration.

20 (b) Additional taxes required for an emergency under this section
21 may be imposed only until thirty days following the next general
22 election, unless an extension is approved at that general election.
23 The additional taxes shall expire upon expiration of the declaration of
24 emergency. The legislature shall not impose additional taxes for
25 emergency purposes under this subsection unless funds in the education
26 construction fund have been exhausted.

27 (c) The state or any political subdivision of the state shall not
28 impose any tax on intangible property listed in RCW 84.36.070 as that
29 statute exists on January 1, 1993.

30 (4) If the cost of any state program or function is shifted from
31 the state general fund on or after January 1, 1993, to another source
32 of funding, or if moneys are transferred from the state general fund to
33 another fund or account, the office of financial management shall lower
34 the state expenditure limit to reflect the shift. This subsection does
35 not apply to transfers to the shorelines protection account under
36 section 7 of this act.

1 NEW SECTION. **Sec. 9.** A new section is added to chapter 39.42 RCW
2 to read as follows:

3 Deposits in the shorelines protection account under section 7 of
4 this act shall not be deducted from the calculation of general state
5 revenues under RCW 39.42.060.

6 NEW SECTION. **Sec. 10.** (1) Sections 1 through 6 of this act are
7 necessary for the immediate preservation of the public peace, health,
8 or safety, or support of the state government and its existing public
9 institutions, and take effect immediately.

10 (2) Sections 7 through 9 of this act take effect July 1, 2001.
