- 1 TO THE HONORABLE WILLIAM J. CLINTON, PRESIDENT OF THE UNITED
- 2 STATES, AND TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE
- 3 OF REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF
- 4 THE UNITED STATES, IN CONGRESS ASSEMBLED, AND TO THE SECRETARY OF THE
- 5 UNITED STATES DEPARTMENT OF AGRICULTURE:
- 6 We, your Memorialists, the Senate and House of Representatives of
- 7 the State of Washington, in legislative session assembled, respectfully
- 8 represent and petition as follows:
- 9 WHEREAS, Unilateral trade sanctions have placed a heavy burden on
- 10 American farmers and the American economy; and
- 11 WHEREAS, United States unilateral trade sanctions deprive American
- 12 wheat-growing families of access to eleven percent of the world grain
- 13 trade; and
- 14 WHEREAS, Direct economic losses for wheat producers have ranged
- 15 from three hundred million dollars to over five hundred million dollars
- 16 annually for the past three years; and
- 17 WHEREAS, The losses are not merely confined to wheat, in that
- 18 growers of peas, lentils, barley, and many other crops have been
- 19 affected as well; and

WHEREAS, Unilateral sanctions impose a severe penalty upon United 1 2 States agriculture and upon the consuming public of the sanctioned 3 country, while providing market protection for our competitors; and

4 WHEREAS, Unilateral sanctions that limit commercial, government-5 assisted, or humanitarian movement of agricultural products have proven to be ineffective mechanisms to further United States foreign policy 6 7 goals; and

8 WHEREAS, Farmers across America were grateful for the swift passage 9 emergency federal legislation granting a one-year waiver of sanctions against two major trading partners, Pakistan and India, for credit sales of agricultural commodities, products, medicine, and medical equipment; and 12

13 WHEREAS, That emergency legislation prevented the financial 14 calamity we face from becoming worse yet, greater long-term steps must 15 be taken if America's farm families are to survive.

NOW, THEREFORE, Your Memorialists respectfully pray that all 16 17 current unilateral sanctions pertaining to agricultural exports be eliminated, except in cases of compelling national emergency or 18 19 declaration of war; that in the future the United States refrain from the use of unilateral sanctions other than in the case of war or for 20 national security reasons; that all current sanctions be made subject 21 to economic analysis and review, and ineffective measures be discarded, 22 and time limits applied for the review of continued current sanctions 23 24 measures; that any executive branch embargo of United States 25 agricultural commodities and products be subject to the review of 26 Congress; that a new framework be put in place to set policies for the future use of unilateral sanctions; that sanctions be created with 27 specific sunset provisions; and that legislation be approved to 28 29 implement a producer-compensation program based on the negative impact 30 of sanctions on the sale of agricultural products due to the exports 31 and income hurt due to the imposition of unilateral economic sanctions or embargoes. 32

BE IT RESOLVED, That copies of this Memorial be immediately 33 34 transmitted to the Honorable William J. Clinton, President of the United States, the President of the United States Senate, the Speaker 35 of the House of Representatives, and each member of Congress from the 36
