- 1 AN ACT Relating to the disposal of state parks and recreation
- 2 commission land in Moses Lake, Washington; creating a new section; and
- 3 declaring an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** Upon obtaining necessary waivers or other
- 6 adequate legal assurances with respect to the removal or modification
- 7 of any applicable deed restrictions or reversionary clauses, the state
- 8 parks and recreation commission shall convey to the city of Moses Lake
- 9 all property located within the city of Moses Lake that is currently
- 10 developed for use as a state park, and additionally any land owned by
- 11 the state parks and recreation commission that is adjacent to the land
- 12 currently developed for use as a state park. The city of Moses Lake
- 13 shall take all measures necessary to accept these lands into ownership.
- 14 The city of Moses Lake shall maintain as a city park all conveyed
- 15 land for public outdoor recreation purposes. The title, and any other
- 16 documents necessary for the transfer of these lands, will include
- 17 covenants ensuring that the city of Moses Lake will maintain all
- 18 conveyed land as a city park. If the city of Moses Lake breaches these

- 1 covenants, ownership of all park lands conveyed under this act will
- 2 revert to the state parks and recreation commission.
- 3 <u>NEW SECTION.</u> **Sec. 2.** This act is necessary for the immediate
- 4 preservation of the public peace, health, or safety, or support of the
- 5 state government and its existing public institutions, and takes effect
- 6 immediately.
