- 1 AN ACT Relating to the eradication of Eurasian water milfoil;
- 2 adding a new section to chapter 90.48 RCW; making appropriations; and
- 3 declaring an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 90.48 RCW 6 to read as follows:
- 7 (1) A county weed board seeking to treat not more than twenty
- 8 percent of the littoral zone of a lake infested with Eurasian water
- 9 milfoil may use the pesticide 2,4-D to treat the Eurasian milfoil
- 10 infestation without obtaining a permit under RCW 90.48.445. In lieu of
- 11 a permit, any application under this section must be made according to
- 12 all label requirements and adequate public notice shall be provided.
- 13 The county weed board shall, at a minimum, notify all lake residents,
- 14 post notices of intent to treat weeds at all public access points prior
- 15 to making such treatment, and place informational buoys around the
- 16 treatment area.
- 17 (2) The department shall enter into grant agreements with county
- 18 weed boards by March 1st of each year. The grant agreements may
- 19 include reporting requirements, including an assessment of the

- 1 treatment method, timelines, and a fund disbursement schedule based on
- 2 agreed project milestones.
- 3 (3) Weed boards using this section shall consider development of
- 4 long-term control strategies for eradication and control of the
- 5 Eurasian water milfoil.
- 6 <u>NEW SECTION.</u> **Sec. 2.** (1) The sum of two hundred fifty thousand
- 7 dollars, or as much thereof as may be necessary, is appropriated for
- 8 the fiscal year ending June 30, 2000, from the general fund to the
- 9 department of ecology for the purposes of the Eurasian milfoil
- 10 projects. Up to three percent of the total amount may be used by the
- 11 department to cover administrative costs.
- 12 (2) The sum of two hundred fifty thousand dollars, or as much
- 13 thereof as may be necessary, is appropriated for the fiscal year ending
- 14 June 30, 2001, from the general fund to the department of ecology for
- 15 the purposes of the Eurasian milfoil projects. Up to three percent of
- 16 the total amount may be used by the department to cover administrative
- 17 costs.
- 18 <u>NEW SECTION.</u> **Sec. 3.** Section 2 of this act is necessary for the
- 19 immediate preservation of the public peace, health, or safety, or
- 20 support of the state government and its existing public institutions,
- 21 and takes effect immediately.
