- AN ACT Relating to operating fee waivers; amending RCW 28B.15.066
- 2 and 28B.15.910; and adding a new section to chapter 28B.15 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 NEW SECTION. Sec. 1. A new section is added to chapter 28B.15 RCW
- 5 to read as follows:
- 6 In addition to waivers granted under the authority of RCW
- 7 28B.15.910, the governing boards of the state universities, the
- 8 regional universities, The Evergreen State College, and the community
- 9 colleges may waive all or a portion of the operating fees for any
- 10 student. There shall be no state general fund support for waivers
- 11 granted under this section.
- 12 **Sec. 2.** RCW 28B.15.066 and 1995 1st sp.s. c 9 s 3 are each amended
- 13 to read as follows:
- 14 It is the intent of the legislature that:
- 15 In making appropriations from the state's general fund to
- 16 institutions of higher education, each appropriation shall conform to
- 17 the following:

1 (1) The appropriation shall not be reduced by the amount of 2 operating fees revenue estimated to be collected from students enrolled 3 at the state-funded enrollment level specified in the omnibus biennial 4 operating appropriations act;

- (2) The appropriation shall not be reduced by the amount of operating fees revenue collected from students enrolled above the state-funded level, but within the over-enrollment limitations, specified in the omnibus biennial operating appropriations act; and
- 9 (3) The general fund state appropriation shall not be reduced by
 10 the amount of operating fees revenue collected as a result of waiving
 11 less operating fees revenue than the amounts authorized under RCW
 12 28B.15.910. State general fund appropriations shall not be provided
 13 for revenue foregone as a result of or for waivers granted under
 14 section 1 of this act.
- 15 **Sec. 3.** RCW 28B.15.910 and 1998 c 346 s 904 are each amended to 16 read as follows:
- (1) For the purpose of providing state general fund support to 17 18 public institutions of higher education, except for revenue waived under programs listed in subsection (3) of this section, and unless 19 otherwise expressly provided in the omnibus state appropriations act, 20 the total amount of operating fees revenue waived, exempted, or reduced 21 by a state university, a regional university, The Evergreen State 22 23 College, or the community colleges as a whole, shall not exceed the 24 percentage of total gross authorized operating fees revenue set forth 25 As used in this section, "gross authorized operating fees revenue" means the estimated gross operating fees revenue as estimated 26 27 under RCW 82.33.020 or as revised by the office of financial management, before granting any waivers. This limitation applies to 28 all tuition waiver programs established before or after July 1 1992 29
