- 1 TO THE HONORABLE GARY LOCKE, GOVERNOR OF THE STATE OF WASHINGTON:
- We, your Memorialists, the Senate and House of Representatives of
- 3 the State of Washington, in legislative session assembled, respectfully
- 4 represent and petition as follows:
- 5 WHEREAS, On Sunday, June 25, 1950, seven North Korean Army
- 6 Divisions supported by tanks and aircraft, conducted an attack and
- 7 invaded the Southern Republic of Korea; and
- 8 WHEREAS, Three years and over five million casualties later, a
- 9 cease fire was secured ending the fighting only miles from where it
- 10 began; and
- 11 WHEREAS, The Korean War has only become a footnote in history to
- 12 most Americans, but was no less of a war to the one and one-half
- 13 million fighting men and women from this nation who served in that
- 14 short "Police Action" and struggled to contain Communist aggression;
- 15 and
- 16 WHEREAS, The memories of endless hostile hills, gritty pudding-like
- 17 mud, snow, choking dust, frozen reservoirs, long periods of boredom,
- 18 and the violent death of friends will forever linger in the minds of
- 19 those who fought under these inhospitable conditions; and
- 20 WHEREAS, Twenty-two nations joined forces with the courageous
- 21 people of South Korea, cherishing freedom and democracy under the

- 1 United Nations Command, and eventually secured a cease fire for the
- 2 preservation of peace and a democratic way of life for the citizens of
- 3 South Korea; and
- 4 WHEREAS, More than five hundred sons and daughters of Washington
- 5 state stood in the unbroken line of patriots who dared to die in order
- 6 that freedom might live and grow. Freedom lives and through it, these
- 7 courageous men and women live in a way that would humble the
- 8 undertakings of most people; and
- 9 WHEREAS, The families and loved ones of these men and women
- 10 sacrificed just as much, by enduring the pain of their absence, the
- 11 uncertainty of their whereabouts, and the agony of their deaths; and
- 12 WHEREAS, This millennium commemorates the 50th anniversary of that
- 13 holocaust, known as "the Forgotten War" and veterans' service
- 14 organizations are involved in honoring those gallant veterans who
- 15 fought the battles for the preservation of freedom, and the members of
- 16 the armed forces who even to this day guard the gates of freedom in
- 17 Korea; and
- 18 WHEREAS, As a nation, we should educate every generation of
- 19 Americans on the history of the Korean War in preserving our nation's
- 20 liberty, freedom, and prosperity, and commemorating this event will
- 21 provide Americans with a clear understanding of, and appreciation for,
- 22 the sacrifices of these veterans and their families;
- NOW, THEREFORE, Your Memorialists respectfully pray that the years
- 24 2000 and 2003 be designated as the 50th anniversaries of the beginning
- 25 and end of the Korean War to honor all veterans of this nation and our
- 26 allies during the Korean War as well as those serving there today, and
- 27 encourage all citizens of the Evergreen State to combine their efforts
- 28 with veterans' service organizations and educational institutions to
- 29 remember, and perpetuate the meaning of sacrifice for peace and
- 30 freedom, by honoring those veterans who secured that legacy for future
- 31 generations throughout the world;
- 32 BE IT RESOLVED, That copies of this Memorial be immediately
- 33 transmitted to the Honorable Gary Locke, Governor of the State of
- 34 Washington.
