8 **Sec. 3.** RCW 84.36.800 and 1998 c 311 s 24 are each amended to read as  
9 follows:

10 As used in this chapter:

11 (1) "~~((Church Religious worship~~ purposes means the use of real and personal  
12 property owned by a nonprofit religious organization for religious worship or related  
13 administrative, educational, eleemosynary and social activities. This definition is to be  
14 broadly construed;

15 (2) "~~((Convent Religious community residence~~" means a house or set of  
16 buildings occupied by a community of clergy or nuns devoted to religious life under a  
17 superior;

18 (3) "Hospital means any portion of a hospital building or other building in  
19 connection therewith used as a residence for persons engaged or employed in the  
20 operation of a hospital or operated as a portion of the hospital unit;

21 (4) "Nonprofit means an organization, association or corporation no part of the  
22 income of which is paid directly or indirectly to its members, stockholders, officers,  
23 directors or trustees except in the form of services rendered by the organization,  
24 association or corporation in accordance with its purposes and bylaws and the salary or  
25 compensation paid to officers of such organization, association or corporation for actual  
26 services rendered and compared to the salary or compensation of like positions within the  
27 public services of the state;

28 (5) "~~((Parsonage Clergy residence~~" means a residence occupied by a member  
29 of the clergy who has been designated for a particular congregation and who holds regular  
30 services therefor.

1           (6) "Place of worship" means real and personal property owned by  
2 a nonprofit religious organization and used for religious worship  
3 purposes."

4           Renumber sections consecutively, correct any internal references  
5 accordingly, and correct the title.

**EFFECT:** Replaces terms such as "church" with terms like "place of  
worship."
