12 project unless the addition itself is capable, or intended to be
13 capable, of generating electricity in an amount greater than two
14 hundred fifty megawatts)) or other plant or installation that would
15 cause the applicant's total projected energy production capacity,
16 including the proposed plant or installation, to exceed one hundred ten
17 percent of the projected demand of the consumers within the applicant's
18 service area boundaries over a twenty-year period following completion
19 of the project-

EFFECT: Changes the definition of major public energy project from any project that generates or has the capacity to generate electricity in an amount greater than 400 megawatts to a nuclear power plant of any size and any other plant that would increase the public utility's total production capacity to more than 110 percent of the projected demand of consumers within the public utility's service area over a 20 year period following completion of the project. The definition of major public energy project- determines which public power projects must obtain approval for public financing through a public vote.
