The legislature finds that bicycling and 8 walking are becoming increasingly popular in Washington as clean and 9 efficient modes of transportation, as recreational activities, and as 10 organized sports. Future plans for the state's transportation system will require increased access and safety for bicycles and pedestrians 11 12 on our common roadways, and federal transportation legislation and 13 funding programs have created strong incentives to implement these 14 changes quickly. As a result, many more people are likely to take up 15 bicycling in Washington both as a leisure activity and as a convenient, 16 inexpensive form of transportation. Bicyclists are more vulnerable to 17 injury and accident than motorists, and both should be knowledgeable about traffic Bicyclists should be highly visible and 18 laws. 19 predictable when riding in traffic, and be encouraged to wear bicycle 20 safety helmets. Hundreds of bicyclists and pedestrians are seriously injured every year in accidents, and millions of dollars are spent on 21 health care costs associated with these accidents. 22 There is clear evidence that organized training in the rules and techniques of safe 23 and effective cycling can significantly reduce the incidence of serious 24 injury and accidents, increase cooperation among road users, and 25 26 significantly increase the incidence of bicycle helmet particularly among minors. A reduction in accidents benefits the 27 Therefore, it is appropriate for businesses and 28 entire community. community organizations to provide donations to bicycle and pedestrian 29 30 safety training programs.
- 31 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 46.04 RCW
- 32 to read as follows:
- 33 "Cooper Jones Act license plate emblems" means emblems on valid
- 34 Washington license plates that display the symbol of bicycle safety
- 35 created in section 3 of this act.

NEW SECTION. Sec. 3. A new section is added to chapter 46.16 RCW to read as follows:

3 In cooperation with the Washington state patrol and the department 4 of licensing, the traffic safety commission shall create and design, and the department shall issue, Cooper Jones license plate emblems 5 displaying a symbol of bicycle safety that may be used on motor 6 7 vehicles required to display two motor vehicle license plates, 8 excluding vehicles registered under chapter 46.87 RCW, upon terms and 9 conditions established by the department. These license plate emblems 10 will fund the Cooper Jones act and provide funding for bicyclist and pedestrian safety education, enforcement, and encouragement. 11

12 Any person may purchase Cooper Jones license plate emblems. The emblems are to be displayed on the vehicle license plates in the manner 13 described by the department, existing vehicular licensing procedures, 14 15 and current laws. The fee for Cooper Jones emblems shall be twentyfive dollars. All moneys collected shall first go to the department to 16 be deposited into the motor vehicle fund until all expenses of 17 designing and producing the emblems are recovered. 18 Thereafter, the 19 department shall deduct an amount not to exceed five dollars of each 20 fee collected for Cooper Jones emblems for administration and collection expenses. The remaining proceeds shall be remitted to the 21 custody of the state treasurer with a proper identifying detailed 22 report. The state treasurer shall credit the proceeds to the bicycle 23 24 and pedestrian safety account as established in RCW 43.59.150."
