### HOUSE COMMITTEE ON CAPITAL BUDGET

**Majority Report:** Do pass as amended. Signed by 9 members: Representatives Murray, Chair; McIntire, Vice Chair; Chase, Hunt, Lantz, O'Brien, Ogden, Reardon and Veloria.

**Minority Report:** Do not pass. Signed by 8 members: Representatives Alexander, Ranking Minority Member; Armstrong, Bush, Casada, Esser, Hankins, Schoesler and Woods.

**Background:**

Washington is on a biennial budget cycle. The Legislature authorizes expenditures for capital needs in the capital budget for a two-year period, and authorizes bond sales through passage of a bond bill associated with the capital budget.

The current capital budget covers the period from July 1, 2001, through June 30, 2003.

---

**Summary of Amended Bill:**

Supplemental appropriations are made for the 2001-03 biennium. The budget appropriates \$125 million for economic stimulus projects (\$108 million) and other supplemental projects (\$17 million). Adjustments are made to other appropriations.

**Amended Bill Compared to Engrossed Bill:**

While the original engrossed bill finances \$125 million in economic stimulus projects and other supplemental projects using bonds exempted from the debt limit, the amended bill funds \$125 million in similar projects primarily using debt limit bonds and the Education Construction Fund.

**Appropriation:** None.

**Fiscal Note:** Not Requested.

**Effective Date of Amended Bill:** This bill contains an emergency clause and takes effect immediately.
