- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 Sec. 1. RCW 28A.410.010 and 1992 c 159 s 3 and 1992 c 60 s 2 are 6 each reenacted and amended to read as follows:
- 7 (1) The state board of education shall establish, publish, and
- enforce rules ((and regulations)) determining eligibility for and 8
- 9 certification of personnel employed in the common schools of this
- 10 state, including certification for emergency or temporary,
- substitute or provisional duty and under such certificates or 11
- 12 permits as the board shall deem proper or as otherwise prescribed
- by law((-)) subject to the following conditions: 13
- 14 (a) The rules shall require that the initial application for
- 15 certification shall require a record check of the applicant
- 16 through the Washington state patrol criminal identification system
- 17 and through the federal bureau of investigation at the applicant's
- The record check shall include a fingerprint check using a 18

- 1 complete Washington state criminal identification fingerprint
- 2 card. The superintendent of public instruction may waive the record
- 3 check for any applicant who has had a record check within the two
- 4 years before application.
- 5 (b) The rules shall permit a holder of a lapsed certificate who
- 6 has separated from service with a school district or approved
- 7 private school located in the state of Washington to be employed
- 8 <u>on a conditional basis for a maximum of two years by a school</u>
- 9 district or approved private school under the following
- 10 conditions:
- 11 <u>(i) The holder's certificate has not been suspended or revoked;</u>
- 12 <u>(ii) The holder has successfully completed state-mandated</u>
- 13 <u>background checks</u>;
- 14 (iii) The holder's certificate lapsed no more than eight years
- 15 <u>before the holder is reemployed under this section;</u>
- 16 (iv) The holder has a letter of recommendation from the school
- 17 <u>district or approved private school of last employment;</u>
- 18 (v) The holder must complete any certificate renewal
- 19 requirements established by the state board of education within
- 20 two years of initial reemployment, and must file with the employer
- 21 <u>a written plan for achieving the requirements within the allotted</u>
- 22 <u>time; and</u>
- 23 (vi) If hired by a school district, the holder shall be
- 24 employed under a one-year provisional contract that may be renewed
- 25 no more than once. The holder must make satisfactory progress
- 26 toward the achievement of the certificate renewal requirements
- 27 <u>before the provisional contract may be renewed.</u>
- 28 (2) In establishing rules pertaining to the qualifications of
- 29 instructors of American sign language the state board shall
- 30 consult with the national association of the deaf, "sign
- 31 instructors guidance network" (s.i.g.n.), and the Washington state
- 32 association of the deaf for evaluation and certification of sign
- 33 language instructors.
- 34 (3) The superintendent of public instruction shall act as the
- 35 administrator of any such rules ((and regulations)) and have the
- 36 power to issue any certificates or permits and revoke the same in
