1 AN ACT Relating to consolidating funds within the general  
2 administration services account; amending RCW 43.19.025 and 43.19.1923;  
3 and repealing RCW 39.35C.110.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 43.19.025 and 1998 c 105 s 1 are each amended to read  
6 as follows:

7 The general ((services)) administration ((~~{general administration~~  
8 ~~services}~~)) services account is created in the custody of the state  
9 treasurer and shall be used for all activities previously budgeted and  
10 accounted for in the following internal service funds: The motor  
11 transport account, the general administration management fund, the  
12 general administration facilities and services revolving fund, the  
13 central stores revolving fund, the surplus property purchase revolving  
14 fund, ((and)) the risk management account, and the energy efficiency  
15 services account. Only the director or the director's designee may  
16 authorize expenditures from the account.

17 **Sec. 2.** RCW 43.19.1923 and 1998 c 105 s 6 are each amended to read  
18 as follows:

1       The general administration services account shall be used for the  
2 purchase of supplies and equipment handled or rented through central  
3 stores, and the payment of salaries, wages, and other costs incidental  
4 to the acquisition, operation, and maintenance of the central stores,  
5 and other activities connected therewith, which shall include utilities  
6 services. ~~((Disbursements from the account for the purchasing and  
7 contract administration activities of the division of purchasing within  
8 the department are subject to appropriation and allotment procedures  
9 under chapter 43.88 RCW. Disbursements for all other state purchasing  
10 activities within the general administration services account are not  
11 subject to appropriation.))~~ The account shall be credited with all  
12 receipts from the rental, sale or distribution of supplies, equipment,  
13 and services rendered to the various state agencies. Central stores,  
14 utilities services, and other activities within the general  
15 administration services account shall be treated as separate operating  
16 entities for financial and accounting control. Financial records  
17 involving the general administration services account shall be designed  
18 to provide data for achieving maximum effectiveness and economy of each  
19 individual activity within the account.

20       NEW SECTION.   **Sec. 3.**   RCW 39.35C.110 (Energy efficiency services  
21 account--Fees) and 1996 c 186 s 415 & 1991 c 201 s 12 are each  
22 repealed.
