- AN ACT Relating to reclaimed water; adding a new section to chapter
- 2 82.16 RCW; adding a new section to chapter 82.08 RCW; and adding a new
- 3 section to chapter 82.12 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.16 RCW 6 to read as follows:
- 7 This chapter does not apply to amounts received for water services
- 8 supplied by an entity that holds a permit under RCW 90.46.030 when the
- 9 water supplied is reclaimed water as defined in RCW 90.46.010.
- 10 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.08 RCW
- 11 to read as follows:
- 12 The tax levied by RCW 82.08.020 shall not apply to sales of
- 13 machinery and equipment used directly in transmitting, distributing, or
- 14 storing reclaimed water as defined in RCW 90.46.010, or to sales of or
- 15 charges made for labor and services rendered in respect to installing
- 16 such machinery and equipment. As used in this section, "machinery and
- 17 equipment" means pipelines, outfalls, conduits, pumping stations,
- 18 instrumentation and monitoring equipment, structures, machinery,

- 1 equipment, accessories, and all other construction, devices,
- 2 appurtenances, and facilities used for the primary purpose of
- 3 conducting reclaimed water from a wastewater treatment facility for a
- 4 beneficial use, including the augmentation of streamflow for fish.
- 5 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 82.12 RCW 6 to read as follows:
- 7 The provisions of this chapter shall not apply with respect to the
- 8 use of machinery and equipment used directly in transmitting,
- 9 distributing, or storing reclaimed water as defined in RCW 90.46.010.
- 10 "Machinery and equipment" means pipelines, outfalls, conduits, pumping
- 11 stations, instrumentation and monitoring equipment, structures,
- 12 machinery, equipment, accessories, and all other construction, devices,
- 13 appurtenances, and facilities used for the primary purpose of
- 14 conducting reclaimed water from a wastewater treatment facility for a
- 15 beneficial use, including augmentation of streamflow for fish.
