- AN ACT Relating to requiring the distribution of tips to employees;
- 2 adding a new section to chapter 49.46 RCW; adding a new section to
- 3 chapter 82.04 RCW; and adding a new section to chapter 82.08 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 49.46 RCW 6 to read as follows:
- 7 (1)(a) For the purposes of this section, "tip" means:
- 8 (i) A sum presented voluntarily by a customer to an employee as a
- 9 gift or gratuity in recognition of service performed for the customer;
- 10 or
- 11 (ii) A sum paid by a customer to a seller that is a mandatory
- 12 addition to the selling price, whether labeled a service charge, a tip,
- 13 a gratuity, or otherwise, for service performed for the customer.
- 14 (b) "Tip" includes:
- 15 (i) A sum presented or paid in legal tender of the United States or
- 16 by check on a bank convertible into cash on demand at full face value;
- 17 or

- 1 (ii) A sum transferred by the seller to an employee at the 2 direction of credit customers who designate amounts to be added to
- 3 their bills as tips.
- 4 (2) When a customer pays a tip to a seller, the seller must 5 distribute the tip to employees as follows:
- 6 (a) Through a tip pooling arrangement mutually agreed upon by the 7 employees;
- 8 (b) If a tip pooling arrangement does not exist, then to the 9 employee or employees who performed the service; or
- 10 (c) If the employee or employees who performed the service are not
- 11 readily identifiable, then to the employees who worked on the day the
- 12 customer paid the tip.
- 13 (3) A tip may not be used, in whole or in part, to satisfy the 14 monetary requirements of RCW 49.46.020.
- 15 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.04 RCW
- 16 to read as follows:
- 17 This chapter does not apply to amounts paid or received as tips as
- 18 defined in section 1 of this act.
- 19 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 82.08 RCW
- 20 to read as follows:
- 21 The tax levied by RCW 82.08.020 does not apply to amounts paid or
- 22 received as tips as defined in section 1 of this act.
