- 1 AN ACT Relating to the halal food consumer protection act; adding
- 2 a new chapter to Title 69 RCW; and prescribing penalties.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The definitions in this section apply 5 throughout this chapter unless the context clearly requires otherwise.
- 6 (1) "Dealer" means any person that advertises, represents, or holds
- 7 itself out as selling, preparing, or maintaining food as halal
- 8 including, but not limited to, manufacturers, slaughterhouses,
- 9 wholesalers, stores, restaurants, hotels, catering facilities, butcher
- 10 shops, summer camps, bakeries, delicatessens, supermarkets, grocery
- 11 stores, nursing homes, freezer dealers, and food plan companies.
- 12 (2) "Food product" includes any article other than drugs, whether
- 13 in raw or prepared form, liquid or solid, or packaged or unpackaged,
- 14 and which is used for human consumption.
- 15 (3) "Halal" means a food product which has been prepared,
- 16 processed, manufactured, maintained, and sold in strict compliance with
- 17 the laws and customs of the Islamic religion.
- 18 (4) "Person" includes individuals, partnerships, corporations, and
- 19 associations.

- 1 <u>NEW SECTION.</u> **Sec. 2.** No dealer may knowingly sell or offer for
- 2 sale any food product represented as "halal" or "halal style" when that
- 3 dealer knows that the food product is not halal and when the
- 4 representation is likely to cause a prospective purchaser to believe
- 5 that it is halal. This representation can be made orally or in
- 6 writing, or by display of a sign, mark, insignia, or simulation.
- 7 <u>NEW SECTION.</u> **Sec. 3.** A violation of this chapter constitutes a
- 8 violation of the consumer protection act, chapter 19.86 RCW.
- 9 <u>NEW SECTION.</u> **Sec. 4.** A dealer who violates any provision of this
- 10 chapter is guilty of a gross misdemeanor.
- 11 <u>NEW SECTION.</u> **Sec. 5.** This chapter may be known and cited as the
- 12 halal food consumer protection act.
- 13 <u>NEW SECTION.</u> **Sec. 6.** Sections 1 through 5 of this act constitute
- 14 a new chapter in Title 69 RCW.
