- 1 AN ACT Relating to housing allowances for nonsupervisory K-12
- 2 employees; amending RCW 28A.400.200, 84.52.0531, 41.32.010, and
- 3 41.40.010; adding a new section to chapter 28A.400 RCW; adding a new
- 4 section to chapter 28A.500 RCW; adding a new section to chapter 84.52
- 5 RCW; and creating a new section.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 NEW SECTION. Sec. 1. As the disparity in the cost-of-living
- 8 between school districts across the state has grown in recent years,
- 9 the purchasing power of equalized salaries has become more disparate
- 10 for K-12 employees. A major contributor to these costs is housing.
- 11 The purpose of this act is to authorize a housing allowance for
- 12 nonsupervisory public school employees in order to minimize disparities
- 13 in purchasing power among educational employees across the state.
- 14 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 28A.400
- 15 RCW to read as follows:
- 16 (1) Eligible school districts may provide a housing allowance for
- 17 nonsupervisory classified and certificated employees.

(2) The cost of the housing for each school district and the statewide median shall be determined every four years based on a standard set of housing specifications and on data reported for the most recent annual period for which data are available. The collection of data shall be done by a nationally recognized entity that collects statistically valid housing cost data for federal government agencies and businesses, selected by the superintendent of public instruction and subject to approval by the legislative fiscal committees and the office of financial management. The office of financial management shall contract with the entity selected under this subsection (2) from funds provided for this purpose.

- (3) The housing allowance levy shall be authorized for school 12 districts having housing costs that exceed the statewide median cost of 13 housing as determined under subsection (2) of this section. 14 The 15 calculation of the maximum levy allowed for a qualifying school 16 district shall be the number of nonsupervisory classified 17 certificated full-time equivalent employees multiplied by difference between the district's cost of housing and the median cost 18 19 of housing statewide. For purposes of this calculation, the difference 20 between the district's cost of housing and the statewide median shall not exceed fifty percent of the median. 21
  - (4) Individual payment of the housing allowance to nonsupervisory classified and certificated employees is subject to collective bargaining but shall be paid only to actively employed nonsupervisory classified and certificated employees. The housing allowance shall not be considered as within the definition of basic education for the purposes of chapter 28A.150 RCW, nor is it earnable compensation as defined in RCW 41.32.010 or compensation earnable as defined in RCW 41.40.010.
- 30 (5) Local school districts that qualify for a housing allowance 31 levy under subsection (3) of this section may submit to voters an 32 excess general fund levy on real property to support up to and 33 including the maximum housing levy authority determined in subsection 34 (3) of this section. This levy is not subject to the limitations in 35 RCW 84.52.0531. This levy does not qualify a school district for local 36 effort assistance under chapter 28A.500 RCW.
- 37 (6) The office of the superintendent of public instruction shall 38 administer the housing allowance program and shall adopt rules for 39 implementation.

- NEW SECTION. Sec. 3. A new section is added to chapter 28A.500 1
- 2 RCW to read as follows:
- 3 Levies authorized under section 2 of this act shall not be
- 4 considered in determining a school district's eligibility for local
- 5 effort assistance under this chapter.
- Sec. 4. RCW 28A.400.200 and 1997 c 141 s 2 are each amended to 6 read as follows: 7
- 8 (1) Every school district board of directors shall fix, alter,
- 9 allow, and order paid salaries and compensation for all district
- employees in conformance with this section. 10
- (2)(a) Salaries for certificated instructional staff shall not be 11
- 12 less than the salary provided in the appropriations act in the
- 13 statewide salary allocation schedule for an employee with a
- baccalaureate degree and zero years of service; and 14
- 15 (b) Salaries for certificated instructional staff with a masters
- 16 degree shall not be less than the salary provided in the appropriations
- act in the statewide salary allocation schedule for an employee with a 17
- 18 masters degree and zero years of service;
- 19 (3)(a) The actual average salary paid to basic education and
- special education certificated instructional staff shall not exceed the 20
- district's average basic education and special education program 21
- certificated instructional staff salary used for the state basic 22
- 23 education allocations for that school year as determined pursuant to
- 24 RCW 28A.150.410.
- 25 (b) Fringe benefit contributions for basic education and special
- education certificated instructional staff shall be included as salary 26
- 27 under (a) of this subsection only to the extent that the district's
- actual average benefit contribution exceeds the amount of the insurance
- 28
- 29 benefits allocation provided per certificated instructional staff unit
- 30 in the state operating appropriations act in effect at the time the
- compensation is payable. For purposes of this section, fringe benefits 31
- 32 shall not include payment for unused leave for illness or injury under
- 33 28A.400.210; employer contributions for old age survivors
- 34 insurance, workers' compensation, unemployment compensation, and
- retirement benefits under the Washington state retirement system; or 35
- 36 employer contributions for health benefits in excess of the insurance
- benefits allocation provided per certificated instructional staff unit 37
- 38 in the state operating appropriations act in effect at the time the

- 1 compensation is payable. A school district may not use state funds to 2 provide employer contributions for such excess health benefits.
- 3 (c) Salary and benefits for certificated instructional staff in 4 programs other than basic education and special education shall be 5 consistent with the salary and benefits paid to certificated 6 instructional staff in the basic education and special education 7 programs.
- 8 (4) Salaries and benefits for certificated instructional staff may 9 exceed the limitations in subsection (3) of this section only by separate contract for additional time, additional responsibilities, or 10 incentives. Supplemental contracts shall not cause the state to incur 11 any present or future funding obligation. Supplemental contracts shall 12 13 be subject to the collective bargaining provisions of chapter 41.59 RCW and the provisions of RCW 28A.405.240, shall not exceed one year, and 14 15 if not renewed shall not constitute adverse change in accordance with RCW 28A.405.300 through 28A.405.380. No district may enter into a 16 17 supplemental contract under this subsection for the provision of services which are a part of the basic education program required by 18 19 Article IX, section 3 of the state Constitution.
- 20 (5) Employee benefit plans offered by any district shall comply 21 with RCW 28A.400.350 and 28A.400.275 and 28A.400.280.
- 22 (6) Housing allowances authorized in section 2 of this act shall 23 not be included as salary under this section and shall not be included 24 in salary limitations.
- 25 **Sec. 5.** RCW 84.52.0531 and 1997 c 259 s 2 are each amended to read 26 as follows:
- The maximum dollar amount which may be levied by or for any school district for maintenance and operation support under the provisions of RCW 84.52.053 shall be determined as follows:
- 30 (1) For excess levies for collection in calendar year 1997, the 31 maximum dollar amount shall be calculated pursuant to the laws and 32 rules in effect in November 1996.
- 33 (2) For excess levies for collection in calendar year 1998 and 34 thereafter, the maximum dollar amount shall be the sum of (a) plus or 35 minus (b) and (c) of this subsection minus (d) of this subsection:
- 36 (a) The district's levy base as defined in subsection (3) of this 37 section multiplied by the district's maximum levy percentage as defined 38 in subsection (4) of this section;

- (b) For districts in a high/nonhigh relationship, the high school district's maximum levy amount shall be reduced and the nonhigh school district's maximum levy amount shall be increased by an amount equal to the estimated amount of the nonhigh payment due to the high school district under RCW 28A.545.030(3) and 28A.545.050 for the school year commencing the year of the levy;

- (iii) The percent increase per full-time equivalent student as stated in the state basic education appropriation section of the biennial budget between the prior school year and the current school year divided by fifty-five percent;

- 24 (3) For excess levies for collection in calendar year 1998 and 25 thereafter, a district's levy base shall be the sum of allocations in 26 (a) through (c) of this subsection received by the district for the prior school year, including allocations for compensation increases, 27 plus the sum of such allocations multiplied by the percent increase per 28 29 full time equivalent student as stated in the state basic education 30 appropriation section of the biennial budget between the prior school 31 year and the current school year and divided by fifty-five percent. A district's levy base shall not include local school district property 32 tax levies or other local revenues, or state and federal allocations 33 not identified in (a) through (c) of this subsection. 34
- 35 (a) The district's basic education allocation as determined gray gray and 28A.150.250; 28A.150.260, and 28A.150.350;
- 37 (b) State and federal categorical allocations for the following 38 programs:
  - (i) Pupil transportation;

- 8 (c) Any other federal allocations for elementary and secondary 9 school programs, including direct grants, other than federal impact aid 10 funds and allocations in lieu of taxes.
- 11 (4) A district's maximum levy percentage shall be twenty-two 12 percent in 1998 and twenty-four percent in 1999 and every year 13 thereafter; plus, for qualifying districts, the grandfathered 14 percentage determined as follows:
- 15 (a) For 1997, the difference between the district's 1993 maximum 16 levy percentage and twenty percent; and
- 17 (b) For 1998 and thereafter, the percentage calculated as follows:
- (i) Multiply the grandfathered percentage for the prior year times the district's levy base determined under subsection (3) of this section;
- (ii) Reduce the result of (b)(i) of this subsection by any levy reduction funds as defined in subsection (5) of this section that are to be allocated to the district for the current school year;
- (iii) Divide the result of (b)(ii) of this subsection by the district's levy base; and
- 26 (iv) Take the greater of zero or the percentage calculated in 27 (b)(iii) of this subsection.
- (5) "Levy reduction funds" shall mean increases in state funds from 28 the prior school year for programs included under subsection (3) of 29 30 this section: (a) That are not attributable to enrollment changes, compensation increases, or inflationary adjustments; and (b) that are 31 or were specifically identified as levy reduction funds in the 32 33 appropriations act. If levy reduction funds are dependent on formula factors which would not be finalized until after the start of the 34 35 current school year, the superintendent of public instruction shall estimate the total amount of levy reduction funds by using prior school 36 year data in place of current school year data. Levy reduction funds 37 shall not include moneys received by school districts from cities or 38

- 1 (6) For the purposes of this section, "prior school year" means the 2 most recent school year completed prior to the year in which the levies 3 are to be collected.
- 4 (7) For the purposes of this section, "current school year" means 5 the year immediately following the prior school year.
- 6 (8) Funds collected from transportation vehicle fund tax levies 7 shall not be subject to the levy limitations in this section.
- 8 (9) The limitations in this section do not apply to excess general
  9 fund levies for the support of the housing allowance provided for in
  10 section 2 of this act.
- 11 <u>(10)</u> The superintendent of public instruction shall develop rules 12 ((and regulations)) and inform school districts of the pertinent data 13 necessary to carry out the provisions of this section.
- NEW SECTION. Sec. 6. A new section is added to chapter 84.52 RCW to read as follows:
- A levy submitted to voters under section 2 of this act may be submitted as a separate levy, or as part of a maintenance and operation levy if the housing allowance levy is separately identified.
- 19 **Sec. 7.** RCW 41.32.010 and 1997 c 254 s 3 are each amended to read 20 as follows:
- As used in this chapter, unless a different meaning is plainly required by the context:
- (1)(a) "Accumulated contributions" for plan 1 members, means the sum of all regular annuity contributions and, except for the purpose of withdrawal at the time of retirement, any amount paid under RCW 41.50.165(2) with regular interest thereon.
- (b) "Accumulated contributions" for plan 2 members, means the sum of all contributions standing to the credit of a member in the member's individual account, including any amount paid under RCW 41.50.165(2), together with the regular interest thereon.
- 31 (2) "Actuarial equivalent" means a benefit of equal value when 32 computed upon the basis of such mortality tables and regulations as 33 shall be adopted by the director and regular interest.
- 34 (3) "Annuity" means the moneys payable per year during life by 35 reason of accumulated contributions of a member.
- 36 (4) "Member reserve" means the fund in which all of the accumulated 37 contributions of members are held.

- 1 (5)(a) "Beneficiary" for plan 1 members, means any person in 2 receipt of a retirement allowance or other benefit provided by this 3 chapter.
- 4 (b) "Beneficiary" for plan 2 and plan 3 members, means any person 5 in receipt of a retirement allowance or other benefit provided by this 6 chapter resulting from service rendered to an employer by another 7 person.
- 8 (6) "Contract" means any agreement for service and compensation 9 between a member and an employer.
- 10 (7) "Creditable service" means membership service plus prior 11 service for which credit is allowable. This subsection shall apply 12 only to plan 1 members.
- 13 (8) "Dependent" means receiving one-half or more of support from a 14 member.
- 15 (9) "Disability allowance" means monthly payments during 16 disability. This subsection shall apply only to plan 1 members.
  - (10)(a) "Earnable compensation" for plan 1 members, means:
- (i) All salaries and wages paid by an employer to an employee member of the retirement system for personal services rendered during a fiscal year. In all cases where compensation includes maintenance the employer shall fix the value of that part of the compensation not paid in money.
- (ii) "Earnable compensation" for plan 1 members also includes the following actual or imputed payments, which are not paid for personal services:
- (A) Retroactive payments to an individual by an employer on reinstatement of the employee in a position, or payments by an employer to an individual in lieu of reinstatement in a position which are awarded or granted as the equivalent of the salary or wages which the individual would have earned during a payroll period shall be considered earnable compensation and the individual shall receive the equivalent service credit.
- 33 (B) If a leave of absence, without pay, is taken by a member for 34 the purpose of serving as a member of the state legislature, and such 35 member has served in the legislature five or more years, the salary 36 which would have been received for the position from which the leave of 37 absence was taken shall be considered as compensation earnable if the 38 employee's contribution thereon is paid by the employee. In addition, 39 where a member has been a member of the state legislature for five or

more years, earnable compensation for the member's two highest compensated consecutive years of service shall include a sum not to exceed thirty-six hundred dollars for each of such two consecutive years, regardless of whether or not legislative service was rendered during those two years.

- (iii) For members employed less than full time under written 6 7 contract with a school district, or community college district, in an 8 instructional position, for which the member receives service credit of 9 less than one year in all of the years used to determine the earnable 10 compensation used for computing benefits due under RCW 41.32.497, 41.32.498, and 41.32.520, the member may elect to have earnable 11 compensation defined as provided in RCW 41.32.345. For the purposes of 12 13 this subsection, the term "instructional position" means a position in which more than seventy-five percent of the member's time is spent as 14 15 a classroom instructor (including office hours), a librarian, or a 16 counselor. Earnable compensation shall be so defined only for the 17 purpose of the calculation of retirement benefits and only as necessary to insure that members who receive fractional service credit under RCW 18 19 41.32.270 receive benefits proportional to those received by members who have received full-time service credit. 20
- 21 (iv) "Earnable compensation" does not include:

- 27 (b) "Earnable compensation" for plan 2 and plan 3 members, means 28 salaries or wages earned by a member during a payroll period for 29 personal services, including overtime payments, and shall include wages 30 and salaries deferred under provisions established pursuant to sections 31 403(b), 414(h), and 457 of the United States Internal Revenue Code, but shall exclude lump sum payments for deferred annual sick leave, unused 32 33 accumulated vacation, unused accumulated annual leave, or any form of 34 severance pay.

- 6 (ii) In any year in which a member serves in the legislature the 7 member shall have the option of having such member's earnable compensation be the greater of: 8
- 9 (A) The earnable compensation the member would have received had 10 such member not served in the legislature; or
- Such member's actual earnable compensation received for 11 12 teaching legislative service combined. additional and Any 13 contributions to the retirement system required because compensation earnable under (b)(ii)(A) of this subsection is greater than 14 15 compensation earnable under (b)(ii)(B) of this subsection shall be paid by the member for both member and employer contributions. 16
- 17 (11) "Employer" means the state of Washington, the school district, or any agency of the state of Washington by which the member is paid. 18
- 19 (12) "Fiscal year" means a year which begins July 1st and ends June 20 30th of the following year.
- (13) "Former state fund" means the state retirement fund in 21 operation for teachers under chapter 187, Laws of 1923, as amended. 22
- (14) "Local fund" means any of the local retirement funds for 23 24 teachers operated in any school district in accordance with the 25 provisions of chapter 163, Laws of 1917 as amended.
- 26 (15) "Member" means any teacher included in the membership of the 27 retirement system. Also, any other employee of the public schools who, 28 on July 1, 1947, had not elected to be exempt from membership and who, prior to that date, had by an authorized payroll deduction, contributed 29 30 to the member reserve.
- (16) "Membership service" means service rendered subsequent to the 31 first day of eligibility of a person to membership in the retirement 32 33 PROVIDED, That where a member is employed by two or more 34 employers the individual shall receive no more than one service credit 35 month during any calendar month in which multiple service is rendered.
- The provisions of this subsection shall apply only to plan 1 members. 36
- 37 (17) "Pension" means the moneys payable per year during life from the pension reserve. 38

- 1 (18) "Pension reserve" is a fund in which shall be accumulated an 2 actuarial reserve adequate to meet present and future pension 3 liabilities of the system and from which all pension obligations are to 4 be paid.
- (19) "Prior service" means service rendered prior to the first date of eligibility to membership in the retirement system for which credit is allowable. The provisions of this subsection shall apply only to plan 1 members.
- 9 (20) "Prior service contributions" means contributions made by a 10 member to secure credit for prior service. The provisions of this 11 subsection shall apply only to plan 1 members.
- (21) "Public school" means any institution or activity operated by the state of Washington or any instrumentality or political subdivision thereof employing teachers, except the University of Washington and Washington State University.
- 16 (22) "Regular contributions" means the amounts required to be 17 deducted from the compensation of a member and credited to the member's 18 individual account in the member reserve. This subsection shall apply 19 only to plan 1 members.
- 20 (23) "Regular interest" means such rate as the director may 21 determine.
- (24)(a) "Retirement allowance" for plan 1 members, means monthly payments based on the sum of annuity and pension, or any optional benefits payable in lieu thereof.
- (b) "Retirement allowance" for plan 2 and plan 3 members, means monthly payments to a retiree or beneficiary as provided in this chapter.
- 28 (25) "Retirement system" means the Washington state teachers' 29 retirement system.
- 30 (26)(a) "Service" for plan 1 members means the time during which a 31 member has been employed by an employer for compensation.
- 32 (i) If a member is employed by two or more employers the individual 33 shall receive no more than one service credit month during any calendar 34 month in which multiple service is rendered.
- (ii) As authorized by RCW 28A.400.300, up to forty-five days of sick leave may be creditable as service solely for the purpose of determining eligibility to retire under RCW 41.32.470.
- 38 (iii) As authorized in RCW 41.32.065, service earned in an out-of-39 state retirement system that covers teachers in public schools may be

- (b) "Service" for plan 2 and plan 3 members, means periods of employment by a member for one or more employers for which earnable compensation is earned subject to the following conditions:
- (i) A member employed in an eligible position or as a substitute shall receive one service credit month for each month of September through August of the following year if he or she earns earnable compensation for eight hundred ten or more hours during that period and is employed during nine of those months, except that a member may not receive credit for any period prior to the member's employment in an eligible position except as provided in RCW 41.32.812 and 41.50.132;
- (ii) If a member is employed either in an eligible position or as a substitute teacher for nine months of the twelve month period between September through August of the following year but earns earnable compensation for less than eight hundred ten hours but for at least six hundred thirty hours, he or she will receive one-half of a service credit month for each month of the twelve month period;
- 19 (iii) All other members in an eligible position or as a substitute 20 teacher shall receive service credit as follows:
- 21 (A) A service credit month is earned in those calendar months where 22 earnable compensation is earned for ninety or more hours;
- 23 (B) A half-service credit month is earned in those calendar months 24 where earnable compensation is earned for at least seventy hours but 25 less than ninety hours; and
- 26 (C) A quarter-service credit month is earned in those calendar 27 months where earnable compensation is earned for less than seventy 28 hours.
- (iv) Any person who is a member of the teachers' retirement system and who is elected or appointed to a state elective position may continue to be a member of the retirement system and continue to receive a service credit month for each of the months in a state elective position by making the required member contributions.
- (v) When an individual is employed by two or more employers the individual shall only receive one month's service credit during any calendar month in which multiple service for ninety or more hours is rendered.
- (vi) As authorized by RCW 28A.400.300, up to forty-five days of sick leave may be creditable as service solely for the purpose of

- 1 determining eligibility to retire under RCW 41.32.470. For purposes of

The term includes state, educational service district, and 26 school district superintendents and their assistants and all employees certificated by the superintendent of public instruction; and in 27 addition thereto any full time school doctor who is employed by a 28 public school and renders service of an instructional or educational 29 30 nature.
- 31 (30) "Average final compensation" for plan 2 and plan 3 members, 32 means the member's average earnable compensation of the highest 33 consecutive sixty service credit months prior to such member's 34 retirement, termination, or death. Periods constituting authorized 35 leaves of absence may not be used in the calculation of average final 36 compensation except under RCW 41.32.810(2).
- 37 (31) "Retiree" means any person who has begun accruing a retirement 38 allowance or other benefit provided by this chapter resulting from 39 service rendered to an employer while a member.

- 1 (32) "Department" means the department of retirement systems 2 created in chapter 41.50 RCW.
