16 For any new or revised water or sewer general comprehensive plan submitted by a city, town, public utility district, or water-sewer 17 18 district for review under this chapter, the department of health shall 19 review and either approve, conditionally approve, reject, or request amendments within ninety days of the receipt of the submission of the The department of health may extend this ninety-day time 21 limitation for new submittals by up to an additional ninety days if 22 23 insufficient time exists to adequately review the general comprehensive 24 plan. In addition, the governing body of the city, town, public 25 utility district, or water-sewer district and the department of health may mutually agree to an extension of the deadlines contained in this 27 section.
