1 AN ACT Relating to programs and proceedings for children under the
2 BECCA and HOPE acts; amending RCW 13.32A.030, 13.32A.160, 13.32A.170,
3 13.32A.179, 13.32A.190, 13.32A.196, 13.32A.198, 28A.225.035, 7.21.030,
4 13.32A.250, and 13.32A.250; reenacting and amending RCW 28A.225.090 and
5 28A.225.090; adding a new section to chapter 13.32A RCW; adding a new
6 section to chapter 74.15 RCW; providing an effective date; and
7 providing an expiration date.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

9 **Sec. 1.** RCW 13.32A.030 and 2000 c 123 s 2 are each amended to read
10 as follows:

11 As used in this chapter the following terms have the meanings
12 indicated unless the context clearly requires otherwise:

13 (1) "Abuse or neglect" means the injury, sexual abuse, sexual
14 exploitation, negligent treatment, or maltreatment of a child by any
15 person under circumstances which indicate that the child's health,
16 welfare, and safety is harmed, excluding conduct permitted under RCW
17 9A.16.100. An abused child is a child who has been subjected to child
18 abuse or neglect as defined in this section.

1 (2) "Administrator" means the individual who has the daily
2 administrative responsibility of a crisis residential center, or his or
3 her designee.

4 (3) "At-risk youth" means a juvenile:

5 (a) Who is absent from home for at least seventy-two consecutive
6 hours without consent of his or her parent;

7 (b) Who is beyond the control of his or her parent such that the
8 child's behavior endangers the health, safety, or welfare of the child
9 or any other person; ((or))

10 (c) Who has a substance abuse problem for which there are no
11 pending criminal charges related to the substance abuse; or

12 (d) Who refuses or fails to comply with the compulsory school
13 attendance laws as provided under chapter 28A.225 RCW.

14 (4) "Child," "juvenile," and "youth" mean any unemancipated
15 individual who is under the chronological age of eighteen years.

16 (5) "Child in need of services" means a juvenile:

17 (a) Who is beyond the control of his or her parent such that the
18 child's behavior endangers the health, safety, or welfare of the child
19 or other person;

20 (b) Who has been reported to law enforcement as absent without
21 consent for at least twenty-four consecutive hours on two or more
22 separate occasions from the home of either parent, a crisis residential
23 center, an out-of-home placement, or a court-ordered placement; and

24 (i) Has exhibited a serious substance abuse problem; or

25 (ii) Has exhibited behaviors that create a serious risk of harm to
26 the health, safety, or welfare of the child or any other person; or

27 (c)(i) Who is in need of: (A) Necessary services, including food,
28 shelter, health care, clothing, or education; or (B) services designed
29 to maintain or reunite the family;

30 (ii) Who lacks access to, or has declined to utilize, these
31 services; and

32 (iii) Whose parents have evidenced continuing but unsuccessful
33 efforts to maintain the family structure or are unable or unwilling to
34 continue efforts to maintain the family structure.

35 (6) "Child in need of services petition" means a petition filed in
36 juvenile court by a parent, child, or the department seeking
37 adjudication of placement of the child.

38 (7) "Crisis residential center" means a secure or semi-secure
39 facility established pursuant to chapter 74.13 RCW.

1 (8) "Custodian" means the person or entity who has the legal right
2 to the custody of the child.

3 (9) "Department" means the department of social and health
4 services.

5 (10) "Extended family member" means an adult who is a grandparent,
6 brother, sister, stepbrother, stepsister, uncle, aunt, or first cousin
7 with whom the child has a relationship and is comfortable, and who is
8 willing and available to care for the child.

9 (11) "Guardian" means that person or agency that (a) has been
10 appointed as the guardian of a child in a legal proceeding other than
11 a proceeding under chapter 13.34 RCW, and (b) has the right to legal
12 custody of the child pursuant to such appointment. The term "guardian"
13 does not include a "dependency guardian" appointed pursuant to a
14 proceeding under chapter 13.34 RCW.

15 (12) "Multidisciplinary team" means a group formed to provide
16 assistance and support to a child who is an at-risk youth or a child in
17 need of services and his or her parent. The team shall include the
18 parent, a department case worker, a local government representative
19 when authorized by the local government, and when appropriate, members
20 from the mental health and substance abuse disciplines. The team may
21 also include, but is not limited to, the following persons: Educators,
22 law enforcement personnel, probation officers, employers, church
23 persons, tribal members, therapists, medical personnel, social service
24 providers, placement providers, and extended family members. The team
25 members shall be volunteers who do not receive compensation while
26 acting in a capacity as a team member, unless the member's employer
27 chooses to provide compensation or the member is a state employee.

28 (13) "Out-of-home placement" means a placement in a foster family
29 home or group care facility licensed pursuant to chapter 74.15 RCW or
30 placement in a home, other than that of the child's parent, guardian,
31 or legal custodian, not required to be licensed pursuant to chapter
32 74.15 RCW.

33 (14) "Parent" means the parent or parents who have the legal right
34 to custody of the child. "Parent" includes custodian or guardian.

35 (15) "Secure facility" means a crisis residential center, or
36 portion thereof, that has locking doors, locking windows, or a secured
37 perimeter, designed and operated to prevent a child from leaving
38 without permission of the facility staff.

1 (16) "Semi-secure facility" means any facility, including but not
2 limited to crisis residential centers or specialized foster family
3 homes, operated in a manner to reasonably assure that youth placed
4 there will not run away. Pursuant to rules established by the
5 department, the facility administrator shall establish reasonable hours
6 for residents to come and go from the facility such that no residents
7 are free to come and go at all hours of the day and night. To prevent
8 residents from taking unreasonable actions, the facility administrator,
9 where appropriate, may condition a resident's leaving the facility upon
10 the resident being accompanied by the administrator or the
11 administrator's designee and the resident may be required to notify the
12 administrator or the administrator's designee of any intent to leave,
13 his or her intended destination, and the probable time of his or her
14 return to the center.

15 (17) "Staff secure facility" means a structured group care facility
16 licensed under rules adopted by the department with a ratio of at least
17 one adult staff member to every two children.

18 (18) "Temporary out-of-home placement" means an out-of-home
19 placement of not more than fourteen days ordered by the court at a
20 fact-finding hearing on a child in need of services petition.

21 **Sec. 2.** RCW 13.32A.160 and 2000 c 123 s 19 are each amended to
22 read as follows:

23 (1) When a proper child in need of services petition to approve an
24 out-of-home placement is filed under RCW 13.32A.120, 13.32A.140, or
25 13.32A.150 the juvenile court shall: (a)(i) Schedule a fact-finding
26 hearing to be held: (A) For a child who resides in a place other than
27 his or her parent's home and other than an out-of-home placement,
28 within five calendar days unless the last calendar day is a Saturday,
29 Sunday, or holiday, in which case the hearing shall be held on the
30 preceding judicial day; or (B) for a child living at home or in an out-
31 of-home placement, within ten days; and (ii) notify the parent, child,
32 and the department of such date; (b) notify the parent of the right to
33 be represented by counsel and, if indigent, to have counsel appointed
34 for him or her by the court; (c) appoint legal counsel for the child;
35 (d) inform the child and his or her parent of the legal consequences of
36 the court approving or disapproving a child in need of services
37 petition; (e) notify the parents of their rights under this chapter and
38 chapters 11.88, 13.34, 70.96A, and 71.34 RCW, including the right to

1 file a motion requesting that the court convert the petition to an at-
2 risk youth petition, the right to submit an application for admission
3 of their child to a treatment facility for alcohol, chemical
4 dependency, or mental health treatment, and the right to file a
5 guardianship petition; and (f) notify all parties, including the
6 department, of their right to present evidence at the fact-finding
7 hearing.

8 (2) Upon filing of a child in need of services petition, the child
9 may be placed, if not already placed, by the department in a crisis
10 residential center, foster family home, group home facility licensed
11 under chapter 74.15 RCW, or any other suitable residence other than a
12 HOPE center to be determined by the department. The court may place a
13 child in a crisis residential center for a temporary out-of-home
14 placement as long as the requirements of RCW 13.32A.125 are met.

15 (3) If the child has been placed in a foster family home or group
16 care facility under chapter 74.15 RCW, the child shall remain there, or
17 in any other suitable residence as determined by the department,
18 pending resolution of the petition by the court. Any placement may be
19 reviewed by the court within three judicial days upon the request of
20 the juvenile or the juvenile's parent.

21 **Sec. 3.** RCW 13.32A.170 and 2000 c 123 s 20 are each amended to
22 read as follows:

23 (1) The court shall hold a fact-finding hearing to consider a
24 proper child in need of services petition, giving due weight to the
25 intent of the legislature that families have the right to place
26 reasonable restrictions and rules upon their children, appropriate to
27 the individual child's developmental level. The court may appoint
28 legal counsel and/or a guardian ad litem to represent the child and
29 advise parents of their right to be represented by legal counsel. At
30 the commencement of the hearing, the court shall advise the parents of
31 their rights as set forth in RCW 13.32A.160(1). If the court approves
32 or denies a child in need of services petition, a written statement of
33 the reasons must be filed.

34 (2) The court may approve an order stating that the child shall be
35 placed in a residence other than the home of his or her parent only if
36 it is established by a preponderance of the evidence, including a
37 departmental recommendation for approval or dismissal of the petition,
38 that:

1 (a) The child is a child in need of services as defined in RCW
2 13.32A.030(5);

3 (b) If the petitioner is a child, he or she has made a reasonable
4 effort to resolve the conflict;

5 (c) Reasonable efforts have been made to prevent or eliminate the
6 need for removal of the child from the child's home and to make it
7 possible for the child to return home; and

8 (d) A suitable out-of-home placement resource is available.

9 The court may not grant a petition filed by the child or the
10 department if it is established that the petition is based only upon a
11 dislike of reasonable rules or reasonable discipline established by the
12 parent.

13 The court may not grant the petition if the child is the subject of
14 a proceeding under chapter 13.34 RCW.

15 (3) Following the fact-finding hearing the court shall: (a)
16 Approve a child in need of services petition and, if appropriate, enter
17 a temporary out-of-home placement for a period not to exceed fourteen
18 days pending approval of a disposition decision to be made under RCW
19 13.32A.179(2); (b) approve the parent's motion to convert the petition
20 to an at-risk youth petition ((filed by the parents and dismiss the
21 child in need of services petition)) and approve the at-risk youth
22 petition; or (c) dismiss the petition.

23 At any time the court may order the department to review the case
24 to determine whether the case is appropriate for a dependency petition
25 under chapter 13.34 RCW.

26 **Sec. 4.** RCW 13.32A.179 and 2000 c 123 s 21 are each amended to
27 read as follows:

28 (1) A disposition hearing shall be held no later than fourteen days
29 after the approval of the temporary out-of-home placement. The
30 parents, child, and department shall be notified by the court of the
31 time and place of the hearing.

32 (2) At the conclusion of the disposition hearing, the court may:
33 (a) Reunite the family and dismiss the petition; (b) approve the
34 parent's motion to convert the petition to an at-risk youth petition
35 ((filed by the parents and dismiss the child in need of services
36 petition)) and approve the at-risk youth petition; (c) approve an out-
37 of-home placement requested in the child in need of services petition

1 by the parents; or (d) order an out-of-home placement at the request of
2 the child or the department not to exceed ninety days.

3 At any time the court may order the department to review the matter
4 for purposes of filing a dependency petition under chapter 13.34 RCW.
5 Whether or not the court approves or orders an out-of-home placement,
6 the court may also order any conditions of supervision as set forth in
7 RCW 13.32A.196(3).

8 (3) The court may only enter an order under subsection (2)(d) of
9 this section if it finds by clear, cogent, and convincing evidence
10 that: (a)(i) The order is in the best interest of the family; (ii) the
11 parents have not requested an out-of-home placement; (iii) the parents
12 have not exercised any other right listed in RCW 13.32A.160(1)(e); (iv)
13 the child has made reasonable efforts to resolve the problems that led
14 to the filing of the petition; (v) the problems cannot be resolved by
15 delivery of services to the family during continued placement of the
16 child in the parental home; (vi) reasonable efforts have been made to
17 prevent or eliminate the need for removal of the child from the child's
18 home and to make it possible for the child to return home; and (vii) a
19 suitable out-of-home placement resource is available; (b)(i) the order
20 is in the best interest of the child; and (ii) the parents are
21 unavailable; or (c) the parent's actions cause an imminent threat to
22 the child's health or safety.

23 (4) The court may order the department to submit a dispositional
24 plan if such a plan would assist the court in ordering a suitable
25 disposition in the case. The plan, if ordered, shall address the needs
26 of the child, and the perceived needs of the parents if the order was
27 entered under subsection (2)(d) of this section or if specifically
28 agreed to by the parents. If the parents do not agree or the order was
29 not entered under subsection (2)(d) of this section the plan may only
30 make recommendations regarding services in which the parents may
31 voluntarily participate. If the court orders the department to prepare
32 a plan, the department shall provide copies of the plan to the parent,
33 the child, and the court. If the parties or the court desire the
34 department to be involved in any future proceedings or case plan
35 development, the department shall be provided with timely notification
36 of all court hearings.

37 (5) Prior to disposition, or at any time thereafter, subject to
38 available resources, the court may order that a risk and needs
39 assessment of the child be conducted.

1 (6) A child who fails to comply with a court order issued under
2 this section shall be subject to contempt proceedings, as provided in
3 this chapter, but only if the noncompliance occurs within one year
4 after the entry of the order.

5 ~~((+6+))~~ (7) After the court approves or orders an out-of-home
6 placement, the parents or the department may request, and the court may
7 grant, dismissal of the child in need of services proceeding when it is
8 not feasible for the department to provide services due to one or more
9 of the following circumstances:

10 (a) The child has been absent from court approved placement for
11 thirty consecutive days or more;

12 (b) The parents or the child, or all of them, refuse to cooperate
13 in available, appropriate intervention aimed at reunifying the family;
14 or

15 (c) The department has exhausted all available and appropriate
16 resources that would result in reunification.

17 ~~((+7+))~~ (8) The court shall dismiss a placement made under
18 subsection (2)(c) of this section upon the request of the parents.

19 **Sec. 5.** RCW 13.32A.190 and 1996 c 133 s 25 are each amended to
20 read as follows:

21 (1) Upon making a dispositional order under RCW 13.32A.179, the
22 court shall schedule the matter on the calendar for review within three
23 months, advise the parties of the date thereof, appoint legal counsel
24 and/or a guardian ad litem to represent the child at the review
25 hearing, advise parents of their right to be represented by legal
26 counsel at the review hearing, and notify the parties of their rights
27 to present evidence at the hearing. Where resources are available, the
28 court shall encourage the parent and child to participate in programs
29 for reconciliation of their conflict.

30 (2) At the review hearing, the court shall approve or disapprove
31 the continuation of the dispositional plan in accordance with this
32 chapter. The court shall determine whether reasonable efforts have
33 been made to reunify the family and make it possible for the child to
34 return home. The court shall discontinue the placement and order that
35 the child return home if the court has reasonable grounds to believe
36 that the parents have made reasonable efforts to resolve the conflict
37 and the court has reason to believe that the child's refusal to return

1 home is capricious. If out-of-home placement is continued, the court
2 may modify the dispositional plan.

3 (3) At its discretion, the court may hold a hearing to review a
4 child in need of services matter at any time throughout the duration of
5 the proceeding.

6 (4) Out-of-home placement may not be continued past one hundred
7 eighty days from the day the review hearing commenced. The court shall
8 order the child to return to the home of the parent at the expiration
9 of the placement. If an out-of-home placement is disapproved prior to
10 one hundred eighty days, the court shall enter an order requiring the
11 child to return to the home of the child's parent.

12 ((+4)) (5) The parents and the department may request, and the
13 juvenile court may grant, dismissal of an out-of-home placement order
14 when it is not feasible for the department to provide services due to
15 one or more of the following circumstances:

16 (a) The child has been absent from court approved placement for
17 thirty consecutive days or more;

18 (b) The parents or the child, or all of them, refuse to cooperate
19 in available, appropriate intervention aimed at reunifying the family;
20 or

21 (c) The department has exhausted all available and appropriate
22 resources that would result in reunification.

23 ((+5)) (6) The court shall terminate a placement made under this
24 section upon the request of a parent unless the placement is made
25 pursuant to RCW 13.32A.179(3).

26 ((+6)) (7) The court may dismiss a child in need of services
27 petition filed by a parent at any time if the court finds good cause to
28 believe that continuation of out-of-home placement would serve no
29 useful purpose.

30 ((+7)) (8) The court shall dismiss a child in need of services
31 proceeding if the child is the subject of a proceeding under chapter
32 13.34 RCW.

33 **Sec. 6.** RCW 13.32A.196 and 2000 c 123 s 24 are each amended to
34 read as follows:

35 (1) A dispositional hearing shall be held no later than fourteen
36 days after the fact-finding hearing. Each party shall be notified of
37 the time and date of the hearing.

1 (2) At the dispositional hearing regarding an adjudicated at-risk
2 youth, the court shall consider the recommendations of the parties and
3 the recommendations of any dispositional plan submitted by the
4 department. The court may enter a dispositional order that will assist
5 the parent in maintaining the care, custody, and control of the child
6 and assist the family to resolve family conflicts or problems.

7 (3) The court may set conditions of supervision for the child that
8 include:

9 (a) Regular school attendance;

10 (b) Counseling;

11 (c) Participation in a substance abuse or mental health outpatient
12 treatment program;

13 (d) Reporting on a regular basis to the department or any other
14 designated person or agency; and

15 (e) Any other condition the court deems an appropriate condition of
16 supervision including but not limited to: Employment, participation in
17 an anger management program, and refraining from using alcohol or
18 drugs.

19 (4) No dispositional order or condition of supervision ordered by
20 a court pursuant to this section shall include involuntary commitment
21 of a child for substance abuse or mental health treatment.

22 (5) The court may order the parent to participate in counseling
23 services or any other services for the child requiring parental
24 participation. The parent shall cooperate with the court-ordered case
25 plan and shall take necessary steps to help implement the case plan.
26 The parent shall be financially responsible for costs related to the
27 court-ordered plan; however, this requirement shall not affect the
28 eligibility of the parent or child for public assistance or other
29 benefits to which the parent or child may otherwise be entitled.

30 (6) The parent may request dismissal of an at-risk youth proceeding
31 or out-of-home placement at any time. Upon such a request, the court
32 shall dismiss the matter and cease court supervision of the child
33 unless: (a) A contempt action is pending in the case; (b) a petition
34 has been filed under RCW 13.32A.150 and a hearing has not yet been held
35 under RCW 13.32A.179; or (c) an order has been entered under RCW
36 13.32A.179(3) and the court retains jurisdiction under that subsection.
37 The court may retain jurisdiction over the matter for the purpose of
38 concluding any pending contempt proceedings, including the full

1 satisfaction of any penalties imposed as a result of a contempt
2 finding.

3 (7) An at-risk youth proceeding converted from a truancy proceeding
4 under chapter 28A.225 RCW shall revert to being a truancy proceeding
5 under chapter 28A.225 RCW if, pursuant to this section, the at-risk
6 youth petition is dismissed.

7 (8) The court may order the department to monitor compliance with
8 the dispositional order, assist in coordinating the provision of court-
9 ordered services, and submit reports at subsequent review hearings
10 regarding the status of the case.

11 (9) Prior to disposition, or at any time thereafter, subject to
12 available resources, the court may order that a risk and needs
13 assessment of the child be conducted.

14 **Sec. 7.** RCW 13.32A.198 and 1990 c 276 s 15 are each amended to
15 read as follows:

16 (1) Upon making a disposition regarding an adjudicated at-risk
17 youth, the court shall schedule the matter on the calendar for review
18 within three months, advise the parties of the date thereof, appoint
19 legal counsel for the child, advise the parent of the right to be
20 represented by legal counsel at the review hearing at the parent's own
21 expense, and notify the parties of their rights to present evidence at
22 the hearing.

23 (2) At the review hearing, the court shall approve or disapprove
24 the continuation of court supervision in accordance with the goal of
25 assisting the parent to maintain the care, custody, and control of the
26 child. The court shall determine whether the parent and child are
27 complying with the dispositional plan. If court supervision is
28 continued, the court may modify the dispositional plan.

29 (3) At its discretion, the court may hold a hearing to review an
30 at-risk youth matter at any time throughout the duration of the
31 proceeding.

32 (4) Court supervision of the child may not be continued past one
33 hundred eighty days from the day the review hearing commenced unless
34 the court finds, and the parent agrees, that there are compelling
35 reasons for an extension of supervision. Any extension granted
36 pursuant to this subsection shall not exceed ninety days.

37 ~~((+4))~~ (5) The court may dismiss an at-risk youth proceeding at
38 any time if the court finds good cause to believe that continuation of

1 court supervision would serve no useful purpose or that the parent is
2 not cooperating with the court-ordered case plan. The court shall
3 dismiss an at-risk youth proceeding if the child is the subject of a
4 proceeding under chapter 13.34 RCW.

5 (6) An at-risk youth proceeding converted from a truancy proceeding
6 under chapter 28A.225 RCW shall revert to being a truancy proceeding
7 under chapter 28A.225 RCW if, pursuant to this section, the at-risk
8 youth petition is dismissed.

9 **Sec. 8.** RCW 28A.225.035 and 1999 c 319 s 3 are each amended to
10 read as follows:

11 (1) A petition for a civil action under RCW 28A.225.030 or
12 28A.225.015 shall consist of a written notification to the court
13 alleging that:

14 (a) The child has unexcused absences during the current school
15 year;

16 (b) Actions taken by the school district have not been successful
17 in substantially reducing the child's absences from school; and

18 (c) Court intervention and supervision are necessary to assist the
19 school district or parent to reduce the child's absences from school.

20 (2) The petition shall set forth the name, age, school, and
21 residence of the child and the names and residence of the child's
22 parents.

23 (3) The petition shall set forth facts that support the allegations
24 in this section and shall generally request relief available under this
25 chapter and provide information about what the court might order under
26 RCW 28A.225.090.

27 (4) When a petition is filed under RCW 28A.225.030 or 28A.225.015,
28 the juvenile court shall schedule a hearing at which the court shall
29 consider the petition, or if the court determines that a referral to an
30 available community truancy board would substantially reduce the
31 child's unexcused absences, the court may refer the case to a community
32 truancy board under the jurisdiction of the juvenile court.

33 (5) If a referral is made to a community truancy board, the truancy
34 board must meet with the child, a parent, and the school district
35 representative and enter into an agreement with the petitioner and
36 respondent regarding expectations and any actions necessary to address
37 the child's truancy within thirty days of the referral. If the
38 petition is based on RCW 28A.225.015, the child shall not be required

1 to attend and the agreement under this subsection shall be between the
2 truancy board, the school district, and the child's parent. The
3 agreement shall be presented to the juvenile court for its approval.

4 (6) The court shall approve the agreement by order or schedule a
5 hearing. The court may, if the school district and community truancy
6 board agree, permit the truancy board to provide continued supervision
7 over the student, or parent if the petition is based on RCW
8 28A.225.015, and report on compliance with the order.

9 (7) If the truancy board fails to reach an agreement, the truancy
10 board shall return the case to the juvenile court for a hearing.

11 (8) Notwithstanding the provisions in subsection (4) of this
12 section, a hearing shall not be required if other actions by the court
13 would substantially reduce the child's unexcused absences. When a
14 juvenile court hearing is held, the court shall:

15 (a) Separately notify the child, the parent of the child, and the
16 school district of the hearing;

17 (b) Notify the parent and the child of their rights to present
18 evidence at the hearing; and

19 (c) Notify the parent and the child of the options and rights
20 available under chapter 13.32A RCW.

21 (9) The court may require the attendance of the child if eight
22 years old or older, the parents, and the school district at any hearing
23 on a petition filed under RCW 28A.225.030.

24 (10) A school district is responsible for determining who shall
25 represent the school district at hearings on a petition filed under RCW
26 28A.225.030 or 28A.225.015.

27 (11) The court may permit the first hearing to be held without
28 requiring that either party be represented by legal counsel, and to be
29 held without a guardian ad litem for the child under RCW 4.08.050. At
30 the request of the school district, the court shall permit a school
31 district representative who is not an attorney to represent the school
32 district at any future hearings.

33 (12) If the allegations in the petition are established by a
34 preponderance of the evidence, the court shall grant the petition and
35 enter an order assuming jurisdiction to intervene for the period of
36 time determined by the court, after considering the facts alleged in
37 the petition and the circumstances of the juvenile, to most likely
38 cause the juvenile to return to and remain in school while the juvenile
