- 1 AN ACT Relating to salary bonuses for teachers attaining

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds and declares:
- 7 (1) The national board for professional teaching standards has
- 8 established high and rigorous standards for what highly accomplished
- 9 teachers should know and be able to do in order to increase student
- 10 learning results;
- 11 (2) The national board certifies teachers who meet these standards
- 12 through a rigorous, performance-based assessment process;
- 13 (3) A certificate awarded by the national board attests that a
- 14 teacher has met high and rigorous standards and has demonstrated the
- 15 ability to make sound professional judgments about how to best meet
- 16 students' learning needs and effectively help students meet challenging
- 17 academic standards;

- 1 (4) Teachers who attain national board certification should be 2 acknowledged and rewarded in order to encourage more teachers to pursue 3 certification for the benefit of Washington students.
- 4 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 28A.405 5 RCW to read as follows:
- In addition to the compensation received under the salary schedule 6 7 adopted in accordance with RCW 28A.405.200, teachers who have attained certification by the national board for professional teaching standards 8 9 shall receive an annual fifteen percent salary bonus for the duration national board for professional teaching 10 The fifteen percent bonus shall be calculated as 11 certification. Multiply the school district's derived base salary for 12 follows: certificated instructional staff by the national board certified 13 14 teacher's staff mix factor, and multiply that amount by fifteen percent. The school district's derived base salary shall be determined 15 by using the LEAP document for base salaries cited 16 appropriations act. The national board certified teacher's staff mix 17 18 factor shall be determined by using the LEAP document for staff mix 19 factors cited in the appropriations act.
- NEW SECTION. Sec. 3. If specific funding for the purposes of this act, referencing this act by bill or chapter number, is not provided by June 30, 2001, in the omnibus appropriations act, this act is null and void.
