- 1 AN ACT Relating to the timeline for submission of a redistricting
- 2 plan by the redistricting commission; amending RCW 44.05.100; creating
- 3 a new section; and declaring an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 44.05.100 and 1995 c 88 s 1 are each amended to read 6 as follows:
- 7 (1) Upon approval of a redistricting plan by three of the voting
- 8 members of the commission, but not later than ((December 15th)) January
- 9 <u>1st</u> of the year ending in ((one)) two, the commission shall submit the
- 10 plan to the legislature.
- 11 (2) After submission of the plan by the commission, the legislature
- 12 shall have the next thirty days during any regular or special session
- 13 to amend the commission's plan. If the legislature amends the
- 14 commission's plan the legislature's amendment must be approved by an
- 15 affirmative vote in each house of two-thirds of the members elected or
- 16 appointed thereto, and may not include more than two percent of the

- amendment or after expiration of the time provided for legislative 1 amendment by subsection (2) of this section whichever occurs first, and 2 shall constitute the districting law applicable to this state for 3 4 legislative and congressional elections, beginning with the next elections held in the year ending in two. This plan shall be in force 5 until the effective date of the plan based upon the next succeeding 6 7 federal decennial census or until a modified plan takes effect as 8 provided in RCW 44.05.120(6).
- (4) If three of the voting members of the commission fail to 9 approve and submit a plan within the time limitations provided in 10 subsection (1) of this section, the supreme court shall adopt a plan by 11 March 1st of the year ending in two. Any such plan approved by the 12 court is final and constitutes the districting law applicable to this 13 state for legislative and congressional elections, beginning with the 14 15 next election held in the year ending in two. This plan shall be in force until the effective date of the plan based on the next succeeding 16 federal decennial census or until a modified plan takes effect as 17 provided in RCW 44.05.120(6). 18
- NEW SECTION. Sec. 2. This act is remedial and curative in nature and applies retroactively to any plan or portion of a plan submitted to the legislature by the redistricting commission established in 2001.
- NEW SECTION. Sec. 3. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect immediately.
