- 1 AN ACT Relating to residency status for purposes of tuition at
- 2 institutions of higher education; amending RCW 28B.15.012; and
- 3 providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 28B.15.012 and 2000 c 117 s 2 are each amended to read 6 as follows:
- 7 Whenever used in chapter 28B.15 RCW:
- 8 (1) The term "institution" shall mean a public university, college,
- 9 or community college within the state of Washington.
- 10 (2) The term "resident student" shall mean:
- 11 (a) A financially independent student who has had a domicile in the
- 12 state of Washington for the period of one year immediately prior to the
- 13 time of commencement of the first day of the semester or quarter for
- 14 which the student has registered at any institution and has in fact
- 15 established a bona fide domicile in this state primarily for purposes
- 16 other than educational;
- 17 (b) A dependent student, if one or both of the student's parents or
- 18 legal guardians have maintained a bona fide domicile in the state of
- 19 Washington for at least one year immediately prior to commencement of

- 1 the semester or quarter for which the student has registered at any 2 institution;
- 3 (c) A student classified as a resident based upon domicile by an 4 institution on or before May 31, 1982, who was enrolled at a state 5 institution during any term of the 1982-1983 academic year, so long as 6 such student's enrollment (excepting summer sessions) at an institution 7 in this state is continuous;
- 8 (d) Any student who has spent at least seventy-five percent of both 9 his or her junior and senior years in high schools in this state, whose 10 parents or legal guardians have been domiciled in the state for a period of at least one year within the five-year period before the 11 student graduates from high school, and who enrolls in a public 12 13 institution of higher education within six months of leaving high school, for as long as the student remains continuously enrolled for 14 15 three quarters or two semesters in any calendar year;
- 16 (e) A student who is on active military duty stationed in the 17 state;
- 18 (f) A student who is the spouse or a dependent of a person who is 19 on active military duty stationed in the state;
- (g) A student of an out-of-state institution of higher education who is attending a Washington state institution of higher education pursuant to a home tuition agreement as described in RCW 28B.15.725; ((or))
  - (h) A student who resided with his or her parent, guardian, or conservator while attending a public or approved private high school in this state, graduated from a public or approved private high school or received the equivalent of a high school diploma in this state, resided in this state for at least five years as of the date the student graduated from high school or received the equivalent of a high school diploma, registers as an entering student in an institution of higher education not earlier than the 2002 fall semester, and provides to the institution an affidavit stating that the individual will file an application to become a permanent resident at the earliest opportunity the individual is eligible to do so; or
  - (i) A student who meets the requirements of RCW 28B.15.0131: PROVIDED, That a nonresident student enrolled for more than six hours per semester or quarter shall be considered as attending for primarily educational purposes, and for tuition and fee paying purposes only such period of enrollment shall not be counted toward the establishment of

- a bona fide domicile of one year in this state unless such student proves that the student has in fact established a bona fide domicile in this state primarily for purposes other than educational.
- 4 (3) The term "nonresident student" shall mean any student who does 5 not qualify as a "resident student" under the provisions of RCW 6 28B.15.012 and 28B.15.013. Except for students qualifying under 7 subsection (2)(g) or (h) of this section, a nonresident student shall 8 include:
- 9 (a) A student attending an institution with the aid of financial 10 assistance provided by another state or governmental unit or agency 11 thereof, such nonresidency continuing for one year after the completion 12 of such semester or quarter.

- (b) A person who is not a citizen of the United States of America who does not have permanent or temporary resident status or does not hold "Refugee-Parolee" or "Conditional Entrant" status with the United States immigration and naturalization service or is not otherwise permanently residing in the United States under color of law and who does not also meet and comply with all the applicable requirements in RCW 28B.15.012 and 28B.15.013.
- 20 (4) The term "domicile" shall denote a person's true, fixed and 21 permanent home and place of habitation. It is the place where the 22 student intends to remain, and to which the student expects to return 23 when the student leaves without intending to establish a new domicile 24 elsewhere. The burden of proof that a student, parent or guardian has 25 established a domicile in the state of Washington primarily for 26 purposes other than educational lies with the student.
  - (5) The term "dependent" shall mean a person who is not financially independent. Factors to be considered in determining whether a person is financially independent shall be set forth in rules and regulations adopted by the higher education coordinating board and shall include, but not be limited to, the state and federal income tax returns of the person and/or the student's parents or legal guardian filed for the calendar year prior to the year in which application is made and such other evidence as the board may require.
- 35 NEW SECTION. Sec. 2. This act takes effect June 30, 2002.
