

1 hearings to deal with the complaint or belief. The investigation and
2 initial proceedings shall be confidential. Upon beginning an initial
3 proceeding, the commission shall notify the judge or justice of the
4 existence of and basis for the initial proceeding.

5 (3) Whenever the commission concludes, based on an initial
6 proceeding, that there is probable cause to believe that a judge or
7 justice has violated a rule of judicial conduct or that the judge or
8 justice suffers from a disability which is permanent or likely to
9 become permanent and which seriously interferes with the performance of
10 judicial duties, the commission shall conduct a public hearing or
11 hearings and shall make public all those records of the initial
12 proceeding that provide the basis for its conclusion. If the
13 commission concludes that there is not probable cause, it shall notify
14 the judge or justice of its conclusion.

15 (4) Upon the completion of the hearing or hearings, the commission
16 in open session shall either dismiss the case, or shall admonish,
17 reprimand, or censure the judge or justice, or shall censure the judge
18 or justice and recommend to the supreme court the suspension or removal
19 of the judge or justice, or shall recommend to the supreme court the
20 retirement of the judge or justice. The commission may not recommend
21 suspension or removal unless it censures the judge or justice for the
22 violation serving as the basis for the recommendation. The commission
23 may recommend retirement of a judge or justice for a disability which
24 is permanent or likely to become permanent and which seriously
25 interferes with the performance of judicial duties.

26 (5) Upon the recommendation of the commission, the supreme court
27 may suspend, remove, or retire a judge or justice. The office of a
28 judge or justice retired or removed by the supreme court becomes
29 vacant, and that person is ineligible for judicial office until
30 eligibility is reinstated by the supreme court. The salary of a
31 removed judge or justice shall cease. The supreme court shall specify
32 the effect upon salary when it suspends a judge or justice. The
33 supreme court may not suspend, remove, or retire a judge or justice
34 until the commission, after notice and hearing, recommends that action
35 be taken, and the supreme court conducts a hearing, after notice, to
36 review commission proceedings and findings against the judge or
37 justice.

1 (6) Within thirty days after the commission admonishes, reprimands,
2 or censures a judge or justice, the judge or justice shall have a right
3 of appeal de novo to the supreme court.

4 (7) Any matter before the commission or supreme court may be
5 disposed of by a stipulation entered into in a public proceeding. The
6 stipulation shall be signed by the judge or justice and the commission
7 or court. The stipulation may impose any terms and conditions deemed
8 appropriate by the commission or court. A stipulation shall set forth
9 all material facts relating to the proceeding and the conduct of the
10 judge or justice.

11 (8) Whenever the commission adopts a recommendation that a judge or
12 justice be removed, the judge or justice shall be suspended
13 immediately, with salary, from his or her judicial position until a
14 final determination is made by the supreme court.

15 (9) The legislature shall provide for commissioners' terms of
16 office and compensation. The commission shall employ one or more
17 investigative officers with appropriate professional training and
18 experience. The investigative officers of the commission shall report
19 directly to the commission. The commission shall also employ such
20 administrative or other staff as are necessary to manage the affairs of
21 the commission.

22 (10) The commission shall, to the extent that compliance does not
23 conflict with this section, comply with laws of general applicability
24 to state agencies with respect to rule-making procedures, and with
25 respect to public notice of and attendance at commission proceedings
26 other than initial proceedings. The commission shall establish rules
27 of procedure for commission proceedings including due process and
28 confidentiality of proceedings.

29 BE IT FURTHER RESOLVED, That the secretary of state shall cause
30 notice of this constitutional amendment to be published at least four
31 times during the four weeks next preceding the election in every legal
32 newspaper in the state.
