- 1 AN ACT Relating to the municipal research council; amending RCW
- 2 43.110.010; providing an effective date; and declaring an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 43.110.010 and 1997 c 437 s 1 are each amended to read 5 as follows:
- 6 There shall be a state agency which shall be known as the municipal
- 7 research council. The council shall be composed of ((twenty-three))
- 8 <u>fourteen</u> members. ((Four)) <u>Two</u> members shall be appointed by the
- 9 president of the senate, with equal representation from each of the two
- 10 major political parties; ((four)) two members shall be appointed by the
- 11 speaker of the house of representatives, with equal representation from
- 12 each of the two major political parties; one member shall be
- 13 ((appointed by the governor independently)) the director of community,
- 14 trade, and economic development; ((nine)) six members, who shall be
- 15 city or town officials, shall be appointed by the governor from a list
- 16 of ((nine)) six nominees submitted by the board of directors of the
- 17 association of Washington cities; and ((five)) three members, who shall
- 18 be county officials, shall be appointed by the governor, ((two)) one of
- 19 whom shall be ((from a list of two nominees)) a nominee submitted by

- 1 the board of directors of the Washington association of county
- 2 officials, and ((three)) two of whom shall be from a list of ((three))
- 3 $\underline{\text{two}}$ nominees submitted by the board of directors of the Washington
- 4 state association of counties. Of the city or town officials, at least
- 5 one shall be an official of a city having a population of twenty
- 6 thousand or more; at least one shall be an official of a city having a
- 7 population of one thousand five hundred to twenty thousand; and at
- 8 least one shall be an official of a town having a population of less
- 9 than one thousand five hundred.
- 10 The terms of members shall be for two years. The terms of those
- 11 members who are appointed as legislators or city, town, or county
- 12 officials shall be dependent upon continuance in legislative, city,
- 13 town, or county office. The terms of all members except legislative
- 14 members shall commence on the first day of August in every odd-numbered
- 15 year. The speaker of the house of representatives and the president of
- 16 the senate shall make their appointments on or before the third Monday
- 17 in January in each odd-numbered year, and the terms of the members thus
- 18 appointed shall commence on the third Monday of January in each odd-
- 19 numbered year.
- 20 Council members shall receive no compensation but shall be
- 21 reimbursed for travel expenses at rates in accordance with RCW
- 22 43.03.050 and 43.03.060 as now existing or hereafter amended, except
- 23 that members of the council who are also members of the legislature
- 24 shall be reimbursed at the rates provided by RCW 44.04.120.
- 25 <u>NEW SECTION.</u> **Sec. 2.** This act is necessary for the immediate
- 26 preservation of the public peace, health, or safety, or support of the
- 27 state government and its existing public institutions, and takes effect
- 28 July 1, 2001.
