1 Strike everything after the enacting clause and insert the
2 following:

3 "Sec. 1. RCW 46.09.280 and 1986 c 206 s 13 are each amended to
4 read as follows:

5 The interagency committee for outdoor recreation shall establish
6 (~~a committee of nonhighway road recreationists, including~~
7 ~~representatives of organized ORV groups,~~) the nonhighway and off-road
8 vehicle advisory committee to provide advice regarding the
9 administration of this chapter. The nonhighway and off-road vehicle
10 advisory committee consists of a proportional representation of persons
11 with recreational experience in areas identified in the most recent
12 fuel use study, including but not limited to people with off-road
13 vehicle, hiking, equestrian, mountain biking, hunting, fishing, and
14 wildlife viewing experience. Only representatives of organized ORV
15 groups may be voting members of the committee with respect to
16 expenditure of funds received under RCW 46.09.110.

17 NEW SECTION. **Sec. 2.** The nonhighway and off-road vehicle advisory
18 committee created in RCW 46.09.280 must review the existing nonhighway
19 and off-road vehicle distribution formulas and policies in RCW
20 46.09.020, 46.09.170, and 46.09.280 and develop recommendations for
21 statutory changes. The recommendations should be consistent with the
22 results of the most recent fuel use study, and address the operation
23 and maintenance needs of existing facilities. For the review in this
24 section, the committee must also include representation of county
25 sheriffs, recreational land managers, the state parks and recreation
26 commission, the department of fish and wildlife, and the department of
27 natural resources, and two members of the senate appointed by the
28 president of the senate, to include one member from each major caucus,
29 and two members of the house of representatives appointed by the

1 speaker of the house of representatives, to include one member from
2 each major caucus. In the senate, members must be selected from the
3 parks, fish and wildlife committee and ways and means committee. In
4 the house of representatives, members must be selected from the
5 fisheries, ecology and parks committee and either the appropriations or
6 capital budget committee. Recommendations must be submitted to the
7 appropriate standing committees of the legislature by January 1, 2004."

8 On page 1, line 1 of the title, after "programs;" strike the
9 remainder of the title and insert "amending RCW 46.09.280; and creating
10 a new section."

EFFECT: The nonhighway and off-road vehicle advisory committee is created. The committee must make recommendations to the Legislature by January 1, 2004, on future distribution of off-road vehicle and nonhighway funds.
