On page 1, line 1 of the title, after "sharing;" strike the remainder of the title and insert "amending RCW 41.04.655, 41.04.660, and 41.04.665; and declaring an emergency."

EFFECT: Clarifies that annual leave, sick leave, and personal holidays may be transferred to an employee who is absent due to illness once his or her own annual leave and sick leave are depleted, or to an employee who is absent due to military service once his or her own annual leave and paid military leave are depleted. Adds an emergency clause.
