2 following:

3 "PART I - UNEMPLOYMENT COMPENSATION BENEFITS

4 **Sec. 1.** RCW 50.04.030 and 1991 c 117 s 1 are each amended to read
5 as follows:

6 (1) "Benefit year" with respect to each individual, means the
7 fifty-two consecutive week period beginning with the first day of the
8 calendar week in which the individual files an application for an
9 initial determination and thereafter the fifty-two consecutive week
10 period beginning with the first day of the calendar week in which the
11 individual next files an application for an initial determination after
12 the expiration of the individual's last preceding benefit year:
13 PROVIDED, HOWEVER, That the foregoing limitation shall not be deemed to
14 preclude the establishment of a new benefit year under the laws of
15 another state pursuant to any agreement providing for the interstate
16 combining of employment and wages and the interstate payment of
17 benefits nor shall this limitation be deemed to preclude the
18 commissioner from backdating an initial application at the request of
19 the claimant either for the convenience of the department of employment
20 security or for any other reason deemed by the commissioner to be good
21 cause.

22 (2) An individual's benefit year shall be extended to be fifty-
23 three weeks when at the expiration of fifty-two weeks the establishment
24 of a new benefit year would result in the use of a quarter of wages in
25 the new base year that had been included in the individual's prior base
26 year.

27 (3)(a) No benefit year will be established unless it is determined
28 that:

1 (i) The individual earned wages in "employment" in not less than
2 six hundred eighty hours of the individual's base year(~~(:—PROVIDED,~~
3 ~~HOWEVER, That))~~); or

4 (ii) Beginning with claims that have an effective date on or after
5 January 4, 2004, the individual earned wages in "employment" in not
6 less than six hundred eighty hours of the individual's base year and
7 also earned wages in "employment" in at least two quarters of the
8 individual's base year. If sections 9 and 10 of this act are not
9 enacted by July 1, 2003, this subsection (3)(a)(ii) is null and void.

10 (b) A benefit year (~~cannot~~) may not be established if the base
11 year wages include wages earned prior to the establishment of a prior
12 benefit year unless the individual worked and earned wages since the
13 last separation from employment immediately before the application for
14 initial determination in the previous benefit year if the applicant was
15 an unemployed individual at the time of application, or since the
16 initial separation in the previous benefit year if the applicant was
17 not an unemployed individual at the time of filing an application for
18 initial determination for the previous benefit year, of not less than
19 six times the weekly benefit amount computed for the individual's new
20 benefit year.

21 (c) If an individual's prior benefit year was based on the last
22 four completed calendar quarters, a new benefit year shall not be
23 established until the new base year does not include any hours used in
24 the establishment of the prior benefit year.

25 (4) If the wages of an individual are not based upon a fixed
26 duration of time or if the individual's wages are paid at irregular
27 intervals or in such manner as not to extend regularly over the period
28 of employment, the wages for any week shall be determined in such
29 manner as the commissioner may by regulation prescribe. Such
30 regulation shall, so far as possible, secure results reasonably similar
31 to those which would prevail if the individual were paid his or her
32 wages at regular intervals.

33 **Sec. 2.** RCW 50.20.120 and 2002 c 149 s 4 are each amended to read
34 as follows:

35 (1)(a) Subject to the other provisions of this title, benefits
36 shall be payable to any eligible individual during the individual's

1 benefit year in a maximum amount equal to the lesser of thirty times
2 the weekly benefit amount (~~((determined hereinafter))~~), as determined
3 in subsection (2) of this section, or one-third of the individual's
4 base year wages under this title: PROVIDED, That as to any week
5 (~~((beginning on and after March 31, 1981,))~~) which falls in an extended
6 benefit period as defined in RCW 50.22.010(1), (~~((as now or hereafter~~
7 ~~amended,))~~) an individual's eligibility for maximum benefits in excess
8 of twenty-six times his or her weekly benefit amount will be subject to
9 the terms and conditions set forth in RCW 50.22.020(~~((, as now or~~
10 ~~hereafter amended))~~).

11 (b) With respect to claims that have an effective date on or after
12 January 4, 2004, benefits shall be payable to any eligible individual
13 during the individual's benefit year in a maximum amount equal to the
14 lesser of twenty-six times the weekly benefit amount, as determined in
15 subsection (2) of this section, or one-third of the individual's base
16 year wages under this title. If sections 9 and 10 of this act are not
17 enacted by July 1, 2003, this subsection (1)(b) is null and void.

18 (2)(a) An individual's weekly benefit amount shall be an amount
19 equal to one twenty-fifth of the average quarterly wages of the
20 individual's total wages during the two quarters of the individual's
21 base year in which such total wages were highest. The maximum and
22 minimum amounts payable weekly shall be determined as of each June 30th
23 to apply to benefit years beginning in the twelve-month period
24 immediately following such June 30th. (~~((Except as provided in RCW~~
25 ~~50.20.125,))~~)

26 (b) The maximum amount payable weekly shall be:

27 (i) Except as provided in (b)(ii) of this subsection, seventy
28 percent of the "average weekly wage" for the calendar year preceding
29 such June 30th.

30 (ii) Beginning with claims that have an effective date on or after
31 January 4, 2004, the maximum amount payable weekly shall be sixty-six
32 and two-thirds percent of the "average weekly wage" for the calendar
33 year preceding such June 30th or four hundred ninety-six dollars,
34 whichever is greater. If sections 9 and 10 of this act are not enacted
35 by July 1, 2003, this subsection (2)(b) is null and void.

36 (c) The minimum amount payable weekly shall be fifteen percent of
37 the "average weekly wage" for the calendar year preceding such June

1 30th. If any weekly benefit, maximum benefit, or minimum benefit
2 amount computed herein is not a multiple of one dollar, it shall be
3 reduced to the next lower multiple of one dollar.

4 (3)(a) In addition to the amount payable weekly under subsection
5 (2) of this section, an individual shall be paid a dependent allowance
6 of ten dollars weekly for: (i) Each child who is a dependent of the
7 individual for federal income tax exemptions; and (ii) each child for
8 whom the individual owes child support obligations and for whom no
9 other person is receiving dependent allowances under this subsection.
10 The dependent allowance may not exceed thirty dollars weekly.

11 (b) For the purposes of this subsection:

12 (i) "Child" means a biological, adopted, or foster child, a
13 stepchild, a legal ward, or a child of a person standing in loco
14 parentis who is: (A) Under eighteen years of age; (B) eighteen years
15 of age or older and incapable of self-care because of a mental or
16 physical disability; or (C) under twenty-four years of age, enrolled as
17 a student, and regularly attending classes, or is between two
18 successive academic years or terms, at an institution of higher
19 education.

20 (ii) "Institution of higher education" means an educational
21 institution that: (A) Admits as regular students only individuals
22 having a certificate of graduation from a high school, or the
23 recognized equivalent of such a certificate; (B) is legally authorized
24 to provide a program of education beyond high school; (C) provides an
25 educational program for which it awards a bachelor's or higher degree,
26 or provides a program which is acceptable for full credit toward such
27 a degree, or offers a program of training to prepare students for
28 gainful employment in a recognized occupation; and (D) is a public or
29 other nonprofit institution.

30 (4) The sum of the amount payable weekly under subsection (2) of
31 this section and the dependent allowance payable weekly under
32 subsection (3) of this section may not exceed the maximum amount
33 payable weekly specified in subsection (2) of this section.

34 **Sec. 3.** RCW 50.04.293 and 1993 c 483 s 1 are each amended to read
35 as follows:

36 (1) "Misconduct" means an employee's act or failure to act in

1 willful disregard of his or her employer's interest where the effect of
2 the employee's act or failure to act is to harm the employer's
3 business.

4 (2) "Gross misconduct" means a felony or gross misdemeanor by the
5 employee that is connected with the employee's work which results in
6 harm to the employer's business.

7 **Sec. 4.** RCW 50.20.065 and 1993 c 483 s 11 are each amended to read
8 as follows:

9 (1) An individual who has been discharged from his or her work
10 because of (~~a felony or gross misdemeanor~~) gross misconduct of which
11 he or she has been convicted, or has admitted committing to a competent
12 authority, (~~and that is connected with his or her work~~) shall have
13 all hourly wage credits based on that employment or six hundred eighty
14 hours of wage credits, whichever is greater, canceled.

15 (2) The employer shall notify the department of such an admission
16 or conviction, not later than six months following the admission or
17 conviction.

18 (3) The claimant shall disclose any conviction of the claimant of
19 a work-connected felony or gross misdemeanor occurring in the previous
20 two years to the department at the time of application for benefits.

21 (4) All benefits that are paid in error based on wage/hour credits
22 that should have been removed from the claimant's base year are
23 recoverable, notwithstanding RCW 50.20.190 or 50.24.020 or any other
24 provisions of this title.

25 NEW SECTION. **Sec. 5.** A new section is added to chapter 50.20 RCW
26 to read as follows:

27 An individual is disqualified for benefits for any day during which
28 he or she is incarcerated in any federal, state, or municipal penal
29 institution, jail, medical facility, public or private hospital, or in
30 any other place because of a criminal violation of a federal, state, or
31 municipal law or ordinance. For purposes of this section,
32 "incarceration" includes any time spent in the custody of law
33 enforcement authorities upon adjudication or conviction by a court of
34 competent jurisdiction.

1 NEW SECTION. **Sec. 6.** A new section is added to chapter 50.20 RCW
2 to read as follows:

3 An otherwise eligible individual may not be denied benefits for any
4 week because the individual is available for, seeks, applies for, or
5 accepts only work of at least fifteen hours per week by reason of the
6 application of RCW 50.20.010(3), 50.20.015, 50.20.080, or 50.22.020(1)
7 relating to availability for work and active search for work, or
8 failure to apply for or refusal to accept suitable work.

9 **Sec. 7.** RCW 50.20.150 and 1970 ex.s. c 2 s 7 are each amended to
10 read as follows:

11 (1) The applicant for initial determination, his most recent
12 employing unit as stated by the applicant, and any other interested
13 party which the commissioner by regulation prescribes, shall, if not
14 previously notified within the same continuous period of unemployment,
15 be given notice promptly in writing that an application for initial
16 determination has been filed and such notice shall contain the reasons
17 given by the applicant for his last separation from work. If, during
18 his benefit year, the applicant becomes unemployed after having
19 accepted subsequent work, and reports for the purpose of reestablishing
20 his eligibility for benefits, a similar notice shall be given promptly
21 to his then most recent employing unit as stated by him, or to any
22 other interested party which the commissioner by regulation prescribes.

23 (2) Each base year employer shall be promptly notified of the
24 filing of any application for initial determination which may result in
25 a charge to his account.

26 (3) Any employer who receives a notice under this section and has
27 information which might make the applicant ineligible or disqualify the
28 applicant for benefits shall report this information to the employment
29 security department at the address indicated on the notice within ten
30 days of the date the notice was mailed. If the employer reports this
31 information to the department more than ten days after the date the
32 notice was mailed:

33 (a) The applicant may not be determined to be ineligible or
34 disqualified based on the information for a claim period compensated
35 before receipt of the information by the department; and

1 (b) The applicant is entitled to a rebuttable presumption of
2 eligibility for a claim period after receipt of the information by the
3 department.

4 **Sec. 8.** RCW 50.20.240 and 2002 c 8 s 3 are each amended to read as
5 follows:

6 (1) To ensure that following the initial application for benefits,
7 an individual is actively engaged in searching for work, ((effective
8 July 1, 1999,)) the employment security department shall implement a
9 job search monitoring program. Except for those individuals with
10 employer attachment or union referral, individuals who qualify for
11 unemployment compensation under RCW 50.20.050(2)(d), and individuals in
12 commissioner-approved training, an individual who has received five or
13 more weeks of benefits under this title must provide evidence of
14 seeking work, as directed by the commissioner or the commissioner's
15 agents, for each week beyond five in which a claim is filed. The
16 evidence must demonstrate contacts with at least three employers per
17 week or documented in-person job search activity at the local
18 reemployment center. In developing the requirements for the job search
19 monitoring program, the commissioner or the commissioner's agents shall
20 utilize an existing advisory committee having equal representation of
21 employers and workers.

22 (2) During any extended benefit period as defined in RCW 50.22.010,
23 the department may: (a) Suspend the job search monitoring program
24 under subsection (1) of this section; and (b) shift funding and staff
25 from job search monitoring activities to eligibility determination and
26 benefit payment activities.

27 **PART II - UNEMPLOYMENT COMPENSATION CONTRIBUTIONS**

28 **Sec. 9.** RCW 50.29.020 and 2002 c 149 s 6 and 2002 c 8 s 4 are each
29 reenacted and amended to read as follows:

30 (1)(a) An experience rating account shall be established and
31 maintained for each employer, except employers as described in RCW
32 50.44.010 and 50.44.030 who have properly elected to make payments in
33 lieu of contributions, taxable local government employers as described

1 in RCW 50.44.035, and those employers who are required to make payments
2 in lieu of contributions, based on existing records of the employment
3 security department.

4 (b) Benefits paid to ((any)) an eligible individual((s)) shall be
5 charged to the experience rating accounts of each of such individual's
6 employers during the individual's base year in the same ratio that the
7 wages paid by each employer to the individual during the base year bear
8 to the wages paid by all employers to that individual during that base
9 year, except as otherwise provided in this section.

10 (c) Benefits paid to an eligible individual shall be charged to the
11 experience rating account of only the individual's separating employer
12 if the individual qualifies for benefits under: (i) RCW
13 50.20.050(2)(a) and became unemployed after having worked and earned
14 wages in the bona fide work; or (ii) RCW 50.20.050(3).

15 (2) The legislature finds that certain benefit payments, in whole
16 or in part, should not be charged to the experience rating accounts of
17 employers except those employers described in RCW 50.44.010 and
18 50.44.030 who have properly elected to make payments in lieu of
19 contributions, taxable local government employers described in RCW
20 50.44.035, and those employers who are required to make payments in
21 lieu of contributions, as follows:

22 (a) Benefits paid to any individuals later determined to be
23 ineligible shall not be charged to the experience rating account of any
24 contribution paying employer.

25 (b) Benefits paid to an individual filing under the provisions of
26 chapter 50.06 RCW shall not be charged to the experience rating account
27 of any contribution paying employer only if:

28 (i) The individual files under RCW 50.06.020(1) after receiving
29 crime victims' compensation for a disability resulting from a nonwork-
30 related occurrence; or

31 (ii) The individual files under RCW 50.06.020(2).

32 (c) Benefits paid which represent the state's share of benefits
33 payable as extended benefits defined under RCW 50.22.010(6) shall not
34 be charged to the experience rating account of any contribution paying
35 employer.

36 (d) In the case of individuals who requalify for benefits under RCW
37 50.20.050 or 50.20.060, benefits based on wage credits earned prior to

1 the disqualifying separation shall not be charged to the experience
2 rating account of the contribution paying employer from whom that
3 separation took place.

4 (e) Individuals who qualify for benefits under RCW 50.20.050(2)(d)
5 shall not have their benefits charged to the experience rating account
6 of any contribution paying employer.

7 (f) In the case of individuals identified under RCW 50.20.015,
8 benefits paid with respect to a calendar quarter, which exceed the
9 total amount of wages earned in the state of Washington in the higher
10 of two corresponding calendar quarters included within the individual's
11 determination period, as defined in RCW 50.20.015, shall not be charged
12 to the experience rating account of any contribution paying employer.

13 (3)(a) A contribution-paying base year employer, not otherwise
14 eligible for relief of charges for benefits under this section, may
15 receive such relief if the benefit charges result from payment to an
16 individual who:

17 (i) Last left the employ of such employer voluntarily for reasons
18 not attributable to the employer;

19 (ii) Was discharged for misconduct connected with his or her work
20 not a result of inability to meet the minimum job requirements;

21 (iii) Is unemployed as a result of closure or severe curtailment of
22 operation at the employer's plant, building, work site, or other
23 facility. This closure must be for reasons directly attributable to a
24 catastrophic occurrence such as fire, flood, or other natural disaster;
25 or

26 (iv) Continues to be employed on a regularly scheduled permanent
27 part-time basis by a base year employer and who at some time during the
28 base year was concurrently employed and subsequently separated from at
29 least one other base year employer. Benefit charge relief ceases when
30 the employment relationship between the employer requesting relief and
31 the claimant is terminated. This subsection does not apply to shared
32 work employers under chapter 50.60 RCW.

33 (b) The employer requesting relief of charges under this subsection
34 must request relief in writing within thirty days following mailing to
35 the last known address of the notification of the valid initial
36 determination of such claim, stating the date and reason for the

1 separation or the circumstances of continued employment. The
2 commissioner, upon investigation of the request, shall determine
3 whether relief should be granted.

4 **Sec. 10.** RCW 50.29.025 and 2003 c 4 (SHB 1832) s 1 are each
5 amended to read as follows:

6 The contribution rate for each employer subject to contributions
7 under RCW 50.24.010 shall be determined under this section.

8 (1) A fund balance ratio shall be determined by dividing the
9 balance in the unemployment compensation fund as of the September 30th
10 immediately preceding the rate year by the total remuneration paid by
11 all employers subject to contributions during the second calendar year
12 preceding the rate year and reported to the department by the following
13 March 31st. The division shall be carried to the fourth decimal place
14 with the remaining fraction, if any, disregarded. The fund balance
15 ratio shall be expressed as a percentage.

16 (2) The interval of the fund balance ratio, expressed as a
17 percentage, shall determine which tax schedule in subsection (5) of
18 this section shall be in effect for assigning tax rates for the rate
19 year, except that during rate year 2004 tax schedule B shall be in
20 effect unless a lower tax schedule is determined to be in effect by the
21 interval of the fund balance ratio. The intervals for determining the
22 effective tax schedule shall be:

(3) An array shall be prepared, listing all qualified employers in ascending order of their benefit ratios. The array shall show for each qualified employer: (a) Identification number; (b) benefit ratio; (c) taxable payrolls for the four calendar quarters immediately preceding the computation date and reported to the department by the cut-off date; (d) a cumulative total of taxable payrolls consisting of the employer's taxable payroll plus the taxable payrolls of all other employers preceding him or her in the array; and (e) the percentage equivalent of the cumulative total of taxable payrolls.

(4) Each employer in the array shall be assigned to one of twenty rate classes according to the percentage intervals of cumulative taxable payrolls set forth in subsection (5) of this section: PROVIDED, That if an employer's taxable payroll falls within two or more rate classes, the employer and any other employer with the same benefit ratio shall be assigned to the lowest rate class which includes any portion of the employer's taxable payroll.

(5)(a) Except as provided in RCW 50.29.026, the contribution rate for each employer in the array shall be the rate specified in the following tables for the rate class to which he or she has been assigned, as determined under subsection (4) of this section, within the tax schedule which is to be in effect during the rate year:

(b) Employers assigned to rate class 20 shall be assigned to one of the rate classes 20A through E as follows:

(i) Employers with a benefit ratio of less than 0.054000 shall be assigned to rate class 20A;

(ii) Employers with a benefit ratio of at least 0.054000 but less than 0.063000 shall be assigned to rate class 20B;

(iii) Employers with a benefit ratio of at least 0.063000 but less than 0.068000 shall be assigned to rate class 20C;

(iv) Employers with a benefit ratio of at least 0.068000 but less than 0.075000 shall be assigned to rate class 20D; and

(v) Employers with a benefit ratio of 0.075000 or higher shall be assigned to rate class 20E.

(6) The contribution rate for each employer not qualified to be in the array shall be as follows:

(a) Employers who do not meet the definition of "qualified employer" by reason of failure to pay contributions when due shall be assigned a contribution rate two-tenths higher than that in rate class 20E for the applicable rate year, except employers who have an approved agency-deferred payment contract by September 30 of the previous rate year. If any employer with an approved agency-deferred payment contract fails to make any one of the succeeding deferred payments or fails to submit any succeeding tax report and payment in a timely manner, the employer's tax rate shall immediately revert to a contribution rate two-tenths higher than that in rate class 20E for the applicable rate year; and

(b) For all other employers not qualified to be in the array, the contribution rate shall be a rate equal to the average industry rate as determined by the commissioner, plus fifteen percent; however, the rate may not be less than one percent or more than the rate in rate class 20E for the applicable rate year.
